Chronology of the event:

- Earlier the PP had obtained EC issued by SEIAA vide No. 1502/EN/T-II-1/017/2011 dated 19.06.2015 and Consent to Operate from WBPCB vide Memo No. 125-7WPBD-Cont(2349)/05 dated 01.02.2022 which is valid upto 31.07.2026.
- The PP had also obtained DFO approved plantation plan for 28975.27 sqm. (33% of land area).
- The PP applied in prescribed format for Terms of Reference and uploaded the application in the PARIVESH portal on 18.12.2021 (Proposal No, SIA/WB/IND/67416/2021).
- The PP had obtained Auto-Terms of References (TORs) issued by SEIAA, West Bengal on 23.11.2021.
- Public hearing was conducted on 12.08.2022 by WBPCB and District Authority following the procedures as per EIA Notification, 2006 and its amendments.
- The PP had applied for EC in prescribed format and uploaded final EIA report in the PARIVESH portal on 22.12.2022.
- The PP was called for the EC presentation in the 63rd SEAC meeting held on 18.01.2023 and the PP presented their proposal in the meeting.

SEAC observation and recommendations:

- The SEAC observed that the project falls within Bamunara Area which is within 5 km. of Durgapur Municipal Corporation boundary, declared as Severely Polluted Area.
- Based on the submission and presentation made by the PP, the committee recommended that the following submission / clarifications should be uploaded in the PARIVESH portal by the project proponent for further consideration: -
 - 1) Certified Compliance Report (CCR) stating complete compliance with the provisions laid down in MoEF&CC O.M. F No. IA3-22/10/2022-IA.III[E 177258] dated 08.06.2022.
 - 2) The plot area mentioned in the DFO approved plantation area does not match with the plot area mentioned in the EIA report.
 - 3) Status of existing plantation with photographs.
 - 4) Complete land documents including conversion for all the plots and mutated in the name of project proponent within the actual plot area. Summary of the area, present character and ownership of the plots should be submitted.
 - 5) Permission/application for ground water abstraction for the water requirement of the entire project (160 KLD).
 - 6) Pollution control system for the slag crusher.
 - 7) Flow chart for water balance showing use of harvested rainwater. Waterline should be shown into the process flowsheet.
 - 8) The committee directed the PP to revamp the emission control system for the existing plant so that the overall impact on ambient air quality remains the same. Air quality of within the processing areas of the plant area after expansion should be within prescribed permissible exposure limits. Revised plan for upgradation of emission control system air quality monitoring system should be submitted.
 - 9) Height for the ambient air quality monitoring stations during baseline studies should be mentioned.

- 10) Plan for prevention of occupational health hazards and safety measures for workers (e. g. physical injuries, fire hazards, electrical shocks, noise hazards etc.) to be adopted.
- 11) Emergency preparedness plan.
- 12) Distance of proposed tube wells from nearest tube wells.
- 13) Depth of bore wells for ground water monitoring conducted during baseline study.
- 14) Display board for display of all environmental parameters and beneficiary of the social part of EMP. Plan in this regard should be submitted.
- 15) Year-wise budget break-up should be provided for the need-based activities of the EMP.

All the documents should be duly signed by the project proponent and environmental consultant.

The SEAC will further consider the case on submission of satisfactory reply on the above-mentioned queries only through "PARIVESH" portal.

 - 4) Study report on base flow level measured at 5 points with date and supporting photographs. It should be committed that mining will be done at least 1m above the base flow level. Accordingly, if required, the proposal may also be revised.
