MINUTES OF THE SEIAA MEETING

DATE & TIME OF THE MEETING: 28th January, 2020: 2 PM, **VENUE**: OFFICE CHAMBER OF THE CHAIRMAN

Shri T.T.C. Marak, Chairman presided over the meeting. At the outset, the Chairman welcomed the Members and then requested the Member Secretary to present the Agenda points for discussion.

The Member Secretary apprised the members about the actions taken on the decision arrived at in the last SEIAA meeting held on 10th September, 2019 and circulated the minutes of the said meeting. The meeting approved the actions taken and confirmed the proceedings. Then the following agenda items were discussed in the meeting.

Deliberation on Agenda 1 :

Grant of prior EC to the project proposal No.SIA/ML/MIN/ 40647/2016 ,dated 19/10/2019 : Madan Pyrda (Block- I), Limestone mining project – deemed forest area (area = 4.89 ha), applied by M/s Green Valley Industries Ltd.

The Member Secretary placed the EC application along-with its attachments before the meeting and briefed the members about the project. He stated that the TOR application dated 31/11/2016 had been examined by SEAC, Meghalaya. The SEAC recommended the TOR application vide letter No. SEAC/PP-52/2017/200/733 dtd. 08/12/2017 for the Project to SEIAA for approval. TOR was approved and issued by SEIAA to the Project vide letter No. SEIAA/P-25/30/2016/43/972 dt. 04/01/2018. PP submitted online EC application vide proposal No.SIA/ML/MIN/40647/2016 dtd. 19/10/Page 1 of 19



2019 along-with relevant attachments (documents) -viz., Form-2, PFR, approved Mining Plan, EIA Report, EMP Report, Public Hearing and other relevant papers. Thereafter, the PP submitted the EDS on 19/10/2019; then the application was forwarded online by SEIAA to SEAC for further necessary action.

As per the EC application and the documents attached, the meeting noted as follows:-

(1) The proposed project falls under Schedule 1(a) of Category B1 of EIA Notification 2006 being a captive limestone mine of a Cement factory. The mine lease area is 4.89 ha.(deemed Forest Area) and located at Nongsning village, P.O.- Chiehruphi, Narpuh Elaka, District-East Jaintia Hills, Meghalaya. In the buffer-zone - the water body is Thangskai river to the north about 0.90 km. and the Narpuh Reserve Forest/Eco sensitive zone about 7.95 km SE. The baseline study was conducted from 3rd December, 2017 to 27 February, 2018. The Boundary pillars of the project are :

(2) The State Govt., Meghalaya under State Mining & Geology Department issued order for grant of mining lease vide letter No.MG.6/2011/187 dtd. 04/01/2018 to the project.

- (3) This project site is a private land and a 'deemed forest' area. PP applied for Forest Land Clearance vide (copy of) application proposal No. FP/ML/ MIN/ 8842/2014. The Ministry of Forests, Environment & Climate Change, Govt. of India, New Delhi, vide MoEF & CC letter No.L.No.3-MG B 027/2018-SHI/2596-97 dtd.14/10/2019 agreed to the Govt. of Meghalaya's proposal 'In principle approval' for diversion of 6.55 hectares of deemed private forest land to this project.
- (4) The PP submitted a copy of application No. FP/ML/ MIN/8842/2014 and the 'Form for seeking recommendation of the Standing Committee of NBWL/SBWL'.
- (5) The Public Hearing was conducted by Meghalaya State Pollution Control Board, Shillong on 13th March, 2019 for this project. The Report was forwarded by MSPCB vide letter No. MSPCB/TB-360-GVL-2018/2019-2020/15 dtd. 16.05.2019 to the SEIAA. Then the PP furnished para-wise comments/views in the EIA Report on the actions required to be taken (by the PP) on the views offered by the general public who attended the public hearing and the suggestions made by NGOs in the Public Hearing.
- (6) As per the approved mining plan, the total mineable reserves of limestone is of the order of 1.339 Million Tonnes and the targeted maximum production of limestone is 0.204 Million Tonnes per annum. The average gradient is about 45°. It is a Captive Limestone Mine which will be utilized by the M/s Green Valley Industries Pvt. Ltd. in its own Cement plant. The mining period is about 8(eight) years.



- (7) Mining will be fully mechanized opencast method involving machineries/vehicles like crawler drill, air compressor, hydraulic excavators, dumpers and blasting. The safety zone is about 0.447 ha. Green belt is proposed to be developed in safety zone and plantation will be carried out; the density of tree plantation will be 1125 trees per ha. and in other areas 0.294 trees per ha.. The final void area will be 4.149 ha. The depth is about 45.5 meter. The void area at a depth of 0 meter will be converted into a water body. Conservation plan for preservation of Schedule- I species shall be proposed in which Rs.10 Lakhs would be allotted for the project to be implemented within 5 years from the date of grant of EC. About 19 persons will gain direct employment and many can avail indirect employment opportunities. Dust suppression shall be carried out in the working area and haul roads by sprinkling of water with water tanker. Wet drilling shall be practiced to reduce noise generation and Personal Protective Equipment (PPE) shall be provided to the mine workers.
- (8) The total water consumption is 1 KLD for drinking and 1 KLD for others to be supplied by water Tankers; 6 KLD for sprinkling purposes and 2 KLD for greenbelt to be met from water collected in pits.
- (9) The cost of the mining project is Rs. 1.16 crore. The PP has earmarked capital of Rs. 0.08 crore towards Environmental Protection Measures and Rs. 0.1 crore per annum as recurring cost of Environment Social Responsible (ESR) activities. Further, Rs.0.1631 crore is earmarked to meet the recurring cost per annum towards cost of Environment Management Plan (EMP) activities.

- (10)**Undertaking by the PP** (M/s Green Valley Industries Pvt. Ltd.) that the information provided in the EIA/EMP Report and all other submission made to the SEIAA/SEAC, Meghalaya in respect of this project are factually correct and the PP is fully accountable for the same. Shri Pawan Kumar Joshi, Assistant Vice President of the Company signed the document.
- (11)**Undertaking by the Consultant** (M/s Perfact Enviro Solutions Pvt. Ltd., 5th Floor, NM Mall, Sector-3, Rohini New Delhi- 110085, holding a NABET extension certificate No. QCI/NABET/EIA/ACO/19/1158 dtd.09/12/2019 with valid date up to 08/03/2020), that the information provided in the EIA/EMP Report and all other submission made to the SEIAA/SEAC, Meghalaya in respect of this project are factually correct and the Consultant is fully accountable for the same. Shri Udai Shanker Pandey, Director of the Firm signed the undertaking on behalf of the Firm.
- (12)As per the uploaded minutes, the SEAC after all additional clarifications, that is, the EIA & EMP Reports, Public Hearing reports were furnished and the presentation given by the Project Proponent, field inspection being carried out by SEAC had *in its meeting held on 11th December, 2019* unanimously recommended for grant of Environmental Clearance to the project,

RECOMMENDATION:

The State Environment Impact Assessment Authority, Meghalaya, resolved to accept the recommendations of the SEAC for granting of EC to the project, in its meeting held on 28.01.2020. Accordingly, Environmental Clearance is hereby accorded for the above



project on the recommendation of the SEAC and as per the EIA Notification- 2006 and its subsequent amendments, subject to strict compliance of the Terms and Conditions as listed at Annexure – I

- 4. The Boulder-stone is to be used for construction purposes and export to Bangladesh. The proposed production capacity is about 302010 tonnes per annum. The mining operation will be done as per the approved mining plan with a mining method of open cast and semi-mechanized by using hydraulic excavator and breakers.
