The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1: Proposal was deferred in 5.68 meeting of SEIAA for "there is a conflict of the KML provided with the forest boundary and mining is clearly visible in the forest area, also DCF, Bundi has not certified the distance as 51 m. hence, the Authority decided to call for a site inspection report from the concerned DCF" Now, PP has submitted the DCF, Letter dated 19/05/2023 stating that the distance of the forest from the lease area is minimum 51 m as per the combined report from revenue department, Forest department and Mining department, dated 30/11/2022 and report from Assistant Conservator of Forest bundi, dated 16/05/2023. However, CCR is more than one year old. Hence, the Authority decided to defer this proposal for submission of additional information within 45 days.
- 2. Serial No. 2: Proposal was deferred in 5.72 meeting of SEIAA for "submission of CA Certificate for penalty calculation". Now, PP has submitted the same. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 55588/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 2.29 Lacs towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop the running of this project.
- 3. Serial No. 3: Proposal was deferred in 5.75 meeting of SEIAA for "submission of revised mining plan". Now PP has submitted the mining plan with revised production details showing Total production capacity 200013 TPA, Saleable -84437 TPA & waste 115576 TPA with seal and sign on every change done. Considering the same, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
