




**Minutes of the 81<sup>st</sup> SEAC Meeting held on 23<sup>rd</sup> September 2016**

81-12 F.5698	<b>Proposed construction of Residential Project by “M/s. Pallava Estate LLP.,” at S.F.No.399/3B etc, Chettipunniyam Village, Chengalpattu Taluk, Kancheepuram District – Category “B2”- 8(a) Building and Construction Projects –Environmental Clearance- Regarding</b>
	<p>The Proponent of “ M/s. Pallava Estate LLP.,” has applied for Environment Clearance for the proposed construction of residential project with the built up area of 52880.42 Sq.m. at S.F.No.399/3B etc, Chettipunniyam Village, Chengalpattu Taluk, Kancheepuram District, Tamil Nadu on 29.08.2016.</p> <p>The Committee further observed that the above project comes under Item No 8(a) of the Schedule. After the presentation made by the proponent the Committee decided to recommend the proposal for the grant of EC to SEIAA , subject to the following conditions:</p> <ol style="list-style-type: none"> <li>1. The proponent shall give a detailed report on how the excess storm water will be managed so that the surrounding area is not flooded and also ensuring the free flow of the Storm water without water stagnation due to the proposed activity.</li> <li>2. The Proponent shall ensure that the Ground water quality should not be degraded at any point of time.</li> <li>3. There shall be no drawl of ground water for the fresh water supply to residents. Alternative proposal for the supply of fresh water shall be provided by the Proponent.</li> </ol>
