


Minutes of the 82nd SEAC Meeting held on 21st October 2016

	<p>The Proponent of “M/s. Lancor Holdings Ltd.,” has submitted application Form1, Form 1A for obtaining Environment Clearance for the proposed construction of residential building with built up area of 37817 sq.m. at S.no. 495/1A etc., Sholinganallur Village, Sholinganallur Taluk, Kancheepuram District on 07.09.2016.</p> <p>The Committee observed that the above project comes under Item No 8(a) of the Schedule .Based on the presentation made by the proponent and the documents furnished, the SEAC decided to recommend the proposal for the grant of EC to SEIAA , subject to the following conditions:</p> <ol style="list-style-type: none"> 1. Revised rain water harvesting and storm water drainage based on the peak flow rainfall for the proposed site. Also furnish details on what percentage is recharged into the surface and the quantity of excess goes off from the proposed site. 2. Bio degradable Solid waste shall be managed in-situ the project site. 3. Explore the possibility of increasing the Green belt area inside the project site, so as to reuse the treated sewage to the maximum extent possible. 4. STP shall be surrounded with more number of trees, so as to protect the residents from odour and dust pollution. Give a detailed plan on Green belt around STP. 5. Furnish details on number of trees proposed to be planted, with details of plant species.
