The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 3, 9, 10, 11, 12: The Authority accepted the recommendation of SEAC and decided to grant EC to these proposals.
- 2. Serial No. 1, 4 & 7: The Authority accepted the recommendation of SEAC and decided to grant ToR to these proposals.
- 3. Serial No. 5, 8: The Authority accepted the recommendation of SEAC and decided to close & delist the proposal.
- 4. Serial No. 15, 16: The Authority based on the recommendation of SEAC, after detailed discussions and deliberations decided to approve EIA/EMP of all these proposals and grant EC with the condition that all the lease holders of cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 5. Serial No. 2: The Authority examined the proposal in detail and found that it has following shortcomings:
  - a. Form 2 is not submitted in Hard Copy
  - b. Document/NOC regarding outside plantation
  - c. As per PFR, water source is given as private borewells for which permission is required from CGWA.
  - d. CTO is not taken under Water Act and also not in the name of lesse

- e. NABET Certificate is not valid as on date
- f. Authenticated production figures for 2020-21, 2021-22 not given
- g. Discrepancies with respect to proposed production capacity in Note-sheet, Form 1, New Mining Plan
- h. Cluster Certificate was issued on 23/11/2020
- i. Details regarding crusher and its EMP are not given

  Hence the Authority decided to refer back this proposal to SEAC for reexamination.
- **6. Serial No. 6:** The Authority examined the proposal in detail and found that it has following shortcomings:
  - a. Form 1 Online Submitted Copy
  - b. Form 2 Online Submitted Copy
  - c. Calculation of Penalty for Violation Case
  - d. Project cost is different in Presentation and in File.

Hence the Authority decided to refer back this proposal to SEAC for reexamination.

- 7. Serial No. 13: The Authority examined the proposal and found that despite the increase in area of the cluster the project proponent has not shown any increase in the traffic of vehicles and pollution load, which in the opinion of the Authority is not possible. Hence the Authority decided to refer back this proposal to SEAC for re-examining the proposal.
- 8. Serial No. 14: It is a violation case and the proponent has submitted the penalty amount as rupees 10,73,763.245 which is on actual production basis in the year 2001 2007. The SOP for penalty calculation as outlined in MOEF&CC Government of India OM 7.7.2021 imposes a penalty on turnover. The Authority was of the view that the project proponent must submit the turnover figures from

2001 to 2007 certified by a Charted Accountant. Hence the Authority decided to defer this case for additional information.

9. Serial No 17: The Authority decided to grant Transfer EC to this proposal.
