The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1: Proposal was deferred in the 5.90 meeting of SEIAA for "the following shortcomings and PP was called for presentation to explain environmental aspects of the proposal:
 - a. PP said in its report that turnover is NIL but the same is not certified by CA.
 - b. DCF, Alwar certificate not submitted, only DCF Sariska is available.

c. In the DCF certificate and approved maps, the building name is given as Mahalaxmi Complex but the proposal is given with the name as Manbhavan Apartments."

Based on the comprehensive discussion in the personal hearing and clarifications given by PP on the shortcomings asked, representation of PP and submitted documents were found satisfactory by the Authority. Hence, the Authority decided to grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 13.5 lacs by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 42 lacs towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

- 2. Serial No. 2: The proposal was deferred in the 5.93rd meeting of the Authority as, "the consultant is M/s. Macrocosm Environmental Solutions but Affidavit has been submitted by some other consultant i.e., Superintendence company of India (P) Limited. Also, DCF certificate of some other proposal was submitted at the time of presentation before SEAC, which is a gross negligence. Hence, the Authority is imposing a fine of Rs. 10,000/- on the consultant for this irresponsibility"
 - Now, PP has submitted the corrected affidavit and penalty imposed to the RSPCB. Hence, the Authority decided to grant EC to this proposal.
- 3. Serial No. 3: Proposal was deferred in the 5.87 meeting of SEIAA for "submission of ATR for non-compliance of specific condition 4 and general condition 10 & 15 in CCR regarding the conditions given in the earlier issued EC."
 - Now, PP has submitted the Action Taken Report for the conditions asked. Hence, the Authority decided to grant EC (Expansion & Inclusion) to this proposal.
- 4. Serial No. 4: Proposal was deferred in the 5.92 meeting of SEIAA as "Submitted DSR is for sandstone whereas the proposal is for Quartz & Feldspar." Now, PP has submitted the correct DSR.
 - Hence, the Authority decided to accept the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 5. Serial No. 5: The proposal was deferred in the 5.93rd meeting of SEIAA 31.08.23 for submission of a conservation plan as Mukundra Hills Tiger Reserve & Ramgarh Vishdhari Tiger buffer areas fall within 10 km. Now, PP has submitted the

- Conservation plan dated 06.05.23. Hence, the Authority decided to grant EC to this proposal.
- 6. Serial No. 6: Proposal was deferred in the 5.93 meeting of SEIAA for "submission of latest past production certificate duly authenticated by the Mining Department." Now, PP has submitted the production certificate vide letter dated 20/06/2023. Hence, the Authority decided to grant approval of EIA/ EMP, EC to this proposal subject to submission of Bank Guarantee of Rs 4,55,000/- (Refundable) for Remediation Plan and Natural & Community Resource Augmentation Plan & deposition of penalty amount of Rs. 4,51,428/- (Non Refundable) to RSPCB before issue of EC. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

Now, PP has submitted the Annual e-return duly signed by the Mining Department. Hence, the Authority decided to grant EC (Expansion) to this proposal.
- 8. Serial No. 8: Proposal was deferred in the 5.93rd meeting of the Authority for submission of Conservation Plan. PP in his reply dated 14.9.23 has submitted receipt of conservation plan dated 8.5.23. Hence, the Authority decided to grant EC to this proposal.
- 9. Serial No. 9: Proposal was deferred in the 5.87th meeting of the Authority and a show cause notice was issued against PP as well as consultant for submission of false affidavit and directed PP for clarification why their application for EC should not be rejected and appropriate legal action taken. PP in his reply dated 11.9.23 admitted his mistake and has also submitted revised affidavit of PP. Hence, the Authority decided to grant ToR under violation to this proposal.
- 10. Serial No. 10, 12, 13, 14, 39, 40, 50: The Authority accepted the recommendations of SEAC and decided to close and delist these proposals.
- 11. Serial No. 11, 15, 17, 20, 21, 22, 23, 24, 25, 28, 31, 32, 34, 36, 37, 38, 41, 47, 52, 53, 55, 57, 59: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals.
- 12. Serial No. 16: The Authority decided to issue to a show cause notice to the PP, since, they have stated in their affidavit that, "the project/ activity pertaining to the mining lease has been in violation of the order dated 02/08/2017 of the Hon'ble Supreme court in the matter of writ petition (civil)No. 114 of 2014, Common Cause v/s UOI". Hence,

- PP needs to explain why their application should not be rejected as PP has applied for fresh EC.
- Serial No. 18, 30: The Authority decided to accept the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 14. Serial No. 19: In this proposal, the affidavit submitted by the consultant doesn't state whether the project is of violation or not. Also, the parking provided in the proposal is inadequate. Hence, the Authority decided to defer this proposal for submission of revised affidavit clearly stating whether the proposal is of violation or not. PP is also directed to submit the revised parking details in compliance of the SEIAA letter no F1(4)/SEIAA/SEAC-Raj/CREDAI/2023-24 dated 15.09.2023 citing the size of 3BHK flats within 45 days.

- 16. Serial No. 27: The Authority accepted the recommendations of SEAC and decided to grant ToR under violation to this proposal.
- Serial No. 29: In this proposal, following shortcomings were encountered
 - Submitted DSR is of Marble while the proposed mineral is Quartz & Feldspar
 - b. Todgarh Raoli WLS is located within 10 kms of the proposed lease area, but no conservation plan has been submitted for the same.
 - Cluster certificate has expired on 20.4.23
 - Hence, the Authority decided to defer this proposal for submission of Correct DSR, Conservation Plan and Revised cluster certificate, within 45 days.
- Serial No. 33: In this proposal, Affidavit submitted in the name of PP, is signed by Mr. Shanti Lal Nahar of M/s ERA Minerals & Mines but his name is not mentioned in the partnership deed. Hence, the Authority decided to defer this proposal for clarification by PP on the same.
- 19. Serial No. 35: In this proposal, according to the submitted DCF Banswara certificate dated 6.9.21, the lease area is at a distance of 40 m from Hindolamal PF. The Authority decided to issue a show cause notice to PP to explain why this proposal should not be rejected as per State Government order dated 14.03.2023.
- 20. Serial No. 42, 43, 44, 45, 46: The Authority accepted the recommendations with conditions of SEAC and decided to grant amendment in EC to these proposals.

- 21. Serial No. 48: In this proposal, LoI for inclusion of Quartz & Feldspar has not been found. Hence, the Authority decided to defer this proposal for submission of the valid LoI for inclusion of Quartz & Feldspar, within 45 days.
- 22. Serial No. 49: The Authority accepted the recommendations of SEAC and decided to grant ToR under Violation subject to final order of Hon'ble NGT, Bhopal vide O.A. No. 26/2023.
- 23. Serial No. 51: The Authority accepted the recommendations of SEAC and decided to grant ToR to this proposal.
- 24. Serial No. 54: The Authority accepted the recommendation of SEAC and decided to reappraise the earlier granted EC by DEIAA Nagaur.
- 25. Serial No. 56: In this proposal, proposed quantity of solid waste generation has not been provided in the EIA report and quantity of water requirement is not clear. Hence, the authority decided to defer this proposal for clarification on the deficiencies cited above, within 45 days.
- 26. Serial No. 58: The recommendations of SEAC is overruled by SEIAA and the Authority decided to refer back the case to SEAC. PP has a right to apply for EC and cannot be compelled to come with the other proponents as a mandatory condition. SEAC is directed to examine the case on technical aspects and submit its recommendations.
- 27. Serial No. 60, 61: In these proposals, production has been carried out exceeding the granted capacity of EC. Hence, The Authority decided to grant Transfer EC to these proposals with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 28. Serial No. 62 to 64: The Authority decided to grant Transfer of EC to these proposals.
- 29. Serial No. 65 to 68: The Authority decided to grant Transfer EC to these proposals with a direction that since the ECs were issued by DEIAA, the concerned PP shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
