Agenda A- Minutes of 806th SEAC-1 Meeting Dated 03/11/2023 (Part Minutes)

 Common Bio-Medical Waste Treatment Facility using latest Plasma Pyrolysis technology at Village-Naipura Kalan, District-Varanasi, Shri Madho Singh, M/s Mahamana Pandit Madan Mohan Malaviya Cancer Centre (a unit of Tata Memorial Centre), 8139/7191/SIA/UP/INFRA2/441226/2023.

SEIAA noted the comments of SEAC that this proposal is technically satisfactory except the fact that the gap analysis is still awaited which has to be provided by UP Pollution Control Board as per the provisions of govt. order no. 631/81-6-2023, dated 28/06/2023 and revised guidelines for Common Bio-medical Waste Treatment and Disposal Facilities, 2016. Due to importance of the project & the request of project proponent, the committee recommends this project for grant of environmental clearance on the proposal as above alongwith standard environmental clearance conditions prescribed by MoEF&CC, Gol. SEIAA may take gap analysis report directly from UP Pollution Control Board and impose appropriate additional condition (if required) based upon the gap analysis.

SEIAA noted that gap analysis report signed by RO UPPCB Varanasi dated 02.11.2023 is present in the file but it is not clear why SEAC has not taken s cognizance of this report. The report states that:-

SEIAA noted that the proposed plant plans to use the Plasma pyrolysis technology plant which is expected to give better results in terms of disposal of Bio Medical Waste, hence SEIAA agreed with the recommendation of SEAC to grant EC to the above project. However UPPCB is advised to monitor performance efficiency in terms of stack emission of the plant on regular basis and submit its report to SEIAA. UPPCB is also is advised to conduct gap analysis of the whole State as per revised CBWTF guidelines 2016.

its drainage pattern, final discharge of treated waste water, details of 72 hospital/nursing homes, clear demarcation of Khorabar Awasiya Yojna (Township) & Medicity on layout plan, details of power backup, double plumbing and Bio Medical waste disposal.

SEIAA noted that validity of consultant is wrongly mentioned as May 01, 2021 which seems to be typographical error. SEIAA agreed with the recommendation of SEAC to issue additional ToR to the title proposal for conducting EIA studies. SEIAA added following points to ToR-

- Proposed production per annum shall be as per approved replenishment study report.
- 2- Since no intimation has been submitted regarding available monitoring data, hence data will be collected after issuance of ToR.
- 3- All pages of technical documents/EIA/EMP etc. should be signed by the consultant and project proponent both.
- 4- The lease area its address and production per annum should match with as mentioned in DSR and Lol. In case there is any difference clarification/ amendment letter from competent authority shall be submitted along with EIA. EIA and public hearing shall be conducted as per the lease area its address and production per annum mentioned in DSR and Lol.
- 5- Public hearing shall be conducted as per EIA notification, 2006 (as amended).
- 6- SEIAA opined that the project proponent shall submit permission of CGWA or proposal for alternative source of fresh water.
- 7- Latest KML file for the area and mining lease area should be provided.
- 8- Status of leases granted/to be granted in various mining khands along with production since the formulation of DSR, duly certified by the competent authority should be submitted.
- 9- In case project proponent intends to temporarily store mined out material or any tools, equipment's or other material outside mine lease area then NOC from competent authority for doing so should be submitted and details of such area and associated Environmental impacts should be included in EIA-EMP report. This should also be clearly mentioned during public hearing.
- 10- Road network to be used by the project should be clearly shown on Survey of India toposheet in 1:50,000 scale. In case road network involves forest road, permission should be obtained from Forest Department and a copy of the same should be submitted at the time of appraisal of EIA-EMP report.
