The project proponent has submitted his reply however SEIAA noted that the above project comes under violation category. SEIAA also gone through OM F. No. IA3-3/4/2024-IA.III (E230791) dated 08.01.2024 which states that:-

 However, the Hon'ble Supreme Court in W.P (C) no 1394/2023 title Vanashakti vs. Union of India has stayed the operation of both OMs dated 07.07.2021 and 28th January 2022.

Hence SEIAA opined that EC cannot be granted in light of the above and a letter may be send to MoEFCC regarding guideline for disposal of violation cases where ToR has been granted or penalty/ bank guarantee has been submitted by project proponent before the decision of Hon'ble court since such violation cases were being dealt by SEIAA till now as per extant orders and OMs.

### Proposed Construction of Sanfran Sarovar Heights Multistoried Residential Building at Arazi No.-134, 135, 136, 137, 98 & 97/2 Lahargird, Jhansi, Uttar Pradesh File no- 7468.
