SEIAA noted that the above projects were appraised by SEAC on 05.12.2023 and 06.12.2023 that is after 04.12.2023, the date of letter issued by MoEFCC, regarding competent authority for approval of DSR, in which it is mentioned that DSR is to be submitted to SEAC for examination and SEIAA for approval. SEAC had appraised the projects on the basis of DSR approved by authority competent to approve DSR at that time. Based on the appraisal and considering the technicality, the Authority decided unanimously that EC may be granted. The matter was again deliberated upon and it was

found that DSR has not been submitted by the above District as per EIA notification, 2006 (as amended). Hence in light of letter dated 04.12.2023, it was unanimously decided that issuance of EC for projects mentioned at serial no. 1 to 6 may be kept on hold.
