The above-mentioned Sand Mining proposals (Agenda Sl. No, 01 to 10) were considered by the Committee. The Committee discussed/examined the extension of validity of environmental clearance proposal of the sand mining leases. Based on the discussions/examination, the committee found their presentation have some missing documents. The Project Proponent has submitted the documents on dated 30.03.2022 as follows:-

- 1) Form - I.
- 2) Pre-Feasibility Report.
- 3) Consent to Operate (CTO).
- 4) Notification form Deptt. of Mines & Geology, Govt. of Bihar. (Memo No. 3725, dated 10.12.2021).
- 5) Previous approved Mine Plan of Patna & Aurangabad.
- 6) List of sand ghats with 3 years (2018, 2019, 2020) dispatched quantity.
- 7) List of operative and non-operative sand ghats in Aurangabad & Patna Districts.
- 8) List of sand ghats of manipulated past and present RL.

Based on the above, the committee recommend for Extension of Environmental Clearance with the following conditions:-

- I. The Project Proponent has to submit the Replenishment Study Report for FY 2020 - 21 for the concerned sand ghats. Till the time the Replenishment Study is conducted (Pre & Post monsoon), sand mining shall be done to the depth of one meter only. The sand ghat wise Replenishment Study (Pre & Post monsoon) has to be submitted to this committee by December, 2022, for further consideration by the committee. If the Replenishment Study (sand ghat wise) is not submitted by December, 2022, the approval for the Environmental Clearance extension shall be revoked.
- II. The Project Proponent has to submit desired time extension proposal of validity of Environmental Clearance. The same shall be submitted before the SEIAA, Bihar for necessary decision.

- III. The other conditions (specific and general) as contained in the original Environmental Clearance shall be applicable to this Environmental Clearance extension as well, apart from the extant guidelines and court orders.




