The proposal was placed in the 128th SEAC Meeting held on 15.04.2019. The project proponent gave detailed presentation. The salient features of the project and the environmental impact assessment as presented by the proponent are as follows:

1. Government order/ Lease details:

The Quarry lease was applied in the name of Thiru M. Chinraj, Precise Area Communication letter was issued by the District Collect, Thiruvallur vide R.c.No. 197/2017/G&M-2 dated 24.04.2018 for a period of 1 Year. It is a Fresh Gravel quarry over an extent of 6.13.5 hectares of S.F.Nos. 17/3, 17/4, 5, 6, 7, 8, 9, 10, 11, 18/2, 3, 4, 18/5A, 5B, 5C, 6L, 7, 8, 9A, 9B, 10, 11, 12A, 12B, 12C, 13A, 13B, 13C, 13D in Sembedu Village, Tiruvallur Taluk, Tiruvallur.

2. Mining Plan/Scheme of Mining approval details:

Mining plan was prepared for the period of 1 Year. The Mining Plan was got approval from the Assistant Director, Department of Geology and Mining, vide 197/2017/G&M-2 dated 30.05.2018.

3. As per the Department of Geology and Mining, Mining plan approved for the 1 Year, the production schedule for 1 year states that the total Quantity of Gravel should not exceed 58,668m3 up to a depth of 2m below the ground level.

- There are no wastages anticipated during the quarrying operation. The entire Earth/Savudu/Gravel will be transported to the needy Customer's site.
- 5. Opencast method of shallow mining is proposed, Machineries like Excavator has proposed for this quarrying operation.
- 6. Earth/Savudu/Gravel is to be transported by tippers of 10 T capacity.

The SEAC noted the following:

- The Proponent, Thiru M. Chinraj has applied for Tor to SEIAA-TN on 18.06.2018 for the Proposed Fresh Gravel quarry over an extent of 6.13.5 hectares at S.F.Nos. 17/3, 17/4, 5, 6, 7, 8, 9, 10, 11, 18/2, 3, 4, 18/5A, 5B, 5C, 6L, 7, 8, 9A, 9B, 10, 11, 12A, 12B, 12C, 13A, 13B, 13C, 13D in Sembedu Village, Tiruvallur Taluk, Tiruvallur, Tamilnadu.
- The project/activity is covered under Category "B" of Item 1(a) "Mining of Mineral Projects" of the Schedule to the EIA Notification, 2006.

The SEAC ha noted that the project proponent has applied through online vide (SIA/TN/MIN/78817/2018) dated: 19.09.2018 for seeking Environment clearance. The proposed Gravel quarry over an extent of 5.99.5 in S. F. No. 180/2, 180/3, 180/5, 181/1 in T. Pudukottai Village, Manamadurai Taluk and Sivagangai District, Tamilnadu. As per the order dated 13.09.2018 of Hon'ble NGT Principle Bench, New Delhi in O.A No.186 (M.A.No.350/2016) and O.A. No.200/2016 of 2016 and O.A.No.580 /2016(M.A.No.1182/2016)andO.A.No.102/2017 and O.A.No.404/2016 (M.A.No.758 /2016, M.A.No.920 /2016, M.A.No.1122/2016, M.A.No.12/2017 & M.A.No.843/2017) and O.A.No.405/2016 and O.A.No.520 of 2016 (M.A.No.981/2016, M.A.No.982/2016 & M.A.No.384/2017), the proponent should apply for Terms of Reference in the online portal. Hence, the proponent is requested to apply through online for Terms of Reference and submit the acknowledgement copy. After submission of the same, the proposal shall be taken for appraisal by SEAC.
