


The SEIAA agreed with the recommendation of the SEAC that the letter dated 22/12/2020 of Shri Avinash Ray should be sent to the District Magistrate, Banda and District Mining Officer, Banda for providing the factual report on the matter within 15 days. The matter shall be discussed after receipt of factual report.

**14. Transfer of EC issued vide letter No. 689/Parya (DEIAA)-728/2017-18, Dt. 10-01-2018**

SEIAA noted that SEAC has commented that no action is required at SEAC level. SEIAA gone through the letter of Shri Ratan Kumar Nishad dated 12.01.2021, regarding transfer of Environmental Clearance to the above project issued by DEIAA vide letter no. 689/Parya/DEIAA-728/2017-18 dated 10.01.2018. SEIAA gone through documents and found that the above Environmental Clearance was issued to Smt Suketa Nishad, w/o Sri Vinay Kumar Nishad, 601/1A/ 227B and 541/205 Mirapur, Thana Antarsuiya, Sadar, Allahabad . SEIAA noted that the previous lease issued to Smt Suketa Nishad was cancelled vide DM, Allahabad, order no. 807/Khanij/e-nilam balu/2020-21 dated 31.07.2020 and another LOI was issued to Shri Ratan Kumar Nishad ,M/s Ram rattan construction, S/o Late Lalu lal, 6/41 Nai jhusi bazar, jhusi ,Phulpur, Prayagraj vide letter no. 2073/Khanij/2020-21 dated 24.12.2020. for 15,000 m<sup>3</sup> capacity per annum, whereas original EC was issued for 1 lakh m<sup>3</sup> per annum. Geo-coordinates of the area of original EC is also not mentioned. Hence SEIAA opined that the project proponent shall submit relevant documents.







