The Authority after detailed discussion and deliberations decided the following:

 Serial No. 1: Proposal was deferred in the 5.122<sup>nd</sup> meeting of SEIAA and PP was directed to submit the required documents to ascertain that the planning, sanction etc., of the industrial area was in two phases.

Details of the project were obtained from RIICO. The industrial area is being developed in two Phases for which different sanction orders were issued. No EC was required for the Phase-I in accordance with the Schedule of Project or Activity 7 (c) of EIA Notification, 2006 and its amendments thereof.

PP has applied for prior EC for Phase II without commencing work. Under these circumstances, there doesn't seem to be any apparent violation. However, since the approach to Phase II would be through Phase I and it would be maintained in a common manner, it would be appropriate if TOR is issued for the whole industrial area. With these observations, the matter is <u>referred back</u> to SEAC to re-examine its recommendations and appraise it from the view of grant of TOR.

- 2. Serial No. 2: Proposal was deferred in the 5.122<sup>nd</sup> meeting of SEIAA for submission of affidavit in the name of PP along with the details of all habitations nearby with the population in each and a clarification in regard to the land details also to be provided. PP has submitted reply which after detailed deliberation was found inadequate. The Authority is of the view that a notice may be given to PP apprising of the objection raised by ITI, which is in close proximity to the proposed unit and why proposal should not be rejected on account of possibility of being highly polluting in nature, in the form of suspended dust particles. Hence, the Authority decided to defer this proposal for submission of above clarification by PP in 30 days.
- 3. Serial No. 3: Proposal was deferred in the 5.110<sup>th</sup> meeting of SEIAA in light of the O.M. No. IA-22/01/2021-IA-III- Part (1) dated 15.01.2024 issued by MoEF&CC regarding following the SOP for dealing mining proposals under Ministry's OM dated 28.04.2023 on PARIVESH portal.

PP has submitted that the DEIAA EC has been re-appraised by SEIAA vide letter dated 26.05.2024. However, while examining the proposal, following deficiencies have been observed:

- MHTR and Jawai Sagar WLS are in 10 km radius of applied area. Hence, Conservation plan is required to be submitted.
- c. Condition no. 10 and 16 in the submitted CCR are mentioned as Not Complied. Hence, ATR for the same is required.

Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information within 45 days.

- 4. Serial No. 4, 5 31, 32, 34, 35, 36, : The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 5. Serial No. 6, 7, 8, 9, 12, 14, 37, 38, 39, 40, 43, 44, 45, 46: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- 6. Serial No. 10: This proposal seems to be an apparent case trying to evade prior EC and commencing construction. The Authority decided to <u>defer</u> this proposal and issue a Show Cause Notice to PP as well as Consultant, to explain why the case should not be treated as one of violation.
- 7. Serial No. 11: The Authority decided to <u>defer</u> this proposal and PP may be called to explain why the recommendations of SEAC may not be accepted that it is a case of violation.
- 8. Serial No. 13: The Authority decided to <u>defer</u> this proposal as the parking provisions provided in the project are not in accordance with the Authority's MOM dated 15.09.2023 and also, the application to CGWA has been applied for only 81 KLD but the fresh water requirement is 83 KLD for the proposal.
- Serial No. 15, 16, 17, 18, 19, 20, 21, 24, 25, 28: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR to these proposals.
- 10. Serial No. 22, 26, 27: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR to these proposal with the condition the certificate from DCF (WL), Rajsamand to be given at the time of final EC presentation.

- 11. Serial No. 23: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR to this proposal with the condition the Conservation plan for MHTR to be given at the time of final EC presentation.
- 12. Serial No. 29, 47: The Authority accepted the recommendations of SEAC and decided to <u>close and delist</u> these proposals.
- 13. Serial No. 30: In this proposal, PP proposed the production capacity for cluster is more than the production capacity approved in Cluster Mining Plan. Hence, Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP for 29,01,725 TPA (ROM) as mentioned in Cluster Mining Plan and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 14. Serial No. 33: The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects and not to obstruct or disrupt the natural flow of rain water /drainage of barsati nallah at any stage of mining activity.
- 15. Serial No. 41, 42: In these proposals, PP and Consultant do not state anything in their affidavits on the compliance or non-compliance of Common Cause Judgement of the Hon'ble Supreme Court. Hence, the Authority decided to <u>defer</u> these proposals for submission of affidavits in the prescribed format, within 45 days.
- 16. Serial No. 48: In this proposal, affidavits submitted by the PP and Consultant do not state whether the project is of violation/no violation of EIA Notification and also, condition no 16 of submitted CCR is mentioned as Not Complied. Hence, the Authority decided to <u>defer</u> this proposal for submission of revised affidavit and ATR for non-compliance in submitted CCR within 45 days.
- 17. Serial No. 49: In this proposal, Mount Abu WLS is at a distance of 2.05 km as mentioned in certificate issued by DCF, Sirohi vide letter dated 25.07.2022 but no distance from ESZ is mentioned and no Conservation plan has been submitted. Hence, the Authority decided to <u>defer</u> this proposal for submission of revised DCF Certificate stating clearly whether the lease falls in ESZ or not and conservation plan within 45 days.

- 18. Serial No. 50: The Authority accepted the recommendations of SEAC pertaining to re-appraisal of EC and decided to grant EC to this proposal with the additional condition that the PP shall abide by the final outcome of Hon'ble Supreme Court in WP (C) no. 1394/2023 and/ or any further OM issued by the MoEF&CC and to comply accordingly.
- 19. Serial No. 51: SEAC has recommended to Close and delist this proposal as PP has not submitted any document regarding transfer of EC. However, while examination it was found that PP has applied for transfer of EC on 29.04.2024 on Parivesh Portal 2.0. Hence, the Authority decided to <u>refer this proposal back to SEAC</u> to reexamine its recommendations while clubbing both the cases together.
- 20. Serial No. 52 to 134: These pertain to <u>re-appraisal of ECs</u> issued by the erstwhile DEIAAs. The Authority accepted the recommendation of SEAC and decided to <u>grant EC</u> to these proposals.
- 21. Serial No. 135, 136, 140, 141, 142, 143, 144, 145, 146, 148, 149, 150, 151, 152: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2023 issued by MoEF&CC.
- 22. Serial No. 137, 138, 139, 147: The Authority decided to grant <u>Transfer EC</u> to these proposals.
