## **Appraisal & Recommendations of SEAC:**

The said case was taken up during <u>272<sup>nd</sup> meetings of SEAC held on 14.07.2023</u> and the Appraisal Committee (SEAC) made recommendations to the Authority for Grant of <u>Environment Clearance for ONE YEAR</u>, under EIA Notification dated 14.09.2006 issued by Page 2 of 66

the MOEF & CC, GOI for *Mining of Sand (Minor Mineral) from the Riverbed of Yamuna River in Dostpur Block with 29,16,000 MT/year production* as mentioned in LOI/ Mining Plan /EIA Report/ ToR/ DSR/ Replenishment Report for plan period with maximum depth upto 3.0 meter as mentioned in Replenishment Study Report approved by Director Mines & Geology, Haryana and for quantity of 29,16,000 TPA.

#### **Findings and Decision of THE AUTHORITY (SEIAA):**

The said Proposal was taken up during 163<sup>rd</sup> Meeting of SEIAA held on 02.08.2023.

After having gone through the details and relevant record placed on file, alongwith considering the recommendations of the Appraisal Committee (SEAC), the Authority observed as under:

- 1. Whereas, the said Project is proposed to come up for Mining activities at Village Dostpur, Tehsil & District Palwal, Haryana (Mining lease area: 65.98 ha) by M/s Darsh Buildinfra Private Limited and "TEST REPORTS" at Page No. 185 & 186, pertains to Village Palsari, Bharampur, District Roop Nagar, Punjab and Village Hadiwal, District SBS Nagar, Punjab. This is baffling and bemusing as why the TEST REPORTS of some other States have been attached for seeking Environment Clearance in the said case.
- 2. District Survey Report (DSR) submitted by the Project Proponent and the same scrutinized by the Appraisal Committee (SEAC) is not in accordance with the directions of MOEF & CC, GOI, issued vide OM dated 28.04.2023 and the judgement dated 10.11.2021 of Hon'ble Supreme Court of India passed in Civil Appeal No. 3661 of 2020.
- **3.** With regard to Green Belt Development Plan submitted by the Project Proponent and the same appraised by the SEAC is not convincing as number of plant recommended are nearly 3000 per Hectare (five year plan), which otherwise should be around 45000 trees. This needs to be re-examined and re-appraised in the good

interest of environmental remedial measures and environmental protections activities.

In view of the above, the authority deemed it appropriate to **REFER BACK** this case to the Appraisal Committee (SEAC) to re-look into all observations listed above at <u>Sr. No. 1 to 3</u> and any other relevant issue pertaining to the project.

The said Proposal was submitted to the Authority, (SEIAA) (as <u>online Proposal</u>) <u>vide No. SIA/HR/MIN/301567/2023 dated 25.06.2023</u> for seeking Extension of Validity of EC letter dated 16.08.2022 under Category 1(a) of EIA Notification dated 14.09.2006. The Project Proponent has deposited Scrutiny fee of ₹ 1,50,000/- vide DD No. 829785 dated 28.06.2023 (in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021).

## **Appraisal & Recommendations of SEAC:**

The said case was taken up during 272<sup>nd</sup> meetings of SEAC held on 14.07.2023 and the Appraisal Committee (SEAC) made recommendations to the Authority for Grant of Extention of Environmental Clearance to the project upto validity of approved Mining Plan and upto depth of 1 mtr and for quantity of 4,00,000 TPA, as already approved in the EC issued for this Project dated 16.08.2022.

#### Findings and Decision of THE AUTHORITY (SEIAA):

The said Proposal was taken up during 163<sup>rd</sup> Meeting of SEIAA held on 02.08.2023.

The Authority after having seen the relevant record placed on the file and considering the recommendation of the Appraisal Committee (SEAC), observed that report regarding Replenishment issued by the State Geologist, Mines & Geology Department, Haryana appears to be <u>un-realistic and fragile on facts</u>. This needs a careful appraisal and realistic recommendations; in future.

With regard to Grant of Extension of validity of period for the Mining Activities, requested by the Project Proponent and recommended by the Appraisal Committee is considered by the Authority subject to the followings as under:

Petition is disposed of."  Thus, CWP No 4450 of 2019 stood disposed of on 8.04.2019. The order dated 08.04.2019 of the Hon'ble Punjab and Haryana High Court were rendered infructuous as MOEFCC did not comply with this order and granted EC to PP within the stipulated period. (a copy of the order dated 8.04.2019 is attached as Annexure -3).
Point 4:	Current status and standing of the CWP No 4450 of 2019 titled as Satish Kumar Garg & Company Versus State of Haryana & Others in the light of proceedings before the Hon'ble Supreme Court of India (SLP Diary No 14442 of 2021) for condonations of delay in filing.
Reply	In view of the position explained in preceding para there is no current status and standing of CWP No 4450 of 2019 as it stood disposed of on 8.04.2019. This writ petition had no relevancy with the SLP Diary No.14442 of 2021 which has been filed challenging the order of Hon'ble Punjab and Haryana High Court passed in CWP No.2682 of 2018 M/s Satish Kumar Garg & Co Vs State of Haryana dated 26.04.2018 directing the Forest Department Haryana to give NOC to the PP as prayed for in the writ petition.  Hon'ble High Court while allowing the writ petition on 26.04.2018 set aside the refusal of Forest Department to grant NOC vide its letter dated 28.10.2016. In compliance with this order dated 28.04.2018 of the Hon'ble High Court the DFO Mahendergarh issued a fresh NOC on 28.10.2018 reviving the earlier NOC dated 16.09.2002.  No appeal was filed either by the Forest or by Mines Department in Hon'ble Supreme Court of India challenging the order dated 28.04.2018 of Hon'ble High Court. Thus, judgment of Hon'ble High Court dated 28.04.2018 attained the finality and is binding on both Forest or Mines Department, Haryana four SLPs were filed in Supreme Court of India including that of Bheem Singh challenging the High Court order dated 28.04.2018. The Supreme Court issued notices to the respondents on the application for condonation of delay and limitation. There is a delay of 700 days in filing of SLPs.  No interim order has been passed by the Hon'ble Court It is doubtful whether these will be entertained or not on the ground of excessive delay. The cases are not being listed for hearing as petitioners till date have not filed affidavits for service of dasti notices to the respondents, delaying the matter deliberately as EAC was withholding grant of EC to the PP on this account. The Hon'ble Supreme Court vide order dated 30.11.2022 gave last opportunity to the petitioners to file affidavits for service of dasti notices to the respondents. A copy of the order of Supreme Court of India dated 30.11.2022 is attached as Annexure 4

Reply	As per Para IV of MoEFCC Notification dated 12.04.2022, it is mentioned w.r.t validity of Environment Clearance that "The prior Environment Clearance granted for mining projects shall be valid for the project life as laid down in the Mining Plan approved and renewed by Competent Authority from time to time, subject to a maximum of thirty years, whichever is earlier". In view of MoEFCC Notification dated 12.04.2022, we request to grant Environment Clearance to the project for a validity period of 30 years. Copy of MoEFCC Notification dated 12.04.2022 is enclosed as Annexure 6
Point 6:	Appraisal Committee (SEAC) needs to look into the distance of proposed Mining Site from the Closest inhabitation and clear-cut view on the same, whether this could not be a source of inconvenience and threat to Environment around.



A detailed discussion was held on the above mentioned reply submitted by PP to the observation raised in its 159<sup>th</sup> meeting by SEIAA as well as observations raised by SEAC in this meeting. In this case, proper public hearing was conducted and points/public demands raised during the public hearing thoroughly discussed and also were incorporated in the report submitted by Deputy Commissioner. It is also pertinent to mention here that as per record, all the parameters were taken up in the various meetings conducted before MoEF&CC, GoI. Further, in its 269<sup>th</sup> meeting, SEAC has already recommended to increase the amount/budget provided in EMP. It has already been discussed that the PP shall obtain permission from Forest Department regarding the transportation rasta going through Aravali area. An affidavit has already been taken in record, in this regard.

Dr. Rajesh, Mining Officer a representative from the office of Director General, Mines and Geology, Haryana was also present during the meeting and submitted that he has personally visited the site and confirmed that the project site is a barren government land having no important trees/plants grown there.

The committee considered the reply submitted by PP and after detailed deliberation Committee was of the unanimous view that this case be <u>again recommended to SEIAA for</u> grant of Environment Clearance as conveyed vide 269<sup>th</sup> Meeting of SEAC.

#### Findings and Decision of THE AUTHORITY (SEIAA):

The aforesaid Proposal was again taken up during 163<sup>rd</sup> Meeting of SEIAA held on 02.08.2023.

MOEF & CC, GOI vide F. No. IA-J-11015/14/2021-IA-II(M) dated 01.06.2023 transferred the instant Proposal alongwith record file (photocopies) to State Environment Impact Assessment Authority, Haryana for further necessary action.

In the background of this case, it is relevant to place on the record that the Divisional Bench of Hon'ble Punjab & Haryana High Court was pleased to make certain directions to MOEF & CC, GOI in the case of M/s Satish Kumar Garg & Company Versus State of Haryana and Others (CWP No. 4450 of 2019) vide order dated 08.04.2019, relevant part of the same is reproduced as under:

#### 

Having regard to the limited prayer made, seeking direction to the Ministry of Environment and Forest to consider the grant of environment clearance to the petitioner, we deem it appropriate to direct the Union of India-Ministry of Environment and Forest to decide the matter at hand, as expeditiously as possible preferably within a period of six weeks from the date of receipt of certified copy of the order"

The Authority after having gone through the record pertaining to the case and further perusing the recommendation of Appraisal Committee from Noting Page Number 28 to 34 alongwith the observations dated 28.07.2023 made by one of the Member of the Expert Appraisal Committee Sh. Rajibir Singh Bondwal, IFS (Retd.) and comments on the same by the Member Secretary and Chairman of the State Expert Appraisal Committee (SEAC), agreed that no mining activities can be allowed to be undertaken, if statutory requirements or required criteria is not upto the observance of the relevant provisions of Act & Rules, as may be applicable.

But, at the same time, such criteria and yard stick can't be applied in varied manner and fashion, when it comes to the similar and almost the same location. The Yard stick has to be

uniformed and consistent, without compromising any aspect of the ecology and surroundings, which stands as threat and dent to the Environment.

While examining the record, the Authority observed that Mining Activity sites have been functional within the vicinity of 1.25 Km to 4.5 km radius from the proposed Project Site. Details of the same are depicted below in tabulated form:

In the light of details above and emerging matrix of the facts, indicates that mining activities have already been going on in the close proximity of the proposed project site.

Therefore, keeping in view the recommendations dated 20.07.2023 & subsequent comments dated 28.07.2023 of the Appraisal Committee (SEAC) and directions dated 08.04.2019, made by the Hon'ble Punjab and Haryana High Court in the case of M/s Satish Kumar Garg & Company Versus State of Haryana and Others (CWP No. 4450 of 2019), the Authority is inclined to consider the proposal positively i.e. agreed to GRANT ENVIRONMENT CLEARANCE for the Project, subject to the following conditions:

- 1. That the Project Proponent shall carry out Mining Activities within the mining leased area as per the **APPROVED MINING PLAN** issued by Mines & Geology Department, Haryana.
- 2. That the Project Proponent shall not carry out Mining Activities within the Green Area.
- 3. That Project Proponent shall ensure that no loss or damage is caused to the local area ecological set up, in any manner.
- 4. That Project Proponent shall strictly adhere to provisions of Approved Mining Plan, relevant provisions of Forest Act, and other relevant, Acts / Rules (as may be applicable).

- 5. That validity of the project shall be AT PAR with the Approved leased period within the scope & meaning of Approved Mining Plan.
- 6. That Environment Clearance granted to the said project is subject to the final, outcome of pending Court Cases, if any.

# Accordingly, the case is disposed of.

#### **Appraisal & Recommendations of SEAC:**

Lastly, the case was taken up in 272<sup>nd</sup> meeting held on 14.07.2023. The PP and consultant appeared before the committed and presented their case. They were informed about a fresh compliant received in this case through email on dated 11.07.2023. The copy of the same was already circulated to PP/consultant on dated 12.07.2023. PP submitted the reply of the complaint in tabular form as follows:

The PP presented the case before the committee. The committee after discussion directed the PP for submitting some key information in affidavit form about the project and PP has submitted the affidavit regarding:

- 1. That the total acquired land area of project is 207.07 acres out of which, only 4,050 sqm. of Plot area is constructed and operating at Plot no. 1, 2 & Part of 3 which having total built-up area of 3,097.968 sqm. comprising of Basement Floor is 479.852 sqm., Ground Floor is 2,433.70 sqm, First Floor is 169.275 sqm. and Second Floor is 15.141 sqm. in Name of M/s Karnal Print & Pack Cluster Pvt. Ltd.
- 2. That latest Geo-tag site photographs of project site are attached as Annexure-A
- 3. That in compliance of complaint received from Mr. Vikram Singh in SEAC/SEIAA Haryana through Email/PUC dated 11.07.2023, the reply has been given to Member Secretary SEAC on dated 13.07.2023 vide letter no.HSIIDC:Engg:K:2-23:1351. Copy of same is *Annexure-B*.
- 4. That the complainant Mr. Vikram Singh is habitual of making complaint against this project as and when the meeting of SEAC/SEIAA is held.

It is, further, discussed that in 269<sup>th</sup> meeting of SEAC, the Committee had recommended that Rs.10 lakhs earlier deposited with CM Relief Fund may be deducted from total environment compensation cost. However, after detailed discussion, the committee reviewed it and decided that this amount of Rs.10 lakh should not be deleted from the overall damage assessment already recommended vide 269<sup>th</sup> MoM of SEAC held on 12.06.2023 as those Rs.10 lac were deposited under CM Relief Fund.

After due deliberation, on actual status and quantum of violations at the project site with current status, the committee considered the reply submitted by PP and decided that the case be <u>again recommended to SEIAA for granting environment clearance to the project as</u> conveyed vide 269<sup>th</sup> MoM of SEAC.

#### Findings and Decision of THE AUTHORITY (SEIAA):

The aforesaid Proposal was again taken up during 163<sup>rd</sup> Meeting of SEIAA held on 02.08.2023.

Upon perusal of record and details pertaining to the case alongwith recommendations made by the Appraisal Committee (SEAC), the Authority observed as under:

- 1. Terms of Reference (TOR) in the said case was granted in the year 2008 for the development of Industrial Infrastructure in Sector-37, Karnal, Haryana, for which EIA / EMP Report was submitted in the Year 2015 and same was not considered being time barred, validity case.
- 2. The Project Proponent again applied for Grant of Environment Clearance for the same project in the year 2019. Thereafter, a sub-committee was constituted by the Authority and later called for the status report of the project site. The Committee vide letter dated 16.06.2020, submitted their report, the relevant part/ conclusion of the same is reproduced as under:

#### Summary

Violation in terms of established industry was found at Industrial Plot No. 1,2 & part of 3 at HSIIDC Industrial Estate Sector-37, Karnal. So, clear cut violation in terms of established industry was found at Plot No. 1,2, and 3 (part) HSIIDC, Sector-37, Karnal. No any other violation was found at HSIIDC, Sector-37, Karnal.

The Authority after due deliberation, arrived at a conclusion that **ECONOMIC DEVELOPMENT, PROTECTION & CONSERVATION OF ENVIRONMENT** has to 

"CO-EXIST" (side by side), without any unreasonable leverage and compromise.

Whereas, upon perusal of the details/ record relating to the project, it is understood that an area of more than 207 acre was to be developed as a Economic Growth Industrial Centre by the HSIIDC to promote MSME / SSME in Sector-37, Karnal by **Haryana State Industrial Infrastructure Development Corporation Ltd (HSIIDC)** in the year 2008.

Whereas, more than 15 years have already elapsed and the issue of **Grant of Environment Clearance**, in the instant case could not be resolved, due to one or the other complications, handicaps, thus proceedings, remained inconclusive, till date. The Authority is appalled and disappointed to observe that such proposals should have been resolved, "well in time". Rather should not have been allowed to linger with uncertainty and indeterminate state. This probably could have denied many new / budding promising entrepreneurs an opportunity to write their destiny and fate. Since enough water has already flown, it is the time to take a conclusive call for decision in this case, without any further delay.

It is more than clear that HSIIDC is a State body, which has been mandated to create and develop infrastructure for the Industrial and Economic Growth Activities for the people. The Authority has a firm believe that loss & damage to the Environment should not be pardoned and compromised. But, the accountability for the same has to be well reasoned & convincing, based on the ground reality & coupled with circumstances.

Upon perusal of record and replies furnished by the Project Proponent & report of the Sub-committee, the Authority observed as under:

- 1. That out of total land of 207.07 acres, approximately 4000 Sqmtrs Plot Area having Plot No. 1, 2 & 3 (part) have been allotted to a non-polluting MSME Industry in the Year 2012.
- 2. That, the said Project falls under Category 7(c) of the EIA Notification dated 14.09.2006 being Industrial Estate Project. Since, the <u>size of the project is less than 500 hectares</u>, <u>but more than 50 Hectare</u>, therefore, the Project Proponent opted to apply under Violation for Grant of Environment Clearance (EC) within the scope & meaning of the EIA Notification dated 14.09.2006 under Category 8(b) for the Area Development.

- 3. That since, allotment of Plot No. 1, 2 & 3(part) measuring approximately 4050 Sqmtrs (Plot Area) with built up area 3097.96 Sqmtr, before obtaining the Environment Clearance is certainly, an act, which amounts to a violation.
- 4. Accordingly, Project Proponent approaches the Authority for Grant of EC under Violation Category. In all practicality, beside violation, no major damage / loss to the Environment has been caused on the ground (Recent Photographs confirms the same). The entire patch of land of 207.07 acre, stands un-occupied, open to sky without any activity. Thus, in real terms no loss to the Environment beyond the activities being held at Plot No. 1, 2 & 3 (part) can be counted as the packaging industry has no major discharge and scope to generate pollution load.

In the light of above, the Authority deemed it appropriate to partly agree with the recommendation of the Expert Committee to consider the Environment Compensation Cost to the tune of Rs. 13.82 Lakh for the functioning & conducting activities at the project site.

Further, the Authority decided to impose a Penalty of Rs. 50.00 Lakh for the violations as discussed above.

Accordingly, the Authority decided to GRANT ENVIRONMNT CLEARANCE TO THE PROJECT with the direction to deposit Penalty & Environmental Compensation Cost in accordance with the direction dated 28.07.2022 issued by the MOEF & CC, GOI, in this regard.

The Case is disposed of.

The case was taken up during 159<sup>th</sup> Meeting of SEIAA held on 15.06.2023. The Authority having perused the details placed on the record alongwith considering the recommendations made by the Appraisal Committee (SEAC) and further holding discussions, made the observations as under:

- 1. Status of the license to develop the said project requires clarification from the competent authority.
- 2. Project Proponent has mention to achieve Zero Liquid Discharge. PP needs to elaborate on this claim.
- 3. Project Proponent needs to produce a copy of the proposal submitted to DTCP for Occupation Certificate, has Project Proponent made & completed the construction for which OC has been applied and sought from DTCP?
- 4. Structure stability certificate is not from a reputed & authorized agency.
- 5. Khasra Details as mentioned in the Aravali NOC & license from DTCP appears to be mismatching.
- 6. For High Tension Line, proposal for passage is required.

In view of the above, the Authority decided to Refer Back the case to the Appraisal Committee to re-look and examine the observations at Sr. No. 1 to 6, accordingly.

The matter was taken up during 159<sup>th</sup> Meeting of SEIAA held on 15.06.2023. After having gone through the details placed on file alongwith considering the recommendations of the Appraisal committee and perusal of Site Inspection Report of the Sub-committee, besides hearing

- 4. 759 KLD of excess treated water is to be released into external sewer. Carrying capacity of sewer?
- 5. Haryana State Pollution Control Board has filed prosecution against the Project before the Environment Court (Proceedings pending) for violations & irregularities.
- 6. Clarity with regard to Occupation Certificate is required to be made by the Project Proponent before the Appraisal Committee.

In view of the above, the Authority after due deliberations, decided to Refer Back the case to the Appraisal Committee (SEAC) with the directions to re-look/examine all the observations listed above at <u>Sr. No. 1 to 6</u>, besides any other issue, related to Environment, which comes to the notice of the Appraisal Committee. In this regard, the PP need to provide a clarification also on the construction area details of the basement of Block A done till 2014-15 which was altered in the later building plans. It has also been observed by the sub-committee that at present there is no STP installed. The status of STP installation need to be submitted by the PP as Block B is operational. The current status of tree plantation, schedule of further tree plantation as per the plan of the project needs to be submitted by the PP.

After detailed discussion, the committee decided to send the case to SEIAA with the recommendation that the request of project proponent for withdrawal of ToR under violation category be rejected as the project is under violation category of environment clearance.

# Findings and Decision of THE AUTHORITY (SEIAA):

### **Appraisal & Recommendations of SEAC:**

The said case was taken up during 265<sup>th</sup> meetings of SEAC held on 12.04.2023 and SEAC recommended the Project to SEIAA for Grant of Environment Clearance.

The matter was again taken up during 159<sup>th</sup> Meeting of SEIAA held on 15.06.2023. The Authority after having gone through the details placed on the file alongwith perusal of recommendations made by the Appraisal Committee (SEAC) observed that the Project Proponent made his representation before the Appraisal Committee and submitted revised comparative statement to develop 36.642 acres without revising his original proposal through

<u>PARIVESH Web Portal</u>. Which is not good enough to handle and appraise such sensitive issues, where area has been frozen being <u>Natural Conservation Zone (NCZ)</u>. The Authority deemed it appropriate to further direct the Appraisal Committee to capture relevant information with precedents, if any from the concerned Authorities and then make merit based recommendations, stating clearly whether the development & construction activities within & adjoining to the Natural Conservation Zone (NCZ) could be a viable and appropriate move in the larger interest of Environment Protection/Conservation.

### Accordingly, the case was Referred Back to SEAC.

Thereafter, the case was taken up during 271<sup>st</sup> meeting held on 30.06.2023. The PP and consultant appeared before the committee and presented their case. During the presentation and discussion, the PP submitted a letter dated 20.06.2023 that there is no area freeze under **Natural Conservation Zone** (**NCZ**) in our entire project on 53.3833 Acres. However, in zoning plan, 16.7413 Acres land frozen till the said land is either purchased by Loon Land Development Ltd. or execution of registered collaboration agreement with land owners/land owning companies. A copy of zoning plan is submitted by PP in this regard.

PP has further requested to generate Additional Details Sought (ADS) so that they can upload the revise proposal on the PARIVESH Web Portal.

After detailed discussion, the committee acceded with the request of PP and decided that ADS be generated through PARIVESH portal, in this case so that the PP may make required changes.

ADS was generated through PARIVESH portal which was closed by PP.

The case was again taken up during **273<sup>rd</sup> meeting held on 28.07.2023.** The PP alongwith consultant appeared before the committee and presented their case. The PP submitted reply of observations of SEIAA raised in its 159<sup>th</sup> meeting vide letter dated 11.07.2023 alognwith affidavit dated 28.07.2023.

The PP has submitted that as per observation of SEIAA, they have uploaded the revised document on PARIVESH portal. With regard to NCZ, the PP have already submitted an affidavit as stated above stating therein that no land of project site is involved/part of NCZ.

A detailed discussion was held on the submission as well as information/documents provided by the PP during the meeting and found them in order. After due deliberation, the committee decided that the project be recommended to SEIAA for grant of Environment

Clearance with conditions as conveyed vide 265<sup>th</sup> and 268<sup>th</sup> Minutes of Meeting of SEAC, Haryana.

## **Findings and Decision of THE AUTHORITY (SEIAA):**

The aforesaid Proposal was again taken up during 163<sup>rd</sup> Meeting of SEIAA held on 02.08.2023.

The Authority, after having seen the details and relevant record placed on the file besides considering the recommendations of the Appraisal Committee (SEAC); decided to defer this case for further examination of submissions made by the Project proponent.

Accordingly, the case is deferred till next meeting.

The project was submitted to the SEIAA, Haryana vide <u>online proposal No. SIA/HR/MIN/431911/2023</u> for obtaining <u>Environmental Clearance for Capacity Expansion</u> under Category 1(a) of EIA Notification 14.09.2006. The Project Proponent has deposited due Scrutiny fee (as applicable) of ₹ 1,50,000/- vide DD No. 004710 dated 11.04.2022 (in compliance of Haryana Government, Environment & Climate Change, Department Notification No. DE&CCH/3060 dated 14.10.2021).

### **Appraisal & Recommendations of SEAC:**

The said case was taken up in 271<sup>st</sup> meeting held on 29.06.2023 and SEAC recommended the Project to SEIAA for grant of environment Clearance.

The said Proposal was taken up during 162<sup>nd</sup> Meeting of SEIAA held on 19.07.2023. The Authority, after having gone through the details and relevant record placed on file, alongwith considering the recommendations of the Appraisal Committee (SEAC), observed that District Survey Report (DSR), pertains to some other District, instead of Charkhi Dadri, where Mining activities are to be carried out.

Besides this the Authority also observed and examined the proposal pertaining to enhancement of Production Capacity from existing 60,00,000 TPA to 85,00,000 TPA. The Appraisal Committee has recommended the same but without any justification. Whereas, the Authority deemed it appropriate to understand, whether proposed enhancement of production capacity will cause any dent on the Environment and other parameters, upon considering the proposal.

This is due to a recent incident, occurred in District-Bhiwani (Mining Site - Dadam), where many lives were lost and thereafter, it was also found that indiscriminate mining has made serious dents on the Environment / local surroundings by disturbing the eco-system (fauna & flora) and adversely affecting the normal life of the people. Hon'ble NGT also made serious observation and constituted a team of Experts to study and understand the reasons, leading to such unfortunate incident.

Therefore, it is more than imperative and urgent to understand, before considering, such proposals, where production capacity of this magnitude i.e. 60,00,000 TPA to 85,00,000 TPA is proposed to be enhanced, without expressing justification and possible dent on the Environment. The Authority is of the view that Appraisal Committee, while considering such proposals should have sought reasonability and circumstances for considering the proposal of enhancement of this magnitude. Therefore, a response needs to be called from Mines & Geology Department, Haryana in this regard.

Further, the Authority decided to constitute a Sub-committee of the followings:

- 1. Member Secretary, SEIAA (Head of the Sub-committee);
- 2. Member Secretary, SEAC (Member);
- 3. Representative of Member Secretary of HSPCB (Member);
- 4. Mining Officer, Charkhi Dadri (Member);
- 5. Regional Officer of HSPCB of the relevant area (To assist the Sub-committee).

The Sub-committee shall visit the project site and submit a detailed report about the proposal.

In view of the above, the **Authority decided to REFER BACK the case to Appraisal Committee (SEAC)** to re-examine the issues of capacity enhancement. Further, the Appraisal Committee needs to look into the precedents, if any and the circumstances and justification for considering such proposals.

Thereafter, the case was taken up during 273<sup>rd</sup> meeting of SEAC held on 28.07.2023. The sub-committee constituted by SEIAA in its 162<sup>nd</sup> meeting, visited the site on 25.07.2023. The sub-committee has submitted its report and observed that the proposed enhancement of production capacity (from 60 MTPA to 85 MTPA) may be considered subject to certain conditions:

- 1. The project proponent will provide the provision of a dense multilayer green belt with 5 rows of avenue plantations all around the project's boundary using indigenous local species of plants to control air emissions, and noise pollution, and maintain ecosystem equilibrium.
- 2. The project proponent must implement sufficient dust suppression measure using water gun and sprinklers in critical with high PM<sup>10</sup> and PM<sup>2.5</sup> level to meet CPCB norms for ambient air quality.
- 3. Blasting operations should only be conducted during the daytime and must follow controlled practices to minimize ground vibrations and fly rocks. Drills should use dust extractors or water injection systems.
- 4. An Occupational Health Specialist should be appointed for regular medical examinations of workers engaged in the project. Workers with ailments like BP, diabetes, smoking habits, etc., should undergo health check-ups once every six months, and necessary preventive measures should be taken. National Institute recommendations for mine worker occupational environment should be implemented.
- 5. Mining operations should be limited to 2 meters above the groundwater table and should not intersect the groundwater table.
- 6. Pollution due to transportation should be effectively controlled, and mineral transportation should be carried out through covered trucks only. Vehicles should not be overloaded, and only those with a PUCC (Pollution Under Control Certificate) should be allowed to ply.
- 7. Rainwater harvesting measures should be planned, developed, and implemented in consultation with the Central Groundwater Board/Haryana Water Resource Authority to augment groundwater resources
- 8. Air pollution prevention and control measures should be implemented in surrounding villages i.e. Khanak, Baganwala and Tosham areas with heavily saturated Ambient Air Quality to bring down AAQ within prescribed standards. The project proponent will provide six Continuous Ambient Air Quality monitoring stations at different locations to cover Air quality profile of the lease mining area and surrounding.
- 9. Illumination and sound at the project during night time should not disturb nearby villages. Flood lights should be oriented away from villagers, and noise level should be kept within prescribed limits for day and night hours.
- 10. Vibration studies should be conducted before blasting to evaluate the impact on nearby habitats Alternative mineral extraction methods should be considered near sensitive areas vulnerable to blasting vibrations.
- 11. Main haulage roads should have permanent water sprinklers, and other roads should be regularly wetted with water tankers fitted with Sprinklers.
- 12. Mineral transportation through villages should not be allowed, and a bypass road should be constructed to mitigate sound, dust, and accident impacts. The project proponent should bear the cost of widening and strengthening existing public road networks if used for the project.
- 13. Regular monitoring of groundwater levels and quality should be conducted by establishing a network of wells and piezometers, and data should be sent to relevant authorities periodically.
- 14. Critical parameters like PM<sup>10</sup>, PMs, NO, and SO, will be monitored on a daily basis through CAAOMS (Continuous Ambient Air Quality Monitoring

- Stations) and water quality should be monitored periodically, and data should be made public via the company's website and display boards at the project site.
- 15. Noise levels in the work environment should be controlled below 85 dBA, and workers should be provided with ear plugs/muffs.
- 16. Personnel in dusty areas should wear protective respiratory devices, and receive adequate training and information on safety and health aspects.
- 17. Prior permission from competent authorities is required for the drawl of surface water and groundwater.

Further, the PP has also submitted an affidavit clarifying the issue of capacity enhancement. The PP submitted as under:

- 1. Atela Kalan Mine is situated in district CharkhiDadri, Haryana as per approved District Survey Report. Khasra no. and area are mentioned in the approved DSR on page no. 09 which was submitted to SEAC on 30.06.2023.
- 2. The total Geological reserve is estimated as 74,338,540 Metric Tonne and extractable reserves at 90% recovery are 66,904,686 Tones as per approved Mining Plan. Total extract reserve up to May 2023 is 35,015,010.79 Metric Tonne. Thus, the proposed balance mineable reserve is 31,889,675.21 Metric Tonne.
- 3. Previous mining plan was approved for the production capacity of stone 60,00,000 TPA. Earlier the mine was in development stage and production was less with limited equipment. Now, the mine is fully developed and, number and capacity of the mining equipment have increased, enabling us to increase the production from 60,00,000 TPA to 85,00,000 TPA. Now, Mining plan is approved for the production of 85,00,000 TPA till the end of mine.
- 4. As no exploration was done in the area thus the status of the reserves remain the same as it was on 15.09.2014.
- 5. The Targeted Quantity of Masonary stone yearly to be produced in the next 4 years, till the end of mine.

6. SEIAA, Haryana granted the Environmental Clearance to similar case for the Capacity Expansion Mining of Stone from 5.6 MTPA to 9 MTPA at Khasra No 216, over area of 29.50 ha Located at Kalyana 2 Village Kalyana, Tehsil & District Charkhi Dadri, Haryana proposed by M/s SBIPL Projects Limited. (Vide EC letter No. EC23B001HR137089 dated: 31.05.2023) (copy enclosed).

A detailed discussion was held on the report of sub-committee constituted by SEIAA as well as the reply submitted by the PP in support of their contention to increase the capacity of production. Report submitted by sub-committee is self-explanatory, however, it is recommended that the certain conditions raised by the sub-committee may be considered and added while granting of Environment Clearance to the project. The report of committee is also enclosed with the concerned file.

Further, PP also submitted that in past also the SEIAA has granted environment clearance to some other projects in nearby area while raising their capacity of production (EC letter enclosed) and further submitted that as per record DSR is of District Charkhi Dadri and not of some other district.

After detailed deliberations on the documents produced during the presentation, submissions made by the PP and keeping in view the report of sub-committee constituted by SEIAA, the committee has decided to recommend the case to SEIAA for granting Environment Clearance as per the conditions conveyed vide Minutes of 271<sup>st</sup> meeting of SEAC and certain conditions observed by the sub-committee may also be considered and added while granting EC to the project.

# Findings and Decision of THE AUTHORITY (SEIAA):

The aforesaid Proposal was taken up during 163<sup>rd</sup> Meeting of SEIAA held on 02.08.2023.

After perusal of record & due deliberations, the Authority decided to defer this case, till next meeting.

Accordingly, the case is deferred.

The project was submitted to the SEIAA, Haryana vide online proposal No. SIA/HR/MIN/421906/2023 on 20.03.2023 for obtaining Environmental Clearance for Expansion in Production Capacity under Category 1(a) of EIA Notification 14.09.2006. The Project Proponent has deposited due Scrutiny fee (as applicable) of ₹ 1,50,000/- vide DD No. 269785 dated 21.10.2022 (in compliance of Haryana Government, Environment & Climate Change, Department Notification No. DE&CCH/3060 dated 14.10.2021).

# **Appraisal & Recommendations of SEAC:**

The said case was taken up in 271<sup>st</sup> meeting held on 29.06.2023 and SEAC recommended the Project to SEIAA for **Grant of Environment Clearance**.

The said Proposal was taken up during 162<sup>nd</sup> Meeting of SEIAA held on 19.07.2023. (Upon having seen the details pertaining to the said case, the Authority decided to record similar observations as made in the Item No. 6, above).

The Authority, after having gone through the details and relevant record placed on file, alongwith considering the recommendations of the Appraisal Committee (SEAC), observed and examined that the proposal pertaining to enhancement of Production Capacity from existing 10

MTPA to 24 MTPA. The Appraisal Committee has recommended the same but without any justification. Whereas, the Authority deemed it appropriate to understand, whether proposed enhancement of production capacity will cause any dent on the Environment and other parameters, upon considering the proposal.

This is due to a recent incident, occurred in District-Bhiwani (Mining Site - Dadam), where many lives were lost and thereafter, it was also found that indiscriminate mining has made serious dents on the Environment / local surroundings by disturbing the eco-system (fauna & flora) and adversely affecting the normal life of the people. Hon'ble NGT also made serious observation and constituted a team of Experts to study and understand the reasons, leading to such unfortunate incident.

Therefore, it is more than imperative and urgent to understand, before considering, such proposals, where production capacity of this magnitude i.e. 10 MTPA to 24 MTPA is proposed to be enhanced, without expressing justification and possible dent on the Environment. The Authority is of the view that Appraisal Committee, while considering such proposals should have sought reasonability and circumstances for considering the proposal of enhancement of this magnitude. Therefore, a response needs to be called from Mines & Geology Department, Haryana in this regard.

Representations dated 30.06.2023 & 13.07.2023, received from the Village Panchayat and other bodies, opposing the proposal, needs to be looked into in the fairness and propriety of the things pertaining to their interest, being the stack holders in the local area, so that propriety and genuinity of their plea can be understood. Therefore, the Authority decided to constitute a Sub-committee of the followings:

- 1. Member Secretary, SEIAA (Head of the Sub-committee)
- 2. Member Secretary, SEAC (Member)
- 3. Representative of Member Secretary of HSPCB (Member)
- 4. Mining Officer, Bhiwani (Member)
- 5. Regional Officer of HSPCB of the relevant area (To assist the Sub-committee)

  The Sub-committee shall visit the project site and submit a detailed report about the proposal, alongwith hearing the representations received in this case.

In view of the above, the Authority decided to REFER BACK the case to Appraisal Committee (SEAC) to re-examine the issues of capacity enhancement. Further, the Appraisal Committee needs to look into the precedents, if any and the circumstances and justification for considering such proposals.

The case was taken up during **273<sup>rd</sup> meeting held on 28.07.2023**. The sub-committee constituted by SEIAA in its 162<sup>nd</sup> meeting, visited the site on 25.07.2023 and has submitted its report with recommendation that the proposed enhancement of production capacity (from 10 MTPA to 24 MTPA) may be considered subject to certain conditions:

- 1. The project proponent must implement sufficient dust suppression measures using water guns and sprinklers in critical areas with high PM, & PM levels to meet CPCB norms for ambient air quality.
- 2. Blasting operations should only be conducted during the daytime and must follow controlled practices to minimize ground vibrations and fly rocks. Drills should use dust extractors or water injection systems.

- 3. The project proponent will provide the provision of a dense multilayer green belt with 5 rows of avenue plantations all around the project's boundary using indigenous local species of plants to control air emissions, and noise pollution, and maintain ecosystem equilibrium.
- 4. Mining operations should be limited to 2 meters above the groundwater table and should not intersect the groundwater table.
- 5. Rainwater harvesting measures should be planned, developed, and implemented in consultation with the Central Groundwater Board/Haryana Water Resource Authority to augment groundwater resources.
- 6. An Occupational Health Specialist should be appointed for regular medical examinations of workers engaged in the project. Workers with ailments like BP, diabetes, smoking habits, etc., should undergo health check-ups once every six months, and necessary preventive measures should be taken. National Institute recommendations for mine worker occupational environment should be implemented.
- 7. Pollution due to transportation should be effectively controlled, and mineral transportation should be carried out through covered trucks only. Vehicles should not be overloaded, and only those with a PUCC (Pollution Under Control Certificate) should be allowed to ply.
- 8. Air pollution prevention and control measures should be implemented in surrounding villages i.e. Khanak, Baganwala and Tosham areas with heavily saturated Ambient Air Quality to bring down AAQ within prescribed standards. The project proponent will provide six Continuous Ambient Air Quality monitoring stations at different locations to cover Air quality profile of the lease mining area and surrounding.
- 9. Vibration studies should be conducted before blasting to evaluate the impact on nearby habitats Alternative mineral extraction methods should be considered near sensitive areas vulnerable to blasting vibrations.
- 10. Prior permission from competent authorities is required for the drawl of surface water and groundwater for the project.
- 11. Main haulage roads should have permanent water sprinklers, and other roads should be regularly wetted with water tankers fitted with Sprinklers.
- 12. Mineral transportation through villages should not be allowed, and a bypass road should be constructed to mitigate sound, dust, and accident impacts. The project proponent should bear the cost of widening and strengthening existing public road networks if used for the project.
- 13. Critical parameters like PM10, PMs, NO, and SO, will be monitored on a daily basis through CAAQMS (Continuous Ambient Air Quality Monitoring Stations) and water quality should be monitored periodically, and data should be made public via the company's website and display boards at the project site.
- 14. Personnel in dusty areas should wear protective respiratory devices, and receive adequate training and information on safety and health aspects.
- 15. Noise levels in the work environment should be controlled below 85 dBA, and workers should be provided with ear plugs/muffs.
- 16. Regular monitoring of groundwater levels and quality should be conducted by establishing a network of wells and piezometers, and data should be sent to relevant authorities periodically.
- 17. Illumination and sound at the project site during night time should not disturb nearby villages. Floodlights should be oriented away from villagers, and noise levels should be kept within prescribed limits for day and night hours.

The PP also submitted reply of the observations raised by SEIAA in its 162<sup>nd</sup> meeting which is re-produced as under:

i.

- a) The Corporation was granted EC for 10 MTPA as per EC letter dated 06.05.2015. The said capacity was achieved on 03.12.2022 for the period from 03.01.2022 to 02.01.2023. Further, for the current period, the Corporation has already achieved capacity of approx. 7.5 lakh MT in a span of seven months and is projected to achieve the sanctioned capacity by the end of September 2023. Considering the production capacity achievement over the last two years, it can be inferred that there is sufficient demand for the product in the market and also the production capacity of the mine is increasing on yearly basis. It would also be worthwhile to mention that the Corporation had achieved production of approximately 13 Lakh MT on monthly basis during the first five months of the current production period and thus, upscaling the production to meet the proposed enhancement is achievable.
- b) In the neighbouring mining zone viz. Charkhi Dadri, a mine which is spread over approx. 30 hectares is having production capacity of 9 MTPA. Considering the area of Khanak mines, which is spread over 258.30 hectares, the proposed production capacity of 24 MTPA is justifiable.
- c) The Corporation has sufficient space in the mine to ensure that there is no hindrance in transporting the material and managing the increased capacity.
- ii. In the recent past:
  - (a) M/s SBIPL Projects Ltd., Charkhi Dadri (Haryana) has been granted EC for enhanced capacity of 9 MTPA from the earlier sanctioned 5.6 MTPA.
  - (b) M/s Maa Santoshi Khanij Udyog, Distt. Rewari has been granted EC vide letter dated 20.10.2020 for enhanced capacity of 12.59 lakh TPA from 9000 TPA.
  - (c) The MoEF&CC vide letter dated 18.11.2022 has granted EC for enhanced capacity of 25 lakh TPA from 9 lakh TPA to M/s Star Cement Limited.
- iii. The Mines & Geology Department, Haryana has approved the Mining Plan of the Corporation for the enhanced capacity of 24 MTPA vide letter No. DMG/HY/MP/Khanak/2022/5989 dated 29.09.2022.

The detailed discussion was held on the report of sub-committee constituted by SEIAA as well as the reply submitted by the PP in support of their contention to increase the capacity of production. Report submitted by subcommittee is self-explanatory, however, it is recommended that the certain conditions raised by the sub-committee may be considered and added while granting of Environment Clearance to the project. The report of sub-committee is also enclosed with the concerned file.

The PP further submitted that, in past also the SEIAA has granted environment clearance to some other projects in nearby area while raising their capacity of production (**EC letters enclosed**).

The hearing was given to the complainant Sarpanch of village Khanak, Chairman, Zila Parishad, Bhiwani have joined through Video Conference by Members of sub-committee constituted by SEIAA. Complainant Sarpanch was asked to submit their point of view about the complaint, she briefed that due to mining in the area there is pollution, cracks in the houses etc. and Chairman Zila Parishad, Bhiwani explained that mining should be permitted as it is the life line of the approx 80 villages of the surrounding area and regular sprinkling of water will reduce the pollution. The copy of complaint dated

28.07.2023 received from Sarpanch Village Khanak and copy of letter dated 27.07.2023 of Chairman, Zila Parishad are also enclosed herewith.

The complaint of Sarpanch, Village Khanak received by way of email dated 28.07.2023 was further forwarded to PP for submitting reply/comments on the complaint. The reply of PP is as under:

- 1. The blasting activities at Khanak Stone Mine is being conducted during day time and under the supervision of Statutory Mining Personnel on daily basis and only after taking requisite permissions from the concerned department.
- 2. Further, blasting pattern and charging of holes is being done as advised in the report submitted by CIMFR, Dhanbad. Blasting vibrations and other parameters like PPV (Peak Particle Velocity) are being regularly monitored by Seismographic meter present at mine site and random reports for Khanak mining site are also attached herewith for your kind perusal which clearly shows that blasting vibrations were also in permissible limit on any particular day.
- 3. Further, regarding difficulties faced by resident of Khanak due to activities at Khanak Stone Mine. In this regard, the dumpers lifting stone from mine site have been provided with a bypass route within the mine site which enables them not to cross the village route with the loaded stone.
- 4. Also, we are working the mine site which is at least 500 meters from the village area and noise and pollution levels are within prescribed limits at all times during the day and night. Inspite of having low AQI we have arranged the sprinkling of water to reduce the air pollution created during blasting in the mining. The sprinkling of water on haul roads is also being done regularly.
- 5. Furthermore, the photos and videos attached by the complainant of the drilling machines have allegedly been taken during trial run/repairing of the water pump of drill machine after breakdown status. Even in the photos and videos, it can be seen that the said machines are already fitted with wet drilling arrangements. Also, we will ensure that drilling operations at Khanak Mine Site will be done with wet drilling arrangements only. Some photos and videos are attached herewith for you kind consideration in this regard.
- 6. Moreover, it is intimated that a complaint of Gram Panchayat, Khanak was also received through State Expert Appraisal Committee (SEAC) on dt. 30-06-2023. The content of the complaint was almost same. The copy of reply is enclosed herewith.

The PP further requested that since there is no basis of the complaint as detailed above is baseless and may be considered to file the same.

After detailed deliberations on the documents produced during the presentation, submissions made by the PP and keeping in view the report of sub-committee constituted by SEIAA and hearing given to the complainant, the committee has <u>decided to recommend the case to SEIAA for granting Environment Clearance as per the conditions conveyed vide Minutes of 271<sup>st</sup> meeting of SEAC and certain conditions observed by the sub-committee may also be considered and added while granting EC to the project.</u>

The aforesaid Proposal was taken up during 163<sup>rd</sup> Meeting of SEIAA held on 02.08.2023.

Upon perusal of relevant record & details pertaining to the case, besides considering the recommendations of the Appraisal Committee & Sub-committee report dated 25.07.2023, the Authority deemed it appropriate to consider the proposal, AFFIRMATIVELY, within the scope & meaning of EIA Notification dated 14.09.2006 emanating from Environment (Protection) Act, 1986 subject to the conditions as under:

- 1. That proposal to the enhancement of the capacity from 10 MTPA to 24 MTPA over an area of 258.30 ha located in village Khanak, Tehsil-Tosham, District-Bhiwani, Haryana by M/s HSIIDC Ltd shall be strictly in accordance with the approved Mining Plan.
- 2. That Project Proponent shall not violate any provision under the Forest Act / Rules & other relevant Acts & Rules, as may be applicable besides the terms & conditions of contract between the Mines & Geology Department, Haryana.
- 3. That upon considering the various representations of the Village bodies, the Authority is inclined to direct Project Proponent to take care of the HEALTH INFRASTRUCTURE (Health Care Centre) in the LOCAL AREA, besides taking steps to conserve & protect the Environment in and around the Mining site by planting 5000 Trees in consultation with the local administration i.e. Deputy Commissioner, Bhiwani & Village body (Zila Parishad / Sarpanch).
- 4. That Project Proponent shall ensure to adhere to the directions issued by MOEF & CC, GOI and HSPCB, from time to time for the conservation & protection of Environment.

Accordingly, the case is disposed of.
