The case was put up for consideration in the 3rd meeting of reconstituted SEAC held on 18.09.2020. SEAC noted that SEIAA had already issued stipulated conditions for Environmental Clearance vide memo No. 1566/EN/T-II-1/079/2017 dated 07.08.2019 for the

expansion project and advised to submit sanctioned building plan for consideration of EC. After carefully considering the submission of the project proponent and detailed deliberation and since there is no major deviation of salient features and environmental issues as compared to stipulated conditions for EC issued earlier, the committee recommended the project for Environmental Clearance with the additional conditions in addition to standard conditions that the project proponent should strictly comply with the guidelines for High Rise Buildings, issued by MoEF, GoI vide No. 21-270/2008-IA.III dated 07.02.2012.
