Minutes of the 31st Meeting of SEIAA held on 29th - 30th December, 2020

The meeting was chaired by Dr S.S. Negi Chairman SEIAA Uttarakhand and was attended by the following:

- (i) Shri Sushanta Kumar Pattnaik, Member Secretary, SEIAA Uttarakhand.
- (ii) Shri Shailendra Singh Bist, Member, SEIAA Uttarakhand.

The meeting started with welcome note by the Chairman. The Member Secretary informed that total 19 proposals (B1 & B2) and 5 other proposals under miscellaneous item are under consideration for grant of EC. Most of these proposals pertain to Soapstone mining and establishment/expansion of hotel projects. The MS enlisted the points for soapstone mining project based on which project proponent should focus during the presentation/deliberation. These points include no of experimental/explorable pits, issues raised during public hearing & addressing those issues in EMP, nearest water source from mining site & impact of mining on its discharge, landslide vulnerability of these area, site of plantation, welfare activity for the labour, arrangement of fuel wood, conservation plan for endangered species, CER etc. Similarly in the housing/hotel project proposals the points earmarked for presentation/deliberation include water reuse/recycle mechanism, rooftop rainwater harvesting, extent of use of solar energy, air conditioning & cooling system adopted, disposal of excavated earth, water requirement sources, parking facilities designed, food waste disposal etc. After detailed discussion and deliberation on each of the proposal as per agenda item, decision taken by the Authority is as under -

- 1) Environmental Clearance for Extraction of Soapstone at Village - Banstoli Rajoli, Tehsil - Kanda, District- Bageshwar by Shri Rajendra Singh Nagarkoti, (Partner). (Area- 4.933 Ha.)

The Project Proponent should revise/resubmit the project cost, revised EMP including CER and MoU with Gram Panchayat/Van Panchayat for plantation. It should submit original ecological sensitivity certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO and it should also submit funding plan for mitigational measures for wildlife conservation of Schedule 1 species in the vicinity of project site. Hence, Authority deferred the project for next meeting.

- 2) Environmental Clearance for Extraction of Soapstone at Khasra no. 358, 359, 360 & Others Village - Totigad, Tehsil - Dug Nakuri, Dist - Bageshwar by Smt Kamla Devi Bafila W/o Shri Pooran Singh Bafila. (Area- 2.817 Ha.)

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it subject to submission of additional documents - Revised project cost, Original Ecological Sensitivity Certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO, submission of MoU with Gram Panchayat/Van Panchayat for plantation and funding plan for mitigational measures for wildlife conservation of Schedule 1 species in the vicinity of project site

- 3) Environmental Clearance for Extraction of Soapstone Khasra no. 1544, 1545, 1546 & Others Village- Bajina, Tehsil, Kanda, Dist.- Bageshwar by Shri Dinesh Singh Parihar, S/o Shri Sheetal Singh Parihar. (Area- 4.941 Ha.)

The PP should submit the revised water balance chart, original ecological sensitivity certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO and funding plan for mitigational measures for wildlife conservation of schedule 1 species in the vicinity of project site. The PP should also submit the plan for protection of the nearby stream, river and tributary. The Wildlife Management Plan in the EIA report should have the consent of concerning DFO. The original cluster certificate should be submitted. Revisit the project cost, submit reclamation plan. Hence, Authority deferred the proposal for next meeting.

- 4) Environmental Clearance for Extraction of Soapstone at Village - Musyoli, Tehsil & District - Bageshwar by M/s H.B Corporation, Managing Partner Shri Ravi Sharma. (Area- 6.988 Ha.)

The PP should submit the revised water balance chart, original ecological sensitivity certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO and funding plan for mitigational measures for wildlife conservation of schedule 1 species in the vicinity of project site. The PP should also submit the plan for protection of the nearby stream, river and tributary. The Wildlife Management Plan in the EIA report should have the consent of concerning DFO. The original cluster certificate should be submitted. Further the MoU with Van Panchayat/Gram Panchayat for plantation should be submitted. Hence, Authority deferred the proposal for next meeting.

- 5) Environmental Clearance for Extraction of Soapstone at Village - Dayali Kuroli, Tehsil - Dugnakuri, Dist - Bageshwar by Shri Govind Singh Bhauriyal (Owner). (Area- 4.982 Ha.)

The PP should submit the revised water balance chart, original ecological sensitivity certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO and funding plan for mitigational measures for wildlife conservation of schedule 1 species in the vicinity of project site. The PP should submit the revised EMP with enhanced cost. The PP should also submit the plan for protection of the nearby stream, river and tributary. The Wildlife Management Plan in the EIA report should have the consent of concerning DFO. The original cluster certificate should be submitted. Hence, Authority deferred the proposal for next meeting.

- 6) Environmental Clearance for Extraction of Soapstone at Village - Nayal Dhapola, Tehsil & Distt - Bageshwar by Shri Manish Nand Kishore Agarwal. (Area- 10.841 Ha.)

The PP should submit the revised water balance chart, original ecological sensitivity certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO and funding plan for mitigational measures for wildlife conservation of schedule 1 species in the vicinity of project site. The PP should also submit the plan for protection of the nearby stream, river and tributary. The Wildlife Management Plan in the EIA report should have the consent of concerning DFO. The original cluster certificate should be submitted. Further the MoU with Van Panchayat/Gram Panchayat for plantation should be submitted. Hence, Authority deferred the proposal for next meeting.

- 7) Environmental Clearance for Expansion of Hotel Project at Khasra No. 269 Ga, 269 Kh, 266 Kh & 270 Village Majra, Tehsil Central Doon, Haridwar Bypass Road, District Dehradun by M/s Hotel Seyfert Sarovar Premiere by Mr. Mohamed Ilyas & Ms. Alamzahan.

The PP should submit the fresh compliance report of the previous EC granted. It should also submit the compliance of CTE and CTO (granted by PCB). Further it should submit the original Eco sensitivity certificate of the concerned DFO. The authority decided to reconsider the proposal after submission of above documents.

- 8) Environmental Clearance for Group Housing Project of Windlass River Valley Project at Village- Harrawala, Kuanwala & Balawala, Haridwar Road (NH- 72), District- Dehradun by M/s Windlass Developers Pvt. Ltd.

The PP should submit the fresh compliance report of the previous EC granted. It should also submit the compliance of CTE and CTO (granted by PCB). As project site falls within radial distance of 10 Km from Rajaji National Park, hence permission of NBWL is mandatory. The authority decided to reconsider the proposal after submission of above documents.

- 9) Environmental Clearance for Extraction of Sand, Bajri, Boulder at Khasra No- 657/3 Village - Banjarewala Grant, Tehsil- Bhagwanpur, District- Haridwar by Shri Sudhir Kumar Windlass S/o Late Shri Vaid Prakash Windlass. (Area- 15.0 Ha.)

The Authority observed that project site falls within 10 km radial distance of Rajaji National Park. Hence prior approval of NBWL is required. The Authority decided to reconsider the proposal after submission of Wildlife clearance from NBWL

- 10) Environmental Clearance for Extraction of Sand, Bajri, Boulder at Village - Banjarewala Grant, Tehsil- Bhagwanpur, District- Haridwar by Shri Sudhir Kumar Windlass S/o Late Shri Vaid Prakash Windlass. (Area- 13.161 Ha.)

The Authority observed that project site falls within 10 km radial distance of Rajaji National Park. Hence prior approval of NBWL is required. The Authority decided to reconsider the proposal after submission of Wildlife clearance from NBWL

- 11) Environmental Clearance for Extraction of Sand, Bajri, Boulder at Village - Banjarewala Grant, Tehsil- Bhagwanpur, District- Haridwar Uttarakhand by Shri Sudhir Kumar Windlass S/o Late Shri Vaid Prakash Windlass. (Area- 9.878 Ha.)

The Authority observed that project site falls within 10 km radial distance of Rajaji National Park. Hence prior approval of NBWL is required. The Authority decided to reconsider the proposal after submission of Wildlife clearance from NBWL

- 12) Environmental Clearance for Extraction of Sand, Bajri, Boulder at Village - Ranadi, Tehsil - Dunda, District - Uttarkashi by Shri Kanakpal Singh Parmar S/o Shri Mahendra Pal Singh Parmar. (Area- 0.400 Ha.)

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it subject to submission of additional documents – original ecological sensitivity certificate from concerned DFO and MoU with the Van Panchayat/Gram Panchayat for plantation

- 13) Environmental Clearance for Extraction of Soapstone at Village - Ghuni, Tehsil- Ghat, District- Chamoli by M/s Jai Badri Kedar Soapstone Mines & Minerals. (Area- 23.733 Ha.)

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it subject to submission of additional documents - Original Ecological Sensitivity Certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO, submission of MoU with Gram Panchayat/Van Panchayat for plantation and funding plan for mitigational measures for wildlife conservation of Schedule 1 species in the vicinity of project site

- 14) Environmental Clearance for Extraction of Soapstone at Village - Talla Sanyuda, Tehsil & District- Bageshwar by M/s Talla Sanyuda Soapstone Mines by Shri Kishor Singh S/o Vijay Singh. (Area- 2.261 Ha.)

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it subject to submission of additional documents - Original Ecological Sensitivity Certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO, submission of MoU with Gram Panchayat/Van Panchayat for plantation and funding plan for mitigational measures for wildlife conservation of Schedule 1 species in the vicinity of project site

- 15) Environmental Clearance for Extraction of Soapstone at Village – Ghuni, Teh- Ghat, District – Chamoli by M/s Mrigawati Minerals. (Area- 43.524 Ha.).

This is a mining proposal with area more than 25 ha. Hence the Authority decided to undertake field visit first. This will be done within a month. It also asked project proponent to submit Original Ecological Sensitivity Certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO, submission of MoU with Gram Panchayat/Van Panchayat for plantation and funding plan for mitigational measures for wildlife conservation of Schedule 1 species in the vicinity of project site. The Authority decided to reconsider the proposal after field visit and submission of above documents

- 16) Environmental Clearance for Extraction of Soapstone at Village – Ghuni, Teh- Ghat, District – Chamoli by M/s Ramnik Mines & Minerals by Shri Shekhar Singh Papola S/o Shri Deewan Singh Papola. (Area- 7.050 Ha.).

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it subject to submission of additional documents - Original Ecological Sensitivity Certificate of 10 km radial distance from National Park/Sanctuary from concerned DFO, submission of MoU with Gram Panchayat/Van Panchayat for plantation and funding plan for mitigational measures for wildlife conservation of Schedule 1 species in the vicinity of project site

- 17) Environmental Clearance for Expansion of Hotel Facility by Constructing Additional Rooms and Installation of Green Insulated DG sets at Khasra No. 345 Gha, Mauza Kohlupani, Pargana Pachwa Doon, Vikasnagar, Dehradun by M/s Epicure Hotels & Resorts.

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it subject to submission of additional documents- Green Belt plan, original eco sensitivity certificate from concerned DFO and MoU with the beneficiary village Panchayat/school/angabadi for funding under CSR. The PP should ensure that 25 % of power consumption should be use of solar power and common facilities/toilets for support staff of visitors should be adequately provisioned in the lay out plan

- 18) Environmental Clearance for Manufacture of Automobiles Accessories (like Cushion pillow memory, Bone Neck rest, Neck Rest, Centre Console Lumber support , FRP ski Rack, Spoiler ,FRP body Kit etc) at Plot No 22 Shivganga Industrial Estate Lakeshwari, Bhagwanpur Rookie, Haridwar by M/s Kumar Auto Sales Unit-II, Shri Arun Singh

The authority noted that the proposal is incomplete as even EMP has not been submitted. Hence complete detailed proposal needs to be submitted including, Green Belt plan, Fire NoC, TSDF provisioned MoU for handling hazardous waste, registration certificate from industry department, plan for meeting 1/5th power requirement from solar energy, onsite emergency plan, and enlist item wise production capacity. The Authority decided to reconsider the proposal after submission of above documents.

- 19) Environmental Clearance for Proposed Construction of Hotel Facility and Installation of Green Insulated DG set at 851 Kh, Village - Dhalwala, Tehsil - Narendra Nagar, District - Tehri Garhwal, Dehradun by M/s Anantsheel Enterprises LLP.

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it subject to submission of additional documents- Green Belt plan, original eco sensitivity certificate from concerned DFO and MoU with the beneficiary village Panchayat/school/angabadi for funding under CSR. The PP should ensure that 25 % of power consumption should be use of solar power and common facilities/toilets for support staff of visitors should be adequately provisioned in the lay out plan.

- 2) Environmental Clearance for Extraction of Soapstone by Smt Nirmala Dafoti, W/o Late Sh. Kunwar Singh Dafoti R/o Hospital Line, Naiyar Hospital, Bankhola Road, District- Bageshwar, at Village – Pokhri & Bintoli, Tehsil & District- Bageshwar. (Area- 6.683 Ha.).

The project was discussed in the meeting of SEIAA dated 2nd – 3rd November, 2020 in which Authority had sought additional documents. It was observed that the PP has

submitted the desired document. Hence Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it

- 3) Environmental Clearance for Extraction of Soapstone by Shri Deep Chandra Verma S/o Shri Jagdish Lal Verma R/o- Village Sunargaon, Kanda, Tehsil- Kanda, Dist.- Bageshwar., at Vill – Nagkanyal - Kandekanyal, Tehsil - Kanda, District - Bageshwar. (Area- 8.4988 Ha.).

The project was discussed in the meeting of SEIAA dated 2nd – 3rd November, 2020 in which Authority had sought additional documents. It was observed that the PP has submitted the desired document. Hence Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it

- 4) Environmental Clearance for Extraction of Soapstone by Shri Bhuvan Chand Joshi S/o Shri Chandramani Joshi (R/o Village Haripur Sukh) Mool Chand, Garden, Rampur Road, Haldwani, Dist.-Nainital., at Vill- Bajina, Teh Kanda Dist- Bageshwar. (Area- 8.843 Ha.).

The project was discussed in the meeting of SEIAA dated 2nd – 3rd November, 2020 in which Authority had sought additional documents. It was observed that the PP has submitted the desired document. Hence Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it

- 5) Environment Clearance for the proposed hotel project Niranjapur GMS Road, Dehradun by M/s Ghati Developers and Builders.

The area of construction site falls within radial distance of 10 Km from National Park/Sanctuary and hence require permission/wildlife clearance of NBWL. The Authority decided to reconsider the proposal upon submission of above certificate

- 6) Environmental Clearance for manufacturing of custom organic molecules for research & development at plot no – 13, sector 3A, SIDCUL IIE Haridwar

The Authority observed that above project was granted EC by the MS vide letter dated 28th Sep 2020. The PP has sought amendment in the EC regarding production capacity i.e. increasing production capacity from 15 Kg/Year to 300 Kg /Year. Based on the information contained in the EMP and PFR, the Authority agreed for revision of EC as requested.



In addition to above observations and decision taken, the Authority decided to follow the undermentioned procedure in all cases henceforth for consideration of grant of Environmental Clearance –

- The project proponent shall submit original ecological certificate issued by the concerned DFO in forest department
- The project proponent must submit copy of original cluster certificate issued by an officer not less than rank of SDM
- The signatory of the empanelled EIA consultant representing the project proponent shall be the Director of the consulting firm bearing DIN
- There will be regular field visits for checking the veracity of compliance reports being submitted from time to time

The authority was of the view that a large number of Soapstone mining activities have been taken up in Bageshwar district. Hence the Authority decided to send advisory to the mining department, Government of Uttarakhand to undertake Cumulative EIA study in Bageshwar district in Soapstone Mining.
