The Authority after detailed discussion and deliberation decided the following:

 Serial No. 1: The proposal was closed and delisted in the 5.108th meeting of the Authority held on 10.1.2024 on the recommendations of SEAC. Now, PP vide his letter dated 31.1.2024, has requested to relist the proposal and submitted Certified Compliance

Report. Hence, the Authority decided to relist and **refer back** this proposal to SEAC for further examination.

- 2. Serial No. 2: The proposal was deferred in the 5.102nd meeting of the Authority for submission of a clarification on Khasra No. and Complete Mining Plan. Now, PP has submitted the clarification and documents in accordance with the queries of the Authority. Hence, the Authority decided to grant approval of EIA/ EMP and EC to this proposal.
- 3. Serial No. 3: The proposal was deferred in the 5.96th meeting of the Authority held on 4.10.2023 for LoI of inclusion. Now, PP has submitted the LoI for inclusion as asked. Hence, the Authority accepted the previous recommendations of SEAC and decided to grant amendment in ToR to this proposal. PP may be asked to also ensure that permission for PHED connection from the government is sought with all due formalities and financial liabilities entailed, complied with. An undertaking to this effect may be submitted which would be incorporated as a condition in the proposed EC sought. Hence, the Authority decided to defer this proposal. PP may also submit an affidavit stating that no spillover of vehicles will be done, within 45 days".

Now, PP has submitted an undertaking assuring that permission for PHED connection from the government will be taken with all due formalities and financial liabilities entailed. PP has also submitted an affidavit stating that no spillover of building vehicles will be done outside the property. Hence, the Authority decided to **grant EC** to this proposal.

- Serial No. 11, 12, 13, 29: The Authority accepted the recommendations of SEAC and decided to close and delist these proposals.
- 10. Serial No. 17, 18, 24, 25, 26, 28, 30, 31, 32, 33, 44, 50: The Authority decided to close and delist these proposals in light of the O.M. No. IA-22/01/2021-IA-III- Part (1) dated 15.01.2024 issued by MoEF&CC regarding following the SOP for dealing mining proposals under Ministry's OM dated 28.04.2023 on PARIVESH portal.
- Serial No. 34: The Authority accepted the recommendations of SEAC and decided to grant amendment in EC to this proposal.
- 12. Serial No. 43: In this proposal, the PP/ Consultant has not submitted the affidavit regarding implementation of cluster EMP. Hence, the Authority decided to defer this proposal for submission of an affidavit for implementation of cluster EMP, within 45 days.
- 13. Serial No. 53, 54, 55: The Authority decided to grant Transfer EC to these proposals.
- 14.
