The meeting of 574th State Level Environment Impact Assessment Authority, UP (SEIAA) was held on-line on 16.03.2022 at the Directorate of Environment. The following were present in the meeting:-

1. NGT Order dated 11.03.2022 in appeal no. 23/2021 Pramod Vs State of UP and ors.

SEIAA gone through the NGT Order dated 11.03.2022 in appeal no. 23/2021 regarding Sand/Bajri/Boulder mining from Yamuna River bed at Gata No.-1/1/1, Laat No.-03, Village-Nuniyari Aehatmal, Tehsil-Behat, Saharanpur., Shri Dhanpal Singh & Shri Rajeev Bhatia, M/s Shanti Enterprises., Area-24.29 Ha. File No. 6266/5850, which states as follows –

"Accordingly the impugned EC will stand quashed without prejudice to fresh EC being granted after following due process of law. The mining already conducted is illegal and consequences of such illegality may be appropriately determined and enforced by the SEIAA, UP and State PCB, after hearing the PP, within one month from today."

SEIAA opined and decided as follows –

- Said EC be cancelled
- A two member committee headed by Chairman, SEAC-2 (as SEAC-2 has evaluated and recommended this project for grant of EC) and one member from UPSPCB nominated by MS, UPSPCB will submit their report on directions given by Honourable NGT "The mining already conducted is illegal and consequences of

such illegality may be appropriately determined and enforced by the SEIAA, UP and State PCB, after hearing the PP, within one month from today".

- c) Copy of Honourable NGT order be sent to SEAC-1 & SEAC-2 with the direction that this order be discussed in their SEACs and brought to the notice of all the members and in future while examining the proposals, directions given by Honourable NGT should be kept in mind.

SEIAA opined to send the above letter to PCB for necessary action, issue show cause notice to the project proponent and seek status of compliance from IRO, MoEFCC.

1. The project proponent shall ensure that the distillery shall be on ZLD using decanter and MEE. As proposed treated waste water should be completely recycled /reused and ZLD should be achieved. Under no circumstances treated waste water and effluent shall not be discharged to any drain/sewer line/ inland surface water/Nala etc.

6. Clinker Grinding Unit with Cement production capacity of 12,00,000 TPA (3650 TPD) at Plot No:AL-5A, Sector-23, GIDA, Tehsil: Sahjanwa, Gorakhpur., Shri Navneet Jindal, M/s Gallantt Industry Private Limited. File No. 6249/Proposal No. SIA/UP/IND/ 62209/2021

SEIAA noted that the above project was taken in its 550th meeting in which SEIAA opined that project proponent shall submit- Details of MoU regarding fly ash, Segregation of quantity of fly ash from gallants is pat and thermal power plant Air pollution sources and their mitigation details regarding raw material handling and transfer points. The project proponent has submitted his reply vide letter dated 14.03.2022. After reviewing the reply SEIAA agreed with the recommendation of SEAC dated 21.12.2021 to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC adding specific condition as follows:-

1. The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 before the start of work.
 2. If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
 3. Directions/suggestions given during public hearing and commitment made by the project proponent should be strictly complied.
- 7. Transfer of EC of Sand/Morrum mining at Gata no. 15Mi Vill: Nibarri Kachhar Tehsil Sikandara Distt: Kanpur Dehat Lease area-16.58 ha. File No. 4511/4161/Proposal No. SIA/UP/MIN /29420/2018**
