The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal subject to following conditions:
 - a. All the measures prescribed by MoEF&CC Govt of India, for mitigating pollution in the non-attainment city of Jodhpur must be followed.
 - b. An Air Quality Monitoring fixed station shall be set up at the Jodhpur Airport linked with CPCB server to monitor air quality.
- Serial No. 2: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal subject to following conditions:
 - a. EC will be subject to the outcome of court cases pending before Hon'ble High Court of Rajasthan for land acquisition against the project.
 - b. RIICO shall ensure compliance of the conditions stipulated by WRD as per their consent letter accorded dated 13th March 2023 in respect of the the Bandi river.
- 3. Serial No. 3, 4,5,6 & 7: The Authority accepted the recommendations of SEAC and decided to grant Amendment in EC to these proposals subject to the condition that Action Taken Report on Certified Compliance Report be submitted to IRO MoEF&CC and Rajasthan State Pollution Control Board within 30 days.
- 4. Serial No. 8: This proposal was deferred in 5.69 meeting of SEIAA for submission of revised proposal as there was inconsistency in figures and data. PP has now submitted

the revised data which is different from the proposal applied earlier. Hence the Authority decided to **refer back** this proposal to SEAC for re-examination.

- Serial No. 9, 14, 15, 16, 19, 22, 23, 24, 25, 27, 28, 29, 30, 31, 32, 33, 34, 38: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals.
- Serial No. 10: This proposal was deferred in 5.70 meeting of SEIAA as parking provided in this proposal is inadequate with respect to dwelling units. PP submitted revised parking provisions.

The Authority after examining the revised parking proposal was of the view that revised parking proposed is not adequate still. PP is advised to resubmit with increased parking keeping in view the nature of residential accommodation proposed. Hence the Authority decided to defer this proposal for additional information to be submitted within 45 days.

7. Serial No. 11: This proposal was deferred in 5.70 meeting of SEIAA as the requisite details of the project were found unsatisfactory. The Authority had directed the PP to submit comprehensive plan with provisions of reserved parking for Offices, Shops and Flats etc. and all staff engaged & visitors on separate floors of the basement in such a manner that there is no outflow of vehicles outside the premises of the complex.

The PP was heard. The parking proposed is grossly inadequate to the activities proposed in the project wherein parking proposed was 671 ECU against the estimated population given of 11580. Even at the optimal capacity of the parking proposed i.e. 4 persons in one car, the requirement is being met for only 2684 persons against 11580.

It is therefore evident that the project has to be completely redesigned by curtailing several activities proposed in the project, inclusive of visitors. Opportunity had already been given to PP. Therefore, the Authority decided to **Close & Delist** the project. PP may reapply as a revised/fresh project.

8. Serial No. 12 & 13: In both these proposals the project proponent submitted detailed representation to the show cause notice. PP has explained the letter dated 10/3/2023 issued by AME Salumber has not been received by them and also was not in their knowledge on the date of the meeting 17th March 2023, wherein they were heard. It came to their knowledge only when the show cause notice was issued by Authority after which they took up the matter with Department of Mines & Geology and protested against the unjustified cancellation letter issued by AME Salumber. Since the cancellation letter issued by AME Salumber has issued fresh Aravali Certificate effective from the date of cancellation letter issued.

The contention of the PP is acceptable keeping in view the aravali certificate issued dated 17th April 2023. In view of these the show cause notice issued to PP on 18th April 2023 is dropped. PP may proceed further with the letter dated 21st March 2023 vide which the ToR for these proposals were issued.

In the instant case the Authority takes serious note of the conduct of AME Salumber Sh. O P Meena. There seems no apparent reason or justification that out of the blue, when the proposal of PP was under consideration of the Authority, AME cancels the earlier certificates issued without assigning any reason and also asking SEIAA to not to proceed on those previous certificates issued for the purpose of grant of EC. Thereafter AME issues a fresh certificate which is the same as certificates issued earlier. Cancellation of the certificates is a serious matter. The Authority decided to bring this matter in to the knowledge of ACS Mines, Govt of Rajasthan for conduct of enquiry and taking appropriate action.

- Serial No. 17, 20, 39 & 43: The Authority accepted the recommendations of SEAC and decided to Close & Delist these proposals.
- 10. Serial No. 18 & 21: In these proposals DSR submitted is not of Masonry Stone. Hence the Authority decided these proposals to defer for additional information to be submitted within 45 days.
- 11. Serial No. 26: In this proposal General Condition No. 3, 8 and 16 are not complied with. Hence the Authority decided to defer this proposal for Action Taken Report (ATR) to be submitted within 45 days.
- 12. Serial No. 35: This proposal is within a distance of 10 km from the Sajjangarh Wildlife Sanctuary but no Conservation Plan has been submitted. Hence the Authority decided to defer this proposal for additional information to be submitted within 45 days.
- 13. Serial No. 36 & 37: In these proposals SEAC has sent a letter regarding some new facts. Hence the Authority decided to defer these proposals for further examination.
- 14. Serial No. 40, 41 & 42: The Authority accepted the recommendation of SEAC and decided to grant ToR to these proposals.
- 15. Serial No. 44 & 45: In these proposals past production certificate upto 2023 has not been submitted by the PP. Hence the Authority decided to defer these proposals for additional information to be submitted within 45 days.
- 16. Serial No. 46: In this proposal the production has increased from the base year. Hence the Authority decided to grant transfer EC to this proposal with a direction to apply for ToR under violation within 30 days of the grant of the transfer EC.

- 17. Serial No. 47: The Authority decided to grant Transfer EC to this proposal with a direction to get it reappraised as per MOEF&CC OM dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
- 18. Proposal No. 409856, 409664 & 409710: It was decided in the 5.73 meeting of the Authority held on 28th April 2023 to accord EC to these proposals which were outside the ESZ of Jamwa Ramgarh Wildlife Sanctuary.

On the very same day Hon'ble Supreme Court of India in IA no. 3949 of 2016 in Writ Petition (C) No. 202 of 1995 clarified that mining shall not be permitted within a disctance of 1 km from the boundary of National Park/Wildlife Sanctuary (WLS), even if the ESZ is less than 1 km. In case of Jamwa Ramgarh WLS the ESZ is 500m and the distance of proposals cited above from the wildlife sanctuary is 698 m, 600m, and 605m respectively. Accordingly all three mines are located at a distance of less than 1 km from the boundary of Jamwa Ramgarh WLS.

Since this fact has come to the knowledge of the Authority, and it is a bounden duty of the Authority to implement the directions of Hon'ble Supreme Court of India, the Authority hereby suo moto decides to review its decision taken in respect of these three proposals. The EC has not been issued accordingly the Authority decides to Reject these proposals. In addition a letter be sent to Director Mines & Geology, Rajasthan to cancel the mining lease/LoI.
