Further, the Hon'ble NGT, Delhi vide order dt.11.12.2018 in Executive Application No.55/2018 (in OA No.520/2016) suspended the MoEF&CC notification S.O.No.141 (E) dt. 15.01.2016. In compliance to the Hon'ble NGT orders, the proposed mining in mine lease area of 14.331 Ha. falls under Category-B1, thus requires Public consultation after preparation of EIA report duly obtaining Terms of References from SEIAA. Hence, the application for EC is rejected.
