#### Agenda - A Replies

Expansion of Production Capacity From 28,800 TPA to 1,44,000 TPA Billets And From 27,000 MTPA To 1,98,000 MTPA of Rolled Products by Replacement Of Existing 2x12 Mt Induction Furnaces with 2x20 Mt Induction Furnace And Modification Of Rolling Mill in Existing Plant Premises at Industrial Estate, Village-Kandela, Tehsil- Kairana, Shamli, U.P. Shri Abhinav Bansal, M/s Shamli Steels (P) Ltd. File No. 4616/Proposal No. SIA/UP/IND/30511/2018

SEIAA noted that the above project was taken in its 630<sup>th</sup> meeting dated 13.07.2022 in which SEIAA opined that the project proponent shall clearly mention the year wise production of various products and submit compliance report of CTO/CTE certified by UPPCB.

Project proponent has submitted his reply vide letter dated 30.07.2022 stating that as per OM dated 08.06.2022 of MoEFCC "self-certified compliance report for the latest CTO shall be sufficient if the project proponent applies for expansion within a period of one year from the grant/renewal of CTO. If such application is submitted beyond the period of one year from the date of grant/renewal of CTO, CCR shall be required for the latest CTO." SEIAA noted that in CTO dated 29.12.2021 production capacity of MS Billet is mentioned as 2400 MT per month, MS Angle, Channel, TMT Bars as 2250 MT per month. Hence in light of discussion held in SEIAA meeting no. 597 dated 05.05.2022 SEIAA agreed with the recommendation of SEAC-1 dated 21.06.2022 to grant EC to the above project along with all the general and specific conditions as suggested by SEAC-1. In addition to the conditions imposed by SEAC-1, SEIAA added following additional specific conditions:-

- Directions/suggestions given during public hearing and commitment made by the project proponent should be strictly complied.
- The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 before the start of work.
- In compliance to Hon'ble Supreme Court order dated 13/01/2020 in IA no. 158128/2019 and 158129/2019 in Writ petition no. 13029/1985 (MC Mehta Vs GOI and others) antismog guns shall be installed to reduce dust during excavation.
