- 13. Serial No. 41: In this proposal, PP has not submitted the application for abstraction of ground water for increased capacity of water demand. Hence, the Authority decided to grant an amendment in EC subject to submission of application for fresh water requirement.
- 14. Serial No. 44: The Authority has accepted the recommendations of SEAC and decided to grant ToR to this proposal.
- 15. Serial No. 47: In this proposal, as per DCF RVTR certificate dated 23.10.2023 the proposed lease is located at a distance of 300 m from the buffer area of Ramgarh Vishdhari Tiger Reserve. Hence, the Authority decided to refer back this proposal to re-examine in light of the Hon'ble Supreme Court order dated 26.03.2023 in Civil Appeal No. 255-257 and resubmit its recommendations.
- 16. Serial No. 57: This proposal pertains to re-appraisal of EC issued by the erstwhile DEIAAs. The Authority accepted the recommendations of EC and decided to grant EC to this proposal with the additional condition imposed by SEAC that the PP shall abide by the final outcome of Hon'ble Supreme Court in WP (C) no. 1394/2023 and/ or any further OM issued by the MoEF & CC and to comply accordingly.
- 17. Serial No. 68: In this proposal, the lease was transferred to PP on 19.12.2019. The PP has not applied for transfer of EC in compliance with the OM dated 03.11.2023 issued by MoEF&CC. Hence, the Authority decided to defer this proposal with the direction that the RSPCB shall initiate action against the Project Proponent for non-compliance of O.M. dated 03.11.2023 issued by MoEF&CC. Also, the PP is directed to apply for Transfer of EC, within 30 days.
