

The Authority after detailed discussion and deliberation decided the following:

 Serial No. 1: Proposal was deferred in the 5.100th meeting of SEIAA as "PP may be afforded an opportunity of personal hearing to explain why this proposal may not be rejected, as the nearest forest is at 40 m distance from the lease area as per the certificate issued by DCF, Banswara vide letter dated 06.09.2021 and whereas the State Government order dated 14.06.2023 has specified minimum distance for mining as 50 m or more from the forest boundary"

PP was heard, the mine is at a distance of less than 50 m from the forest boundary is an admitted fact. Therefore, in view of the State Government order dated 14.06.2023, the Authority decided to reject this proposal.

- 2. Serial No. 2: Proposal was deferred in the 5.98th meeting of SEIAA for submission of the following:
 - · Revised CSR budget wherein the budget for electricity assurance needs to be incorporated.
 - Secondly, PP needs to indicate and provide a budget for community welfare without restricting it to labor welfare measures only.
 - PP shall also submit a copy of the approved MP.

Now, PP has submitted the requisite details/information. Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 3. Serial No. 3: Proposal was deferred in 5.99th meeting of SEIAA for the submission of clarification on the following issues:
 - . PP/ Consultant of this proposal, mentions construction of single block with B+S+6+11 floors at S. No. 18 in Form-1 whereas in the same form at S. No. 5, it mentions construction of 4 blocks.





- Permission has been provided to construct B+S+9 floors as per the approved building plan letter dated 16.2.2022 whereas the proposal is for construction of B+S+G+11 floors.
- As per the certificate of DCF Wildlife Mukundara National Park dated 25.3.22, Project is located within the ESZ of Chambal Ghariyal WLS at a distance of 4.5 km from Wildlife Sanctuary. It further mentions necessary permission is required to be obtained with respect to ESZ.

Now, PP has submitted the clarification for the above queries and also applied for NBWL vide application dated 22/06/2023. Considering the same, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant TOR under violation** to this proposal.

- 4. Serial No. 4: Proposal was deferred in the 5.95 meeting for "submission of Affidavit regarding violation/no violation as per the format". Now, PP and the consultant have submitted the correct affidavit. Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 5. Serial No. 5: Proposal was closed and delisted in the 5.93rd meeting of SEIAA on the recommendations of SEAC for non-submission of valid LOI within stipulated time period. Now, PP has submitted lease registration document dated 11.07.2023 and requested to relist the proposal for further process. Considering the same, the Authority decided to relist and refer back the proposal to SEAC for further examination.
- 6. Serial No. 6: Proposal was closed and delisted in the 5.74th meeting of SEIAA as the Authority found proposed parking grossly inadequate. PP submitted the request letter to relist the proposal vide letters dated 12.09.2023, 09.10.2023, 12.10.2023 and 30.10.2023. Considering the request letters of the PP, the Authority heard the PP. However, no written representation was submitted in respect of the earlier observation of the Authority. Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of detailed representation in writing to relist and reconsider the proposal, within 45 days.
- Serial No. 7, 14, 15, 16, 39: The Authority accepted the recommendations of SEAC and decided to <u>close and delist</u> these proposals.
- Serial No. 8, 35, 36: The Authority accepted the recommendations and additional conditions
 of SEAC and decided to grant TOR under violation to these proposals.
- Serial No. 9, 10, 12, 17, 18, 30, 40: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- 10. Serial No. 11, 20, 22, 23: The Authority accepted the recommendations & additional conditions of SEAC and decided to <u>approve EIA/EMP and grant EC</u> to these proposals

with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 11. Serial No. 13: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant Amendment in EC to this proposal.
- 12. Serial No. 19: In this proposal, Khasra number in LOI is mentioned as 519/651 whereas in Aravalli certificate, Cluster certificate, Affidavit and Form- I, it is mentioned as 519/656. Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of clarification and submission of revised certificates with correct khasra number, within 45 days.
- 13. Serial No. 21: In this proposal, Block B of the mining lease is at a distance of 10 m from the nearest forest boundary as per topomap and 8 m as per KML submitted by PP and whereas the State Government order dated 14.06.2023 has specified minimum distance for mining as 50 m or more from the forest boundary. Block A and C are at a distance of more than 50 m from the forest boundary. Hence, the Authority decided to defer this proposal and was of the view that PP may be afforded an opportunity of personal hearing to explain why the permission shall not be denied for mining activity in Block B, as the nearest forest is at less than 50 m from the forest boundary.
- 14. Serial No. 24: In this proposal, submitted ATR is not duly signed by PP. Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of ATR duly authenticated by PP, within 45 days.
- 15. Serial No. 25: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal along with the condition to comply with the conditions laid down in the certificate issued by Water Resource Department.
- 16. Serial No. 26: In this proposal, following discrepancies/issues are observed:
 - NABET Certificate was valid till 15.08.2023
 - · CCR is more than one year old
 - Conservation plan not submitted as Jaisamand WLS falls in 10 km.

Hence, the Authority decided <u>defer</u> this proposal for additional information i.e., submission of valid NABET certificate, Latest CCR along with ATR for non-compliance, if any and conservation plan, within 45 days.

17. Serial No. 27: In this proposal, turnover figure is not duly authenticated by CA for the year 2018-2019 and submitted CCR is more than one year old. Hence. The Authority decided to <u>defer</u> this proposal for additional information i.e., submission of CA certificate mentioning turnover for violation period and latest CCR along with ATR for non-compliance, if any, within 45 days.

- 18. Serial No. 28: The Authority accepted the recommendations and additional conditions of SEAC and decided to <u>grant Amendment in EC</u> to this proposal with the Specific condition that <u>The Mining activities shall not be carried out in Khasra No 137 of applied lease</u> as per DCF, Tonk certificate dated 28.09.2020.
- 19. Serial No. 29: The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects and subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 1,37,654/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 21,22,800/- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.
- 20. Serial No. 31: Proposal was referred back to SEAC in the 5.84th meeting of SEIAA and now, the SEAC has again recommended to SEIAA to close and delist the proposal on the basis of the fact that "Executive Engineer, Water Resources Department, Rajsamand has issued certificate on 14.02.2023 despite the Department is not having record of HFL for return period of 25 years and no record for submergence area of proposed mining lease considering the HFL for the return period of 25 years. Besides, the fact that there exists a natural nallah at 16 m from lease boundary was concealed in certificate issued on 14.02.2023."

Keeping in view the SEAC recommendations as well as the certificate issued by WRD department vide letter dated 14.02.2023, the Authority decided to <u>defer</u> this proposal and directs the PP that the observations of the SEAC may be conveyed to Water Resource Department and the PP may submit a final NOC from the Water Resource Department in this regard.

- 21. Serial No. 32: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 50045/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 1,50,000/- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.
- 22. Serial No. 33: In this proposal, Production certificate for FY 2005-06 is submitted without dispatch date and in submitted CCR, Specific condition 1 (26), 3 (2 & 3), 5 (3), 10 (3) and General condition no. 3 and 16 are mentioned as not complied. Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of certified

- production figures and ATR for non-compliance of conditions of EC mentioned in CCR, within 45 days.
- 23. Serial No. 34: In this proposal, in submitted CCR, Specific condition 1 (26), 3 (2 & 3), 5 (3), 10 (3) and General condition no. 3 and 16 are mentioned as not complied. Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of ATR for non-compliance of conditions of EC mentioned in CCR, within 45 days.
- 24. Serial No. 37: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR under violation without Public Hearing to this proposal.
- 25. Serial No. 38: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal subject to the condition of submission of Affidavit regarding no spill over of vehicles on account of inadequate parking place within the complex, as specified in the EC.
- 26. Serial No. 41, 42: The Authority decided to grant Transfer EC with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 27. Serial No. 43, 44, 45, 46: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
