The Proposal of <b>M/s. Shreas Industries Limited., Unit II.,</b> is for Environmental Clearance for expansion of production quantities of the
existing permitted bulk drug - 535.7 TPM to bulk drug & Intermediates – 3905 TPM and Co-generation Power Plant - 1 x 11.5 MW, 1 x 7.5 MW.& 1 x 3 MW.
The representative of the project proponent and their Consultant M/s.Team Labs and Consultants, have attended the online meeting and stated that M/s. Shreas Industries Ltd. Unit II (formerly known as Sanhoc labs Limited Unit I) obtained consent for establishment (CFE) for manufacturing Ibuprofen from APPCB vide Letter No. 472/APPCB/CFE/RO-SKLM/HO/2019 dated 05.07.2019 at Plot No. 22, 23, 24, 25 of area 8.8 acres in the Industrial (Pharma) complex which obtained environmental clearance in the name of M/s. Vijayasri Organics Limited with a total 34 plots.
It is proposed to enhance the Ibuprofen production capacity and inclusion of new active pharma ingredients molecules, co-generation power plants in the <b>remaining plots</b> in the Industrial (Pharma) complex spread over an area of 91.2 acres (total site area after expansion is 100 acres) at Sy. No. 13, 14, 19, 23, 24, 97, 98, 99, 100, 104, 131, 133, Chittivalasa village, Ranasthalam mandal, Srikakulam district, Andhra Pradesh. Construction of Ibuprofen project is <b>yet to be initiated event though CFE is obtained</b>
MoEF&CC, GoI, New Delhi issued notification vide S.O. No. 1223(E), dated 27.03.2020 and MoEF&CC Office Memorandum dated 13.04.2020, wherein " <i>All proposals for projects or activities in respect of Active Pharmaceutical Ingredients (API), received up to the 30th September 2020, shall be appraised , as Category 'B2' projects provided that any subsequent amendment or expansion or change in product mix, after the 30th September 2020, shall be considered as per the provisions in force at that time.</i> " Further it is extended up to 30th March, 2021 vide S.O. No. 3636(E), dated 15.10.2020.
The proposed project falls under Item 5(f) of the schedule of the EIA Notification 2006- Synthetic organic chemicals industry (dyes & dye intermediates & bulk drug and intermediates).
The Committee noted that the existing unit is bulk drug & intermediates manufacturing unit. Now, the PP has proposed the Bulk Drug Intermediates manufacturing unit with expansion of production capacity. The project proponent has submitted the EMP, PFR, Risk Assessment Report and certified compliance report of CFE order of existing Industry.
