The Authority after detailed discussion and deliberation decided the following:


1. **Serial No. 1:** The proposal was deferred in 5.101st meeting of the Authority to submit ATR duly signed by PP. Now, PP has submitted the required document. Hence, the Authority decided to **grant EC** to this proposal.



2. **Serial No. 2:** The proposal was deferred in 5.100th meeting of the Authority for submission of latest cluster certificate. Now, PP has submitted the required document. Hence, the Authority decided to **grant EC** to this proposal.
3. **Serial No. 3:** The proposal was deferred in 5.100th meeting of the Authority as the LoI of the proposal had expired. Now, PP has submitted the lease agreement dated 19.6.23. Hence, the Authority decided to **grant EC** to this proposal.
4. **Serial No. 4:** The proposal was deferred in 5.100th meeting of the Authority for submission of production certificate for 2021-2022 and 2022-2023. Now, PP has submitted the production certificate for the years asked. Hence, the Authority decided to **grant EC** to this proposal.
5. **Serial No. 5:** The proposal was deferred in 5.98th meeting of the Authority for submission of valid and approved mining plan. Now, PP has submitted an approved mining plan dated 17.11.23. Hence, the Authority decided to **approve EIA/ EMP and grant EC** to this proposal based on the recommendations of SEAC. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
6. **Serial No. 6, 8, 11, 14, 15, 16, 17, 19, 20, 23, 24, 29, 30, 31, 32, 33, 34:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to these proposals.
7. **Serial No. 7, 9, 10, 13, 25:** The Authority decided to accept the recommendations and additional conditions of SEAC and decided to **approve EIA/EMP and grant EC** to these proposals. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
8. **Serial No. 12:** The Authority decided to **close & delist** these proposals on the recommendations of SEAC.
9. **Serial No. 18, 21, 26:** The Authority accepted the recommendations of SEAC and decided to **reappraise** the earlier EC issued by DEIAA in these proposals.
10. **Serial No. 22:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal **subject to deposition of penalty** as per MoEF&CC SOP dated 07.07.2021 of **Rs. 1,35,662/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 4,46,000/-** towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

11. **Serial No. 27:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal. Also, in view of the scale of the project and the projected population in the proposal, the PP shall also apply for PHED water connection under the new policy for High Rise Buildings in order to reduce the dependency on ground water.
12. **Serial No. 28:** As per the approved Building Plan of this proposal, permission has been granted for construction of 2B+2S+G+6 floors and 42 flats whereas PP has proposed construction of 2B+2S+G+14 floors with 90 flats. Also, as per the approved building plan, 10 % of total parking has to be reserved for EV charging facility but the same has not been incorporated in the proposal. Hence, the Authority decided to **defer** this proposal for presentation by PP to explain the proposal in detail. PP is also directed to submit a clarification on the same, within 45 days.
13. **Serial No. 35, 36:** The Authority decided to **grant Transfer EC** to these proposals.
14. **Serial No. 37, 38:** The Authority decided to **grant Transfer EC** to these proposals **with the condition that the PPs concerned shall apply for TOR under violation within 45 days**. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
15. **Serial No. 39 to 48:** The Authority decided to **grant Transfer EC** to these proposals **with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.**
