The Authority after detailed discussion and deliberation decided the following:

Serial No. 1: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal. However, the production has been increased by PP in excess of the limit granted in CTO by RSPCB which should be specifically mentioned in the EC for necessary action by RSPCB.

Serial No. 2: The Authority considers that proposed parking is inadequate wherein, the car units proposed for parking are less than 1 per flat. The project has flats up to 4 BHK wherein the

- present-day expected parking required is about 2 per such flat. In addition, no plan was found in file for excess treated water (58 KLD). Hence, the Authority decided to **defer** this proposal and call PP/ Consultant for presentation on the same.
- Serial No. 3, 55: In this proposal, construction activity has already been carried out and PP/ Consultant have also admitted the same in their affidavits. Hence, the Authority accepted the recommendations of SEAC and decided to grant ToR under violation.
- Serial No. 4: The Authority accepted the recommendation of SEAC & decided to grant ToR without Public Hearing to this proposal.
- Serial No. 5: The SEAC has recommended the Authority for grant of ToR with Public Hearing for this proposal. Hence, the Authority decided to grant ToR to this proposal as per SEAC's recommendations and with directions to obtain CGWA NOC before the final presentation for EC.
- Serial No. 6, 7, 9, 38, 43, 48, 60: The Authority accepted the recommendation of SEAC and decided to close & delist these proposals.
- Serial No. 8: In this proposal, the distance of forest from the lease area is 51 m, as per the certificate issued by DCF Bundi. However, there is a conflict with the forest boundary in the KML provided by PP and some mining in forest area is also visible adjacent to the lease area. The Authority took note of this seriously and decided to defer the proposal and call the PP for personal hearing to explain the same.
- Serial No. 10, 44, 45, 46, 49, 50, 54: The Authority accepted the recommendation of SEAC & decided to Grant EC to these proposals.
- Serial No. 11, 56, 57, 59: The Authority accepted the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to this proposal with the condition that issues raised in public hearing are to be implemented by all the lease holders of the cluster and they shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- Serial No. 12: The Authority accepted the recommendations of SEAC and decided to grant ToR for 2450 MT/month production capacity without Public Hearing to this proposal with the direction to submit clarifications/ documents/ information asked by the SEAC at the time of proposal for EC.

- Serial No. 15, 16: The Authority accepted the recommendations of SEAC and decided to grant ToR to these proposals with the direction to submit DCF Certificate regarding forest distance at the time of proposal for EC.
- Serial No. 13, 14, 17, 20, 21, 22, 23, 24, 25, 39, 40, 41, 58: The Authority accepted the recommendation of SEAC & decided to Grant ToR to these proposals.
- Serial No. 18: The SEAC has observed that PP has done the production prior to obtaining EC by DEIAA in 2017 and an affidavit has also been submitted by PP regarding violation. Hence, the Authority accepted the recommendations of SEAC and decided to grant ToR as a case of violation with the direction to submit Certified Compliance Report at the time of proposal for production expansion EC.
- Serial No. 19: The Authority accepted the recommendations of SEAC and decided to grant ToR to this proposal with the direction to submit WRD Certificate at the time of proposal for EC.
- Serial No. 26 to 37: In all these proposals, SEAC in its abstract has mentioned, "The Committee, in view of the project being one of violation of the EIA notification as also in terms of Common Cause judgment of the Hon'ble Supreme Court, decided that the PP is required to conduct Environmental Impact Assessment Study and prepare Remediation Plan, Natural Resource Augment Plan and Community Resource Augmentation Plan".

However, in the examination of SEIAA, it was not clear whether it is a case of violation or not. Hence, The Authority decided to **refer back** these proposals to SEAC for clarification regarding proposals being of violation or not?

Serial No. 42: A major road is passing through the lease area and no safety plan for this road is provided. Hence, the Authority decided to refer back this proposal to SEAC. The SEAC may examine the same on account of:

Category of road (MDR / Village road etc.) to be confirmed from PWD.

A revised safety plan according to the category of the road.

- Serial No. 47: Lol letter enclosed in the file is different from the Lol letter uploaded online. Hence, the Authority decided to refer back this proposal to SEAC. The SEAC may kindly explain the manner in which the proposal was examined and specific reply must be given for the same.
- Serial No. 51: The uploaded KML of this proposal is not accessible. However, mining is visible in the lease area as per the screenshot of KML submitted during the presentation. Hence, the

Authority decided to defer this proposal and call PP/ Consultant for presentation with correct coordinates.

Serial No. 52: The Authority accepted the recommendation of SEAC and decided to grant EC to this proposal subject to condition that PP shall carry out mining activity after leaving 45m distance from seasonal nalla and with compliance to the conditions mentioned in WRD Certificate.

Serial No. 53: The Authority accepted the recommendation of SEAC and decided to grant EC to this proposal subject to condition that PP shall comply with specific conditions mentioned in EC.

Serial No. 61: In this proposal, there is a conflict with the forest boundary in the KML as per the coordinates provided by the PP. However, DCF Barmer has certified that the distance of applied area from the forest is 550m. Hence, keeping in view the DCF certificate, the Authority accepted the recommendation of SEAC and decided to grant EC to this proposal.

Serial No. 62: The proposal was deferred in the 5.49th meeting of the Authority for valid LoI. Subsequent to this, defer letter was issued on 21st Nov 2022 to submit the same in 45 days. Since, the PP/ Consultant failed to submit the same till date. Hence, the Authority decided to close & delist this proposal.
