


**PROCEEDINGS OF THE MEETING OF STATE LEVEL EXPERT APPRAISAL




SCREENING AND SCOPING OF COUNTRY LIQUOR PROPOSALS:



After detailed discussion, the SEAC considered these proposals as 'B2' category and recommended for Environmental Clearance with conditions stipulated for country liquor unit in general.


