The Authority after detailed discussion and deliberation decided the following:

1. **Serial No.1:** This proposal was deferred in the 5.107th meeting of the Authority for submission of certificate from DCF (WL), Mount Abu and an affidavit for implementation

of Cluster EMP. Now, PP has submitted the required documents. Hence, the Authority decided to grant approval of EIA/ EMP and EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

2. **Serial No. 2:** PP was heard. The Authority decided to **defer** the proposal for a clarification on validity of Environmental Clearance with supporting documents within 45 days, stating whether their EC was valid or not on the date of notification dated 12.04.2022.
3. **Serial No. 3:** The reply of PP in response to the query letter issued by SEIAA on 25.10.2023, was examined. PP had originally applied for grant of EC without violation and an affidavit in that regard was submitted accordingly without violation. However, during the course of examination by SEAC, the proposal got revised to ToR with violation. This matter has already been discussed in the meeting dated 7.02.2024 in SEIAA. Environmental Clearance, in the instant case, was issued on 7.10.2015 which is prior to the Common Cause judgement of Hon'ble Supreme Court dated 02.08.2017. There has been no violation of the conditions of EC issued previously for the PP.

Therefore, the present request for expansion in production capacity can not be treated as a violation of conditions of EC, as is also confirmed in the Certified Compliance Report issued dated 17.10.2022 by the IRO.

There is no provision in the Common Cause judgement of Hon'ble Supreme Court of reviewing ECs with retrospective effect in respect of cases wherein production capacity has exceeded the base year. The main directive in this regard, is with the amount to be collected by the Mining Department in such cases. In view of the above, the matter may **be referred back to SEAC** to review its recommendations with respect to grant of EC for expansion "with violation" and the penalty or remediation plan which it entails.

4. **Serial No. 4:** This proposal was deferred in the 5.113th meeting of the Authority for submission of Cluster Certificate, Affidavit of PP and Consultant regarding no violation and a Certificate from WRD with respect to nallah within the core zone of the proposed lease area. Now, PP has submitted an adequate reply to the queries raised. Hence, the Authority decided to **grant EC** to this proposal.
5. **Serial No. 5, 6:** These proposals were deferred in the 5.113th meeting of the Authority for submission of Action Taken Reports on the non-complied conditions of the Certified Compliance Reports. Now, PP has submitted the required documents. Hence, the Authority decided to **grant EC** to these proposals.
6. **Serial No. 7, 10, 12, 18, 30, 34, 43:** The Authority decided to **defer** these proposals in light of the O.M. No. IA3-3/4/2024-IA.III [E 230791] dated 08.01.2024 issued by MoEF&CC regarding stay imposed by Hon'ble Supreme Court in W.P.(C) No. 1394/2023 titled

Vanshakti vs. Union of India, with reference to the SOP dated 7th July 2021 and OM dated 28th January 2022.

7. **Serial No. 8, 52:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **grant ToR** to these proposals.
8. **Serial No. 9, 11, 13, 17, 28, 29, 31, 36, 38:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to these proposals.
9. **Serial No. 14, 24, 35:** The Authority decided to **close and delist** these proposals in light of the, O.M. No. IA-22/01/2021-IA-III- Part (1) dated 15.01.2024 issued by MoEF&CC regarding following the SOP for dealing mining proposals under Ministry's OM dated 28.04.2023 on PARIVESH Portal 2.0.
10. **Serial No. 15:** The Authority decided to **defer** this proposal for Personal Hearing and sought a **clarification on** validity of Environmental Clearance dated 30.11.2012 of this proposal.
11. **Serial No. 16, 22, 33, 41, 42, 44, 45, 46, 47, 48, 49, 50, 51, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64:** The Authority decided to accept the recommendations of SEAC and decided to **close and delist** these proposals.
12. **Serial No. 19, 20, 21, 23, 26, 27, 32, 39, 40:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **approve EIA/EMP and grant EC** to these proposals with the condition that PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
13. **Serial No. 25:** In this proposal, a mismatch has been found in the Khasra Nos. provided in the proposal. In ToR letter, Lol, Annexure G, Aravali Certificate Khasra Nos. are mentioned as 843, 842, 836, 1198/824 and 1199/835 while in Form 1, Lease deed, Aravali Certificate (Old) and in affidavit, they are mentioned as 843, 842, 836, 1199/835. Hence, the Authority decided to **defer** this proposal, for clarification on Khasra Nos., within 45 days.
14. **Serial No. 37:** In view of the estimated population, the proposed Parking Provisions submitted with the proposal are inadequate. In addition, the PP has not submitted an affidavit regarding no spillover of vehicles outside the property. Hence, the Authority has decided to **defer** this proposal for Personal Hearing and submission of an affidavit for no spillover of vehicles outside the project premises.
15. **Serial No. 53:** In this proposal, PP has submitted the WRD Certificate to the Authority. Hence, the Authority decided to **refer back** this proposal to SEAC for further examination.
16. **Serial No. 65:** In this proposal, ToR dated 10.12.2018 was issued by the MoEF & CC under violation. As per the directions of Hon'ble Supreme Court order dated 10.1.2024, the proposal was considered in this meeting and based on the discussions, the Authority decided to **defer** this proposal until further orders are received in light of the O.M. No. IA3-3/4/2024-IA.III [E 230791] dated 08.01.2024 issued by MoEF&CC regarding stay imposed by

Hon'ble Supreme Court in W.P.(C) No. 1394/2023 titled Vanshakti vs. Union of India, with reference to the SOP dated 7th July 2021 and OM dated 28th January 2022.

17. Serial No. 66, 67, 68, 69, 70, 71, 72, 73, 74, 75, 78, 79, 80, 81, 82, 83, 84, 85, 87, 88, 89, 90, 92, 93, 94, 95, 96, 98, 99, 100, 101, 102, 104 :The Authority decided to **grant Transfer EC** to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2024 issued by MoEF&CC.
18. Serial No. 76, 77, 103: The Authority decided to **grant Transfer EC** to these proposals with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
19. Serial No. 86, 91, 97, 105: The Authority decided to **grant Transfer EC** to these proposals.
