SEIAA also decided to seek clarification from SWID as ground water abstraction is a serious environmental concern.

- 2. The PP has submitted plantation plan approved by Forest Range Officer, Hooghly S.F. Range. SEIAA decided to seek clarification from PP including statutory provision, if any, as to why plantation plan approved by Range Officer has been submitted instead of DFO.
- 3. The CER proposed by the PP should be recasted with equal distribution of amount year wise. Consent from sufficient number of targeted beneficiaries should be submitted.
