The Authority after detailed discussion and deliberation decided the following:

Serial No. 1: Proposal was deferred in the 5.113rd meeting of SEIAA for the final outcome
of the stay order imposed by the Supreme Court in W.P. (C) no. 1394/2023 titled Vanashakti
vs. Union of India 02.01.2024.

PP has submitted a representation requesting to consider the proposal as a case of non violation of EIA Notification 2006 and process further for grant of EC while referring to the MoM of the Authority's meeting dated 09.02.2024 which stipulates that "Cases where there has been excess production over the base year, but no excess production over the limit prescribed in the last EC issued, may not be considered as violation cases"

Considering the representation submitted by PP, the Authority is of the view that PP in their affidavit have clearly stated that there is no violation of EIA Notification, 2006 and the OMs issued thereafter. However, as per the Common Cause Judgement dated 02.08.2017 of the Hon'ble Supreme Court, there has been violation of exceeding base year production. The PP was issued EC under EIA Notification, 2006 on 29.08.2016 after which there has been no exceeding of production from the capacity approved in the EC. The PP has now applied for EC for expansion in production. The Authority has held earlier that in such cases for excess production, the penalty should be deposited with the Mining Department and the case should





not be treated as "Violation" of the EIA Notification 2006. The same was communicated to SEAC vide letter dated 09.02.2024.

In view of these facts, the case is <u>referred back</u> to SEAC for reconsideration and in addition to this, SEAC may direct the PP to submit the requisite documents for the following discrepancies:-

- a. In Proposal Khasra No. was 1,148, 154, 151, 152, 153, 155, 174, 175, 176, 194, 195, 197, 198, 473, 476, 561, 708, 649, 648, 647, 646, 645, 644, 643, 642, 611, 610, 609, 608, 607, 606, 565, 560, 556, 555, 554, 553, 552, 422, 421, 479, 480, 478, 477, 475, 474, 203, 204 & 205 but in TOR letter Khasra no. is 1, 204, 476/1, 473, 148, 154, 3, 709 & 561.
- General condition 15 of submitted Certified Compliance Report of EC is mentioned as not complied.
- Serial No. 2: The proposal was deferred in the 5.115th meeting of SEIAA for submission of Affidavit regarding no violation and implementation of Cluster EMP.

Now, PP has submitted the requisite documents. Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

 Serial No. 3: The proposal was deferred in the 5.115th meeting of SEIAA for submission of Affidavit regarding implementation of cluster EMP.

Now, PP has submitted the requisite documents. Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

4. Serial No. 4: The proposal was deferred in the 5.92nd meeting of SEIAA as in the provided KML of this proposal, proposed lease area falls within and adjacent to the forest area.

Now, PP has submitted the Certificate from DCF, Kota stating nearest forest at a distance of 457 m and Certificate from DCF (WL) Kota stating MHTR is at a distance of 2.6 km from the applied area. Considering the same, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant TOR** to this proposal.

 Serial No. 5: The proposal was deferred in the 5.118th meeting of SEIAA for submission of correct numbers of Rain Water Harvesting Structures in the proposal and Valid NOC from CGWA.

Now, PP has submitted a clarification vide his letter dated 30.4.2024 stating that RWH structures are 9 and a copy of CGWA application for which NOC is under way. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal.



- Serial No. 6: The proposal was deferred in the 5.118th meeting of SEIAA for submission of Affidavit regarding no violation and implementation of Cluster EMP.
 - Now, PP has submitted the requisite documents. Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 7. Serial No. 7: The recommendations of SEAC that in this case PP should apply to MoEF&CC for amendment in EC is not in accordance with the further delegation of powers notified by MoEF&CC vide OM dated 03.04.2018 and notification dated 15.11.2018. In addition, SEAC may also consider the notification dated 22.12.2014 issued by MoEF&CC wherein it is stated that Educational Institutes do not require EC.
 - In view of the situation SEAC may reconsider and also to make specific recommendation whether in the present context, PP needs any fresh EC or expansion EC for the residential colony. Hence, the Authority decided to <u>refer back</u> this proposal to SEAC along with the representation submitted by the PP in the SEIAA office.
- 8. Serial No. 8, 9, 10, 14, 16, 17, 18, 21, 22, 24, 25, 28, 29, 30, 38, 40, 43, 45, 46: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- 9. Serial No. 11, 12, 15, 23, 33, 34, 36, 37, 39, 41: The Authority accepted the recommendations and additional conditions of SEAC and decided to approve <u>EIA/EMP</u> and grant EC to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 10. Serial No. 13, 31, 32, 35, 49, 50, 51, 52, 53: The Authority decided to accept the recommendations of SEAC and decided to <u>close and delist</u> these proposals.
- 11. Serial No. 19, 26, 27, 44: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR to these proposals.
- 12. Serial No. 20: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant Amendment of TOR to this proposal.
- 13. Serial No. 42: In this proposal affidavit regarding implementation of Cluster EMP is not submitted. Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of Affidavit regarding implementation of Cluster EMP within 45 days.
- 14. Serial No. 47, 54, 55, 56: The Authority accepted the recommendation of SEAC and decided to grant Re-appraisal of EC issued by DEIAA to these proposals.
- 15. Serial No. 48: In this proposal, the objection of SEAC seems unreasonable. Water Resource Department, which is a competent Authority in the State Government in respect





of water bodies and natural drainage, has issued an NOC on 04.10.2022. In this circumstances to again ask the PP to submit the latest status from WRD does not seem reasonable. Hence, the Authority decided to refer back this proposal to SEAC for reconsideration.

16. Serial No. 57, 58, 59, 60, 61, 63, 64, 65, 66, 67, 69, 70, 71, 72: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2024 issued by MoEF&CC.
