The Authority after detailed discussion and deliberation decided the following:

Grant of EC

- Serial No. 1: The project was deferred in the 5.70th meeting of The SEIAA for submission of revised mining plan as it was under process of approval at the time of personal hearing. Now, PP has submitted the revised mining plan. Hence, the Authority decided to grant EC to this proposal.
- Serial No. 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 26, 27, 32, 33, 34, 38, 39, 41, 44, 45, 46, 47, 48, 50, 51, 52, 54, 55: The Authority accepted the recommendations, additional condition of SEAC and decided to grant EC to these proposals.
- 3. Serial No. 23: In this proposal, Critical Tiger Habitat is at 7.2 km and as per NGT appeal no 48/2016, Nitendra Manav V/s UoI & Others order dated 20.12.2018 activities of all the mining leases falling within 10 Km of Sariska tiger reserve/ WLS would be restricted and EC would not be provided to those mines until they would get clearance from NBWL. Hence, the Authority accepted the recommendations of SEAC and decided to close & delist the proposal till the NBWL clearance is obtained.
- 4. Serial No. 24: In this proposal, area is not mentioned correctly in the DCF certificate and there is no mention of khasra number, reference number, no information regarding the absence of WLS within 10 km periphery.
