- 10. Ground water quality monitoring should be conducted for every month and the report shall furnish in the EIA report.
- 11. EIA report should strictly follow the EIA mining manual.
- 12. Detail plan on rehabilitation and reclamation carried out for the stabilization and restoration of the mined areas.
- 13. The EIA study report shall include the surrounding mining activity, if any.
- 14. Modelling study for Air, Water and noise shall be carried out and incremental increase in the above study shall be substantiated with mitigation measures.
- 15. A study on the geological resources available shall be carried out and reported.
- 16. A specific study on agriculture & livelihood shall be carried out and reported.
- 17. Impact on ponds, rivers and other water bodies to be elaborated.
- 18. Impact of soil erosion, soil physical chemical and biological property changes may be assumed.
- 19. The recommendation for the issue of Terms of Reference is subject to the final outcome of the Hon'ble NGT, Principal Bench, New Delhi in O.A No. 186 of 2016 (M.A.No.350/2016) and O.A.No.200/2016 and O.A.No.580/2016 (M.A.No.1182/2016) and O.A.No.102/2017 and O.A.No.404/2016 (M.A.No.758/2016, M.A.No.920/2016, M.A.No.1122/2016, M.A.No.12/2017 & M.A.No.843/2017) and O.A.No.405/2016 and O.A.No.520 of 2016 (M.A.No.981/2016, M.A.No.982/2016 & M.A.No.384/2017).

Construction Of Hospital By M/s. A.C.S.Medical College & Hospital in S.F. No. 35/1,2,3,63/2,64/1A &1B2 in Numbal village,Ambattur Taluk, Thiruvallur District Tamil Nadu – Activity 8(b) & Category "B2"- Area and Township Development-Environmental Clearance (EC) under violation notification dated: 08.03.2018 of MoEF & CC – Regarding.

The Project Proponent M/s. A.C.S.Medical College & Hospital initially applied for Environmental Clearance to SEIAA – TN in S.F. No. 35/1,2,3,63/2,64/1A &1B2 in Numbal village, Ambattur Taluk, Thiruvallur District Tamil Nadu Tamil Nadu during 2013.

From the perusal of the office records, project proposal and the presentation made by the proponent, the following points were noted:

1. While scrutinizing, it was found from the photographs furnished by the proponent, which shows that the construction activity was started without

- prior Environmental Clearance. Hence it was considered as violation of EIA Notification, 2006.
- 2. The proponent was requested to furnish the 'Letter of Commitment and Expression of Apology' and the proponent submitted the same.
- 3. The same was sent to the State Government for initiating credible action on the said violation by invoking powers under Section 19 of the Environment (Protection) Act, 1986.
- 4. The Proponent was informed that the project proposal is included in the list of cases involving violations of Environmental Protection Act, 1986 and that the project stands delisted in the lists of proposals under process in SEIAA-TN.
- As per the MoEF & CC Notification dated: 14.03.2017, stated that the cases of violation will be dealt strictly as per the procedures specified in the following manner
 - "In case the project or activities requiring prior EC under EIA Notification, 2006 from the concerned regulatory authority are brought for Environmental Clearance after starting the construction work or have undertaken expansion, modernization and change in product mix without prior EC, these projects shall be treated as cases of violations and in such cases, even Category B projects which are granted EC by the SEIAA shall be appraised for grant of EC only by the EAC and Environmental Clearance will be granted at Central level only". Accordingly, the proponent was addressed to submit the proposal to MoEF & CC for EC under violation category vide SEIAA letter dated: 19.06.2017.
- 6. Subsequently, MoEF&CC issued another notification S.O.1030 (E) dated 08.03.2018, stating that "the cases of violations projects or activities covered under category A of the Schedule to the EIA Notification, 2006, including expansion and modernization of existing projects or activities and change in product mix, shall be appraised for grant of Environmental Clearance by the EAC in the Ministry and the Environmental Clearance shall be granted at Central level, and for category B projects, the appraisal and approval thereof shall vest with the State or Union territory level Expert Appraisal Committees and State or Union territory Environment Impact Assessment Authorities in different States and Union territories, constituted under sub-section (3) of section 3 of the Environment (Protection) Act, 1986".

7. The proponent has applied for EC under violation to MoEF & CC.

CHAIRMAN SEAC-TN 8. The application was transferred from MoEF & CC to SEIAA-TN.

The SEAC has noted that the project proponent has applied in the MoEF&CC under violation notification issued by MoEF&CC dated 14.03.2017. But, the application submitted in hard copies to SEIAA has total built up area of 22,281.66 Sq.m with a total plot area of 1,19,263.71 Sq.m. Hence, the SEAC decided that the project proponent is requested to revise the application for the total built up area applied to MoEF&CC under violation notification issued by MoEF&CC dated 14.03.2017.
