- 6. The Socio economic studies should be carried out within 10km buffer zone from the mines.
- 7. Detailed mining closure plan for the proposed project approved by the Geology of Mining department shall be shall be submitted along with EIA report.
 - 21. The spot level and contour level of the proposed quarry site shall be studied and the same shall be furnished to along with EIA.
 - 22. A detailed report on the safety and health aspects of the workers and for the surrounding habitants during operation of mining for drilling and blasting shall be submitted.
 - 23. CER activities should be carried out taking in to consideration the requirement of the local habitants available within the buffer zone as per Office Memorandum of MoEF & CC dated 01.05.2018.
 - 24. Obtain a letter /certificate from the Assistant Director of Geology and Mining standing that there is no other Minerals/resources like sand in the quarrying area within the approved depth of mining and below depth of mining and the same shall be furnished in the EIA report.
 - 25. Ground water quality monitoring should be conducted for every month and the report shall furnish in the EIA report.
