MINUTES OF THE 65th GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA-SEIAA) MEETING HELD ON 26/10/2021 AT 03.30 PM. IN THE CONFERENCE ROOM OF THE 4th FLOOR, DEMPO TOWER, PATTO, PANAJI-GOA.

The sixty-fifth meeting of the Goa-SEIAA (hereinafter referred as 'Authority') was held on 26^{th} October 2021 at 03.30 pm. in the conference room, 4^{th} floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (<u>refer Annexure – 1</u>).

At the outset, Chairman welcomed Authority members and briefed about the agenda items ($refer\ Annexure\ -\ 2$) to be taken up for discussion / deliberations and suitable decisions. Accordingly, the same were considered as detailed below –

1. To decide on application received by Kaloshi Granites for Basalt Stone Extraction in property bearing Survey No. 12/1, Village Damochem, Sattari Taluka, North Goa.

Decision: The Authority after perusing the documents submitted on 13/10/2021, by the above mentioned Project Proponent, in response to the query raised by this Authority on 19/06/2020 in its 55th GSEIAA meeting. The Authority decided to ask the PP to apply online through Parivesh portal as per the Ministry of Environment, Forest & Climate Change (MoEF&CC) Office Memorandum No.22-37/2018-IA.III dated 23rd February, 2021, 19th April, 2021 and No.IA3-19/95/2021-IA-III dated 06/10/2021, which states that all applications for ToR and EC should be submitted online through Parivesh portal.

2. To decide on proposed residential project Alcon Construction (Goa) Pvt. Ltd. Located at Survey No. 112/1 and 112/2, Tonca, Taleigao, Tiswadi North Goa. This application dated 17th September 2021 received on Parivesh (website of MoEF&CC).

Decision: After discussion and considering recommendation by the Goa-SEAC the Authority, members unanimously decided to recommend the said





project proposal for grant of Environmental Clearance under provision of EIA Notification 2006 (as amended) with following conditions:

- i. PP should provide green belt plan, including selection of local plant species in consultation with Goa State Biodiversity Board.
- ii. PP should use solar panels to the extent possible.
- 3. To decide on re-validation of the Environmental Clearance of the project Marvel Resorts Private Limited dated 30th March 2021 received on Parivesh (website of MoEF).

Decision: The Authority after perusing the documents submitted by the Project Proponent, since the PP had already started the work without revalidation of EC and as per Office Memorandum No. F.No.22-21/2020-IA.III dated 07/07/2021 issued by Ministry of Environment, Forest and Climate Change (MoEF&CC), the penalty needs to be imposed for violation. As the PP had not shown the cost of project, we may ask the GSEAC to calculate the estimate cost of the project based on construction carried at site and submit the same to this Authority to impose penalty on PP.

4. To decide on a complaint received from the villagers of Uguem Sanguem Taluka against Basalt Quarry namely Shri. Satyappa Dhangalkar, J.L Baptista, Shri. Josinho Pereira (Marushka Stone Industries) and Shri. Melba Pereira (Dandra Metals).

Decision: After perusing the complaint received from the villagers of Ugem, Sanguem against above mentioned basalt quarry, the Authority decided to inspect the site to see the site condition and thereafter call the Project Proponent for further discussion.

5. Proposed Residential Complex by M/s Trinitas Developers India LLP at Survey No. 117/1A of Sancoale Village of Mormugao taluka in South Goa District.

Decision: The Project Proponent of the said project informed telephonically that he will be unable to attend the meeting, however Shri Rajiv Aundhe,

Director, Aditya Environmental Services Pvt. Ltd. was present for the said meeting. The Authority directed the Shri Rajiv Aundhe to apply the said application on Parivesh portal for grant of Environmental Clearance, as per the Ministry of Environment, Forest and Climate Change (MoEF&CC) Office Memorandum No.22-37/2018.IA.III dated 23rd February, 2021, 19th April, 2021 and O.M No. IA3-19/95/2021-IA-III dated 06/10/2021.
