A. CONSIDERATION OF MINOR MINERAL PROPOSALS (COMPLIANCE RECEIVED):

The committee verified 07 nos. of minor mineral proposals (compliance received) on the basis of MoEF&CC, Govt. of India OM no. F. No. L-I 1011/175/2018-IA-II (M), dated 12.12.2018. B. DECISION ON EC APPLICATIONS APPLIED IN PHYSICAL MODE FOR MINOR MINERAL PROPOSALS (0-5 HA.) PENDING WITH THE APPLICANT.

1. The EC applications of minor mineral extraction proposals (Sand mining and stone, morrum quarrying etc.) involving area less than or equal to 5 ha; i.e., B2 category proposals are all required to be submitted to SEIAA in the online mode. i.e. in the PARIVESH portal of the MoEF&CC, Govt, of India. But, on the plea that the prescribed application Form-IM is not getting generated in the said portal, the concerned Tahasildars were filing such applications in the offline mode using Form-I. Such applications were therefore processed by SEIAA and SEAC in the offline mode and offline ECs were issued in these cases. The MoEF&CC, Govt. of

India has taken exception to this practice, and offline receipt and handling of any such proposal has been prohibited.

- 2. The MoEF&CC, Govt. of India in its OM dated 06.10 2021 has made it mandatory to grant EC with 16-digit EC identification number along with e-signature and other required credentials. This functionality has since been added in the Parivesh Portal. Further, the MoEF&CC, Govt. of India in the said OM has directed all SEIAAs of the States that any new EC issued on or after 20.10.2021 for a project without EC identification number and e-signature shall be treated as invalid.
- 3. The MoEF&CC, Govt of India in a VC meeting held on 12.11.2021 has decided that for online processing of B2 Category Minor Mineral Proposals (area 0-5 ha) in the Parivesh Portal, the EC applications can be submitted to SEIAA in 'Form-2'. The SEIAA/SEAC are to process these proposals following the systemic steps in the said portal, and SEIAA may decide to grant EC and issue system generated EC letter.
- 4. The SEIAA vide letter no. 3497/SEIAA, dated 23.11.2021 has requested to the Director, Minor Minerals, Revenue & Disaster Management Department, Government of Odisha to instruct the concerned Tahasildars / Project Proponents to file the EC applications pending with the Tahasildars / Project Proponents online. The copy of such letter forwarded to the Secretary, SEAC vide memo no. 3498/SEIAA, dated 23.11.2021.
- 5. There are 93 physical EC applications are pending with the Tahasildars / Project Proponents to comply. List of such applications is enclosed as **Annexure-B**.

After detailed discussion, the SEAC decided to forward such 96 physical EC applications to SEIAA, Odisha with a request to instruct the concerned Tahasildars / Project Proponents to file the EC applications online.

C. CONSIDERATION OF TERMS OF REFERENCE FOR EIA STUDY FOR MINOR MINERAL PROPOSALS OF LEASE AREA 25 HA. OR LESS (INCLUDING THE CLUSTER APPROACH)

- The SEAC in its meeting held on 17.11.2020 decided that the appraisal for issue of ToRs for the minor mineral proposals of lease area 25 ha. or less (including cluster approach) may be considered with specific ToRs as suggested by SEAC as well as standard ToRs based on merit of the proposal without presentation.
- 2. The SEIAA, Odisha has forwarded 10 online EC applications of minor mineral proposals of lease area 25 ha. or less (including cluster approach) as per Annexure-C.

After detailed discussion, the SEAC decided to forward such 10 online EC applications to SEIAA, Odisha with a request to issue specific ToRs as suggested by SEAC as well as standard ToRs to these to these 10 proposals for conducting EIA study.
