SEAC has sent back the file with the Penalty calculation but while re-examining the file it was found that given figures of incurred cost and Turnover are not duly certified by CA and also, Certified EC Compliance Report is one year old from the date of inspection. Hence, the Authority decided to defer this proposal on account of additional information.
- 24. Serial No. 78: This proposal was considered in 5.46 Meeting of SEIAA and was referred back to SEAC stating that "The PP has applied for EC for the first time and the production of mineral cannot commence without EC. SEAC has itself admitted that the production has been done without EC then why it is not a case of Violation".

PP has submitted production certificated dated 22.11.2022 and SEAC stated that mining lease got registered on 10.07.2014 before the MoEF&CC Notification dated 07.10.2014 therefore it does not require prior EC and as per the certificate PP has not exceeded the production from 10.07.2014 to 31.10.2014 therefore, it is not as case of violation.

Considering the above facts, the Authority decided to accept the recommendation of SEAC and <u>approve EIA/EMP and grant EC</u> to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

25. Serial No. 80: This proposal was considered in 5.38 Meeting of SEIAA and was referred back to SEAC stating that "despite the increase in area of the cluster the project proponent has not shown any increase in the traffic of the vehicles and pollution load, which in the opinion of the Authority is not possible".

In this context, PP submitted the reply on 30.09.2022 saying that there is no increase in the cluster area but submitting the revised traffic study report.

Considering the above facts, the Authority decided to accept the recommendation of SEAC and <u>approve EIA/EMP and grant EC</u> to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 26. Serial No. 81 to 84: The Authority accepted the recommendations of SEAC and decided to grant Transfer of EC to these proposals.
- 27. The Authority also discussed the representation given by Shri Sanjeev Rawat authorized signatory for Ashiana Housing Limited regarding application of environmental clearance for proposed group housing project Ashiana Ekansh plot area 34816.61 Sqm, Gross Built up Area: 110828.59 Sqm located at Khasra No. 1790, 1791/1, 1791/2, 1792, 1793/1, 1793/2, 1794 and 1794 and 1795, Village Bhankrota, Tehsil Sanganer, Jaipur, Rajasthan

Subsequent to the 5.54th meeting, PP has submitted a certificate from the Architect that the conceptual plans submitted for grant of EC are in accordance with the building plans approved by JDA, which have also been submitted. In view of the clarification submitted in writing, the Authority decided that there was no need for re-examination by SEAC to seeking confirmation on the same point. Accordingly, it was decided to grant EC, as recommended by SEAC.
