The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1 & 2:** These proposals were considered in 5.58th Meeting of SEIAA and were deferred "*as the Authority was of the view that it is appropriate to afford an opportunity of representation/Personal Hearing to PP to explain as to why the recommendations of SEAC may not be accepted*".

During the representation/Personal Hearing, PP/Consultant submitted hard copy of the presentation made for personal hearing. However, the Authority directed that PP/Consultant may submit a detailed formal representation in this regard. Hence, the Authority **decided to defer these proposals**.

- Serial No. 3 & 4:** These proposals were considered in 4.67th Meeting of SEIAA and were rejected as these proposals fall in Aravalli Hills.

In these proposals, original application was submitted in 2018, which was rejected by SEIAA. However, **Hon'ble High Court has set aside the order of**

SEIAA and given directions for affording an opportunity of hearing and to decide the matter afresh in light of SEIAA's recent orders in similar matters.

During this period since the submission of application, several facts and data have changed. Accordingly, PP requested to submit revised application for ToR which may be then examined on merit by SEAC. Hence, the Authority decided to defer this proposal.


3. **Serial No. 5:** The proposal was deferred in 5.45th meeting of SEIAA held on 13.10.2022 as the LoI of the proposal had expired. The PP was directed to submit LoI letter within 45 days failing which the proposal will be closed and delisted.

The PP, even after lapse of more than 90 days, has not submitted valid LoI or lease agreement. Hence, the Authority decided to Close & Delist this proposal.

4. **Serial No. 6:** The proposal was withheld in 5.04th meeting of SEIAA held on 12.01.2022 for "*a) DCF Bhilwara shall provide the exact distance of the proposed area from the forest and depict the same on the map. b) The Mines Department shall provide the details of all the 14 blocks in this cluster along with their distance from the forest area on the map and also provide details of ECs already issued*".


No information has been received neither from PP/Consultant nor from DCF, Bhilwara/Mining Department even after more than 1 year. Hence, the Authority decided to Close & Delist this proposal.


5. **Serial No. 7:** This proposal was deferred in 5.06th meeting of SEIAA held on 13.01.2022 for the Clearance from NBWL. PP has not submitted the same till date. Hence, the Authority decided to Close and Delist this proposal till such time the NBWL Clearance is obtained
6. **Serial No. 8, 11:** The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals with the condition that the WRD condition stating "*PP will be bound to follow all rules issued by the State Government*" shall be adhered to.
7. **Serial No. 9, 10, 12, 14, 16:** The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals.
8. **Serial No. 13:** The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with the direction that all the conditions as mentioned in WRD Certificate shall be complied by the whole cluster.




9. **Serial No. 15:** In this proposal, Mining Plan and Cluster Certificate have expired as on date. Hence, the Authority **decided to defer this proposal** for additional information.
10. **Serial No. 17:** The Authority accepted the recommendations of SEAC and decided to **approve EIA/EMP and grant EC** to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
11. **Serial No. 18 & 19:** The Authority accepted the recommendations & additional conditions of SEAC and decided to **grant ToR to these proposals**.
12. **Serial No. 20:** The Authority accepted the recommendations of SEAC and decided to **close & delist this proposal**.
13. **Serial No. 21:** The Authority decided to **grant Transfer of EC to this proposal**.
