The Authority after detailed discussions and deliberations decided the following:

A. A.

- 1. Sr. No. 1 to 37, 39 to 42, 44 to 48, 50 to 57: the Authority accepted the recommendation of SEAC and decided to Grant EC to these proposals.
- 2. Serial No. 38: The Authority examined the proposal in detail and found that a number of serious complaints/objections were raised during the course of public hearing of the proposal, which do not seem to have been adequately addressed. It was decided to refer this matter to District Collector Nagaur requesting him to examine the objections raised in light of factual position and consultation. Hnece the Authority decided to defer this proposal for additional information.
- 3. Sr. No. 43 & 49: The Authority accepted the recommendation of SEAC to close & delist these proposals.
- 4. **Serial No.** 64: The Project Proponent had filed a representation before SEIAA against the recommendation made by SEAC for refusing to grant ToR. The Project Proponent, along with his counsel, was heard by the Authority in the 5.18th meeting held on April 20, 2022. Since a voluminous body of documents were also provided, SEIAA deferred that matter for taking time to examine them. Accordingly, the case was again put up in the 5.21st meeting held on May 19, 2022 for final decision. The Authority examined the arguments and logic stated by SEAC in support of its decision and, in that light, examined the arguments and documents provided by the PP.
 - A. SEIAA, after careful consideration, disregards the recommendation of SEAC to deny grant of ToR to the PP on account of the following facts:
 - (1) The competent authority in the State to enforce the directions the Hon'ble Supreme Court of India in regard to prohibiting mining in the Aravalli hills with stipulated conditions is the Mining Deptt., as it is for issuing the certificate whether any mine in the Aravalli hills is not in violation of the directions of the Hon'ble Supreme Court. AME Kotputli in his dated 8-1-2020 has stated that the area of this Mining Lease, as per GT sheet 45M/14 (with

detailed co-ordinates quoted in the letter) is not in violation of the order dated 8-04-2005 of the Hon'ble Supreme Court in the Contempt Petition (C) 412/2004 and orders of the Hon'ble Supreme Court in W.P. (Civil) w2. 202/1995 T.N. Godavarman vs. UOI & Oth. According to SEIAA, this certificate is clear and bears no ambiguity.

- (2) All authorities competent to accord approvals, sanctions etc., have interpreted the directions of the Hon'ble Supreme Court in respect of mining in Aravalli hills to be that no new mining lease is to be issued or renewed post Dec. 16, 2002. The Order is not applicable on those mines which have been sanctioned earlier. Various statutory and other approvals required for mining operations like issue of EC, expansion in production, mineral inclusion, setting up of processing units, Mining plans, CTE and CTO etc. have continued to be accorded, subsequent to the 18-04-2005 order, to mines in the Aravalli hills where the lease had been sanctioned prior to the cut-off date. This view or contention has not been struck down by the Hon'ble Supreme Court till date. for being in contempt of the directions issued.
- (3) The Buchara China Clay Mine of M/s Shri Modi Levigated Kaolin Pvt. Ltd., while being located in the Aravalli hills, is an old mine existing prior to 16-12-2002. As stated by SEAC, the mining lease for this project stands extended up to 31-03-2025.
- (4) DFO, Jaipur (North), vide his letter No. 581 dated 20-01-2020 has informed that the permission for diversion of forest land for mining purposes is coterminus with the lease period under MMDR Act.

- (5) Mining Deptt., Govt. of Rajasthan has approved the Modified Mining Plan of this mine vide letter No. SME/Jai/Modified Mine-Plan/P-607/2019/17 dated 08-01-2020.
- (6) Finally, this is only the stage to grant ToR, for which there is no ban by the Hon'ble Supreme Court. Any issues that remain, and not addressed in this order, may be taken up during the course of public hearing and thereafter.
- B. In view of above, after detailed deliberations it was decided to accept the application and grant ToR for mineral inclusion and expansion in production of mining project for China Clay, Quartz, Feldspar, Silica Sand and Masonry stone with proposed production capacity of 15,67,800 TPA with proposed 2 crusher units of capacities 200 TPH and 130 TPH respectively at at its existing 37.84 ha Buchara mine (M.L. No. 07/1992) in Kotputli Tehsil, district Jaipur under the provision of Ministry of Environment, Forests & Climate Change Notification S.O. 1530 (E) dated 06-04-2018 for undertaking detailed EIA / EMP study subject to the following specific terms and conditions in addition to the standard ToR conditions applicable for non-coal mining projects:
 - (1) This approval is granted subject to any pertinent order of the Hon'ble Supreme Court of India, Hon'ble High Court of Rajasthan and any other Court of law as may be applicable for this project.
 - (2) Violations in the project, as reported, may be dealt with in accordance with the procedure set forth by the Ministry of Environment, Forest & Climate Change for such cases.
 - (3) Detailed order is stated in the file concerned.
- Serial No. 58 to 63: The Authority after detailed discussion decided to Grant Transfer EC to these proposals.

The Authority further discussed the issues relating to pendency of proposals in SEIAA & SEAC and distribution of work between SEAC 1 and SEAC 2 and directed the following:

- 1. The Authority in its meeting dated 18th Oct 2021 had decided that B-2 cases would be assigned to SEAC 1 and B-1 cases to SEAC 2 and that the position would be reviewed after some time. On the basis of consultations as well as practices being followed in some other States it was decided that henceforth cases would be assigned on odd and even basis to SEAC 1 and 2 respectively, as received. However, SEIAA may allocate bulk of cases together to any one SEAC if it is apparent that they pertain to a common area and are of the same nature.
- 2. The Authority reviewed the list of long pending cases at the level of SEAC. It was decided that the following cases may be sent to SEIAA for close and delist:
- a) all such cases, where the Project Proponent has not submitted reply to queries raised by SEAC within a period of 90 days or more.
- b) all such cases, where the Project Proponent has got the proposal deferred and not come back to SEAC for hearing within a period of 90 days from the last deferment.
- 3. Similarly, direction is issued to SEAC to take up all cases for hearing that were deferred by SEAC upto and before March 31st, 2022 on priority and to take up hearing of these case cases for final disposal by June 30th, 2022. A list of all such cases that are not disposed of by that date shall also be sent to SEIAA along with the reasons for the same, case wise.
