

**MINUTES OF THE 123<sup>RD</sup> GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA-SEIAA) MEETING HELD ON 29/05//2024 AT 03:00 P.M. IN THE CONFERENCE HALL OF THE DEPARTMENT OF ENVIRONMENT & CLIMATE CHANGE, 4<sup>TH</sup> FLOOR, DEMPO TOWER, PATTO, PANAJI-GOA.**

The 123<sup>rd</sup> meeting of the Goa - SEIAA (*hereinafter referred as 'Authority'*) was held on 29<sup>th</sup> May 2024 at 03:00 pm in the conference room, of the Department of Environment & Climate Change, 4<sup>th</sup> floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (*refer Annexure - 1*).

At the outset, Chairman welcomed Authority members and briefed about the agenda items (*refer Annexure - 2*) to be taken up for discussion / deliberations and appropriate decision. Accordingly, the same were considered as detailed below.

- 1. To decide on application received for ToR from Shirdi Steel & Rollers Private Limited for Expansion of production capacity from 100000 TPA to 150000TtPA at plot No. L-8 & L-9 in Cuncolim Industrial Estate and Survey No. 338(P) and 339(P) of Cuncolim village, Salcete taluka, South Goa.**

**Decision:** After perusing the documents submitted by the Project Proponent, and scrutinizing the Notification No. S.O.3250(E) dated 20/07/2022 and Office Memorandum No.J-11011/321/2016-IA.II(I) dated 27/04/2018 issued by MoEF&CC respectively, the Authority has decided to seek clarification from MoEF&CC, whether the said project needs to undergo public hearing or not.

- 2. To decide on application received from Classic Sqaures Realty Private Limited for proposed construction of a residential project "Central Square" at P.T. Sheet No. 175 of Chalta No. 67/7,68/3,68/5 and 68/6 in Mapusa Municipal area of Bardez taluka, North Goa for prior Environmental Clearance.**

The Project Proponent of Classic Sqaures Realty Private Limited Mr. Oswald D'Mello along with his structural Engineer Mr. Rajesh Mahambrey appeared before the Authority.


**Decision:** After scrutinizing the documents submitted by the Project Proponent and after going through the presentation, the Authority decided to raise the following ADS:

- Details of fire assembly points including the emergency exit.
- Explore the possibility of increasing of solar power.
- PP needs to plant water observant, native varieties of trees in green area and needs to increase the number of varieties of the trees to be planted.
- PP needs to provide separate entry and exit gates.
- Details of parking facility for visitors and residents.
- Details of functioning of STP and its maintenance.

- viii. Safety Measures and Disaster Management/ Rescue Plan.


