

- d. **Tree Plantation:** -Compensatory Tree Planting (CTP) shall be carried out with minimum @100 trees per Ha. of lease area as per the approved cost norm for avenue plantations of the State Forest Department. The Project Proponent (lease holder) shall deposit Rs.2,00,000/- with the respective District Environment Society for raising 400 plants of native species within 2 years in a suitable location adjoining to quarry.
- e. **State EMF Fund:** - An amount equal to five percent (5%) of the royalty payable shall be collected from the lessee by the Tahasildar and deposited to the State Environment Management Fund, which will be utilized as per provisions of Rule 49(3) of the OMMC Rule, 2016 preferably, in and around the areas where mining activities are undertaken.

**Proposal in brief:**

The highlights of the proposal as ascertained from the application and as revealed from proceedings/discussion held during the meeting of SEIAA, are given as under.

- (i) This is a proposal Transfer of EC of Mandal Stone Quarry-II over an area of 4.29 Acres or 1.736 Hectares in village Mandal under Belpara tahasil of Balangir District.
- (ii) Documents submitted: Application in Form-7, earlier EC copy, Tahasildar forwarding letter, Status of quarry and scrutiny of Rs. 1000/- vide e-Challan Ref. No. 336F41E848 dated 09.09.2022
- (iii) The EC of Mandal Stone Quarry-II over an area of 4.29 Acres or 1.736 Hectares in village Mandal under Belpara tahasil of Balangir district was in favour of Tahasildar, Belpara vide SEIAA letter no./Identification No 10038/SEIAA dated 14.12.2020.
- (iv) Present status of quarry - operating conditions
- (v) Whether submitted KML file-Yes
- (vi) The project proponent applied proposal for transfer of EC from the name Tahasildar, Belpara to Sri Sanjib Kumar Thakur, (highest bidder/lessee) with attaching Tahasildar forwarding letter vide letter no. 518 dated 15.03.2022.
- (vii) The Tahasildar vide his letter no. 342 dated 14.02.2023 mentioned that quarry is not working now but in the KML file it appears that quarry is in operating conditions.
- (viii) The proposal was placed in 109<sup>th</sup> SEIAA meeting held on 24.02.2023 and the Authority observed that on viewing the KML file in the google earth image reveals that the quarrying activity has already been done in the lease area, whereas the Tahasildar has mentioned that the quarry is in non-operating condition which is contradictory.

After detail deliberation, the Authority decided that the Sub-Collector, Balangir may be requested to carry out the site inspection and submit report regarding the quantity of material extracted without transfer of EC and valuation of quantity of extraction carried out in the site. If, extraction of material has already taken place, then it is required to submit the following:

- (a) A certified report from the Chartered Accountant (CA) regarding the total project cost incurred upto the date of filling the application and
- (b) Total turnover during the period of operation of the quarry.
- (c) There is discrepancy on actual lease area for which EC obtained and lease area submitted in KML file to SEIAA, Odisha through Email. This needs to be reconciled.
  - (i) Now, the PP has submitted compliance.




