The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1, 6, 8, 9, 11, 13, 15, 17, 19, 21, 24, 25, 27, 32, 33, 36, 37, 38, 39, 41, 42, 44, 46, 56, 61, 64, 65, 70, 72, 73, 74, 75, 76, 81, 82, 84, 85, 86, 87, 88, 89, 90, 91, 92, 94: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- 2. Serial No. 2,3: The Authority decided to refer back these proposals to SEAC. The earlier ground for closing and delisting this proposal has been clarified from the order of Hon'ble NGT dated 09.08.2024 wherein it has been directed to re-appraise ECs granted by DEIAA from 15.01.2016 to 11.12.2018 for appraisal/ re-appraisal by SEIAA. In view of the above, SEAC may re-appraise the proposal from technical view and re-submit its recommendation.
- Serial No. 4,7, 22, 40, 80, 83, 95: The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
- Serial No. 5: For this proposal, the recommendation of SEAC is ambiguous. On one hand they have considered it as a case of "Expansion and Violation" and on the other hand, they

have recommended the proposal for issue of EC for "Expanion and Violation" under the provisions of MoEF&CC notification dated 14.07.2017 and 08.03.2018. However, MoEFCC Notifications dated 14.07.2017 and 08.03.2018 are applicable only for such cases where the applications are submitted within a time period of six months and extended further by one month. Since, in the present case PP has not submitted the application within the window provided for, hence it can not be considered under the provisions of notification 14.07.2017. The plea made by CREDAI before the Hon'ble SC is that changes (increase or decrease) in Builtup area or Number of units are a part and parcel of Building and Construction projects and should be considered as Modification/ Alteration rather than as violation provided that prior EC has been issued and the subsequent changes in BUA or Number of units are approved by the competent authority, the project in the "Permissible Category". Therefore, SEAC may re-examine its recommendation in light of the above.

- 5. Serial No. 10, 12, 18, 20, 23, 48, 50, 51, 52, 53, 54, 55, 58, 60, 66, 71: The Authority accepted the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to these proposals. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects along with the conditions laid down by SEAC.
- Serial No. 14: In this proposal, Cluster Certificate has expired. Hence, the Authority has
 decided to defer this proposal for submission of latest Cluster Certificate, within 45 days.
- 7. Serial No. 16: The Lessee of this proposal has passed away on 04.01.2024. Hence, the Authority has decided to close and delist this proposal and advise the legal heir of the Lessee to get the lease transferred in his/her name and then apply afresh for grant of EC.
- 8. Serial No. 26: SEAC has recommended the proposal for the issue of EC after the Authority has taken an appropriate view on the proposal being in the violation category. Accordingly, the Authroity decided to defer this proposal for further examination on the issues raised by SEAC keeping in view decisions of the Authority in similar cases.
- 9. Serial No. 28, 29: In view of the observations of SEAC, the PP is directed to obtain the lastest Cluster Certificates from the Mining Department which should incorporate all LoIs/ Leases issued in the proposed area after the issue of previously submitted Cluster Certificates in these proposals. This fact should be clrealy recorded in the Cluster Certificates. Hence, the Authority decided to defer this proposal for submission of latest Cluster Certificates, within 45 days.
- 10. Serial No. 30: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal subject to the condition that the additional land of 0.101 Ha shall be

- utilitized for the project only after completion of formal proceedings of transfer in the name of JIAL.
- 11. Serial No. 31: In this proposal, Eco-sensitive Zone of Nahargarh WLS is at a distance of 2.5 km. Hence, the Authroity decided to defer this proposal till further instructions are received from MoEFCC in compliance to the Hon'ble NGT order dated 09.08.2024.
- 12. Serial No. 34: In this proposal, General Condition No. 15 of the Certified Compliance Report has not been complied with. Hence, the Authority decided to defer this proposal for submission of Action Taken Report for the non-complied condition, within 45 days.
- 13. Serial No. 35: In this proposal, Affidavit submitted by the PP does not state the compliance/ non-compliance of EIA Notification, 2006 and the PP has not submitted an affidavit regarding the spillover of vehicles of the building. Hence, the Authority decided to defer this proposal for submission of affidavits, within 45 days. In addition, PP is directed to submit a justification for proposed parking also, keeping in view the usage of the proposed building and population projected.
- 14. Serial No. 43: In this proposal, General condition no. 16 of the Certified Compliance Report has not been complied with. PP has not submitted an affidavit regarding the spillover of vehicles of the building and the Completion Certificate of Phase I. The proposed parking is less than the NBC 2016 norms and SEIAA MoM dated 15.09.2023. Hence, the Authority decided to defer this proposal for submission of requisite documents and revised parking proposal, within 45 days.
- 15. Serial No. 45: In this proposal, the PP has mentioned in the presentation that they have completed the construction till 30.10.2012 before the expiry of EC issued. In this regard, the PP may submit an affidavit clearly stating that no construction on the said project was done after 25.11.2012 i.e. the valid period of the EC issued. Hence, the Authority decided to defer this proposal.
- 16. Serial No. 47: The Authority decided to defer this proposal for submission of a certificate from the CA citing each item on which expenditure has been incurred subsequent to 26.12.2021 upto the present day on the project along with the approved accounts and balance sheets of the project, within 45 days.
- 17. Serial No. 49, 57: The Authority accepted the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to these proposals subject to submission of an affidavit regarding implementation of cluster EMP. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects along with the conditions laid down by SEAC.

- 18. Serial No. 59: In this proposal, the PP has not submitted Production Certificate after financial year 2021-2022. Hence, the Authority decided to defer this proposal for submission of Production Certificate for years 2022-2023 and 2023-2024, within 45 days.
- 19. Serial No. 62: In this proposal, MHTR is at a distance of 3.5 km from the proposed lease. Hence, the Authority decided to defer this proposal for submission of a Conservation Plan, witin 45 days.
- 20. Serial No. 63: The Authority accepted the recommendations of SEAC and decided to grant amendment in EC tho this proposal.
- 21. Serial No. 67: In this proposal, PP has not applied for necessary permissions required to meet the water requirement of the proposal. Hence, the Authority decided to defer this proposal for submission of requisite document, within 45 days.
- 22. Serial No. 68: In this proposal, Eco-sensitive Zone of Nahargarh WLS is at a distance of 4 km. Hence, the Authroity decided to defer this proposal till further instructions are received from MoEFCC in compliance to the Hon'ble NGT order dated 09.08.2024.
- 23. Serial No. 69: In this proposal, the parking provided by the PP was found inadequate. Hence, the Authority decided to defer this proposal for submission of the justification for proposed parking in accordance with order of the Authority dated 15.09.2023 issued for parking provisions.
- 24. Serial No. 77: The Authority accepted the recommendations of SEAC and decided to grant amendment in ToR to this proposal.
- 25. Serial No. 78: In this proposal, the PP has not submitted the Certified Compliance Report. Hence, the Authority decided to defer this proposal for submission of the Certified Compliance Report, within 45 days.
- 26. Serial No. 79: The proposed lease area is located at a distance of 10 km from Juranja Conservation Reserve. Hence, the Authority decided to defer this proposal for submission of a Conservation Plan, within 45 days.
- 27. Serial No. 93: In this Proposal, affidavits submitted by the PP and the Consultant does not mention the compliance or non-complaince of the Common Cause Judgemnt of the Hon'ble Supreme Court. Hence, the Authority decided to defer this proposal for submission of affidavits from the PP and the Consultant for project being in compliance or non-compliance of the Common Cause Judgement, within 45 days.
- 28. Serial No. 96, 97, 98, 99, 100, 101, 102, 103, 105, 106, 107, 108, 109, 110, 111, 112, 113, 114, 115, 116, 117, 118, 119, 120, 121, 122, 124, 125, 126: These pertain to re-appraisal of

- ECs issued by the erstwhile DEIAAs. The Authority accepted the recommendation of SEAC and decided to grant EC to these proposals.
- 29. Serial No. 104: In this proposal, the name of PP differs from the name of applicant for reappraisal of DEIAA EC issued. Hence, the Authority decided to refer back this proposal to SEAC to re-examine and resubmit its recommendations.
- 30. Serial No. 123, 127 and 128: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals with the direction that the RSPCB shall initiate action against the Project Proponent for non-compliance of O.M. dated 03.11.2023 issued by MoEF&CC.
