## **DELIBERATION IN SEIAA AND SEAC**

After detailed deliberations, the committee observed:- **The SEAC in its meeting held on 07.09.2019 has opined that similar type of proposals were already discussed and decision have been taken to extend the validity period upto 30 years or life of the mine whichever is less as per order passed by the Honâ€™ble High Court, Delhi as well as Odisha. Hence, the SEAC recommended for extension of validity period of environmental clearance granted to M/s Gandabahali Graphite Mines as above upto 30 years or life of mine whichever is less. The proposal was placed in the 14th meeting of SEIAA and was decided that that we may ask for the latest compliance report on the EC conditions presently in operation. EC is liable to be revoked if compliance is not satisfactory. Now the PP has submitted the necessary compliance.**
