Note:Submit a copy of each of above documents - <u>Hard and Soft</u> <u>Copies (CD) to the Member secretary, Violation (Note: Not by Name)</u> by speed post so as to reach well in time.

- (ii) Compliance Report from Regional Office, MoEF&CC (Applicable for projects already having EC).
- (iii) The KML/Shape files should be emailed to mentioned at para No. 7 below at least 5 days prior to the meeting.
- (iv) The above all documents are required to be forwarded to the Chairman/Members of the Expert Appraisal Committee along with soft copy.

- 2 All the documents including the hard copy of the presentation material should be legible and printed on both sides on ordinary paper. In caseO1:22 AM the members of the Expert Appraisal Committee do not receive the proposals/documents before the meeting, the Committee will not consider the project.
