

The Authority after detailed discussion and deliberation decided the following:

Hence, the Authority decided to <u>refer back</u> these proposals to SEAC, pointing out the above mistakes in the documentation and to correct the filing of the documents as well as the details in the note-sheet & abstract. The Authority directed SEAC to re-send the proposals back after reviewing along with duly authenticated DSR by the competent authority (not self-attested).

- 7. Serial No. 25: In this proposal, a road is passing along the pillar line DE. Keeping the same in view, the Authority accepted the recommendation of SEAC and decided to grant EC to this proposal with the condition that Mining Department shall reconfirm the pillar locations with the coordinates on KML in order to ensure that no portion of the village road is part of the mining lease area.

- 13. Serial No. 40: The Authority decided to refer back this proposal to SEAC for seeking details on the following points:

Serial No. 41: In this proposal, as per DCF Karauli certificate, Kaila Devi WLS and Ranthambore Tiger Reserve is at a distance of 5.1 km and forest boundary is at 0.04 km as mentioned in submitted Form I. Hence, the Authority decided to reject this proposal in view of the lease area being less than 50 m and point no. 8 of circular dated 14/03/2023 issued by Forest Department, Government of Rajasthan.
- 15. Serial No. 42: The Authority accepted the recommendations & additional conditions of SEAC and decided to <u>approve EIA/ EMP and grant EC</u> to this proposal and PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
