# MINUTES OF THE $106^{\rm TH}$ MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY, JHARKHAND HELD ON $03^{\rm RD}$ and $04^{\rm TH}$ JULY, 2023.

The 106<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 03<sup>rd</sup> & 04<sup>th</sup> July, 2023 in the office of SEIAA. Ranchi under the chairmanship of Shri S.E.H. Kazmi. SEIAA. Jharkhand. The attendance in the meeting is as follows:

The decisions taken in the 106<sup>th</sup> SEIAA meeting are as follows:-

The SEAC has scrutinized the above projects in the light of Hon'ble NGT order dated 13.09.2018, dated 11.12.2018 and MoEF & CC, OM dated 12.12.2018. SEAC has made unanimous recommendations for grant of Environmental Clearance of above mentioned project proposals. The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearances to the above mentioned project proposals with following specific conditions:

- i. Project Authority will ensure that personal protective equipments such as protective clothing, helmet, goggles or other garments or equipments designed to protect from injury or infection will be provided to working personnels.

The above mentioned project is case of violation of E(P) Act, 1986. It is appraised by SEAC in the light of OM no. F.No.22-21/2020-IA.III[E 138949] dated 28.01.2022 of MoEF & CC, Govt. of India and the order passed by Hon'ble Apex Court in the matter of civil appeal no. 7576-7577 of 2021 in Electrosteel Steels Ltd. vs Union of India and SOS vide OM no. F.No. 22-21/2020-IA.III dated 07.07.2021 issued by MoEF & CC, Govt. of India.

SEAC has made recommendations for grant of Environmental Clearance subject to submission of evidence of Bank Guarantee with respect to remediation plan, natural and community resource augmentation plan alongwith penalty amount to be deposited in the office of Jharkhand State Pollution Control Board before grant of Environmental Clearance.

Hence, after full deliberations, it was unanimously decided that Environmental Clearance will be issued to the above project proposal after submission of Bank Guarantees and penalty amount to Jharkhand State Pollution Control Board. SEIAA authorises Member Secretary, SEIAA to issue Environmental Clearance after submission of evidence/receipt of Bank Guarantee and penalty amount to Jharkhand State Pollution Control Board. The Environmental Clearance will be granted with the conditions recommended by SEAC and alongwith the following specific conditions:

- i. Environment management system including organization structure to be drawn to ensure compliance of EC conditions stipulated based on principles of Continuous Improvement and periodical management review.
- ii. All raw material to be stored only under covered shed.
- iii. PAs to offset (upto20%) consumption of conventional energy sources by promoting use of solar energy, passive energy utilization, optimum fenestration, shading effect and heat islands.
- iv. Developers to promote energy conservation measures such that it offsets not less than 02 % of connected load. It is to be achieved by solar panels etc meeting ECBC norms.

v. Trees should be planted & maintained not less than 15% of project area.

The above mentioned project proposal was considered in the light of section 11 of Environment Impact Assessment Notification. 2006 for transferability of Environmental Clearance. The Environmental Clearance was granted by DEIAA, Jharkhand vide letter no. EC/DEIAA/2017-18/37, dated 18.07.2017 in the favour of "M/s K.P. & G. Sons Prop.: Smt. Renu Bohra at Mouza: Amdanda Pahar, P.O.: Bindudham, P.S.: Ranga, District: Sahibganj, Jharkhand (3.17 Ha)".

The applicant vide online application no. SIA/JH/MIN/301711/2023 has requested to transfer (transfer of ownership) of Environmental Clearance in favour of "Amdanda Pahar Stone Mine of M/s K.P. & G. Sons (Partner: Shri Vishal Makhija), Village: Amdana Pahar, Thana: Ranga, District: Sahibganj, Jharkhand (3.17 Ha)" for which he has submitted no objection certificate affirming that the Environmental Clearance will be transferred in favour of "Amdanda Pahar Stone Mine of M/s K.P. & G. Sons (Partner: Shri Vishal Makhija)" for which he has submitted no objections certificate affirming that the lease deed has already been transferred in the name of "Amdanda Pahar Stone Mine of M/s K.P. & G. Sons (Partner: Shri Vishal Makhija)" by Deputy



Commissioner. Sahibganj vide GRN number – 2214749733 and they do not have any objections regarding the transfer of Environmental Clearance and all the terms and conditions of Environmental Clearance dated 18.07.2017 shall be complied by "Amdanda Pahar Stone Mine of M/s K.P. & G. Sons (Partner: Shri Vishal Makhija)".

After the full deliberations, it was unanimously decided that Environmental Clearance issued vide letter no. EC/DEIAA/2017-18/37, dated 18.07.2017 is being transferred to "Amdanda Pahar Stone Mine of M/s K.P. & G. Sons (Partner: Shri Vishal Makhija)" with the same terms and conditions under which prior Environmental Clearance was granted by DEIAA, Sahibganj, Jharkhand for the same validity period subject to satisfactory compliance to all stipulated terms and conditions "Amdanda Pahar Stone Mine of M/s K.P. & G. Sons (Partner: Shri Vishal Makhija)" is directed to obtain Consent to Operate from the State Pollution Control Board in the name of "Amdanda Pahar Stone Mine of M/s K.P. & G. Sons (Partner: Shri Vishal Makhija)". In case any change is proposed in the Scope of the project, the Project Authority (PA) shall obtain fresh Environmental Clearance. Project proponent is also directed in the light of OM No. F.No. IA3-22/11/2023/-IA.III(E-208230) dated 28th April, 2023 issued by Ministry of Environmental Clearance from SEIAA after re-appraisal of SEAC within a period of 08 months from the date of issuing above OM of MoEF & CC.

9. Stone Mine of Shri Arun Kumar Ladia at Plot No. 4 & 5(P) at Village – Lakhanpur, Block – Bengabad, District – Giridih, Jharkhand (0.732 Ha).

The case was heard on 22.06.2023 under the provision of 8(vi) of EIA notification. 2006 in which DFO, Giridih East Division, Giridih and project proponent Shri Arun Kmar Ladia along with his authorized representative of Stone Mine of Shri Arun Kumar Ladia (Area: (0.732 Ha) District – Giridih, Jharkhand. Shri Raghaw Nandan Prasad were present before Member Secretary. SEIAA.

### Brief history of matter:-

- 1. The project proponent Shri Arun Kmar Ladia has submitted application on 07.11.2014 for grant Environmental Clearance of the stone mining project i.e. Stone Mine of Shri Arun Kumar Ladia at Plot No. 4 & 5(P). Village Lakhanpur. Block Bengabad. District Giridih, Jharkhand (Area: 0.732 Ha) with all requisite documents such as Form-1. P.F.R.. Mine Plan and other statutory documents like NOC of Gram Sabha. the certificates issued by CO. DMO and DFO. One of criteria for requirement of Environmental Clearance is the distance from forest boundary should be minimum 250 meter.
- 2. Then DFO, Giridih East Division, Giridih issued the certificate regarding the distance from forest boundary and mining lease vide its letter no. 391, dated 25.02.2014, in which it is mentined that the distance of boundary of mining lease area from notified forest boundary is more than 500 meter.

3. On the basis of aforesaid and along with other mandatory documents, the project proposal was appraised by then SEAC in its 24<sup>th</sup> meeting held on 15<sup>th</sup> to 18<sup>th</sup> December.



2014 and project was recommended for Environmental Clearance. In the light of recommendation of SEAC Environmental Clearance was granted by the then SEIAA in its 28<sup>th</sup> meeting held on 30<sup>th</sup> December, 2014. Accordingly EC letter was issued vide letter no.: EC/SEIAA/2014-15/518/2014/703, dated: 31.12.2014 with certain conditions.

- 4. The present DFO, Giridih East Division, Giridih vide its letter no.: 4261. dated: 21.12.2022 has made a complain that actual distance of mining lease area of Stone Mine of Shri Arun Kumar Ladia at Plot No. 4 & 5(P). Village Lakhanpur, Block Bengabad, District Giridih, Jharkhand (Area: 0.732 Ha) is only zero(0) meter and previous certificate issued by then DFO vide letter no 391 dated 25.02.2014 is wrong. DFO has further reiterated that project authority has also done illegal mining activity on plot no 01 which is notified forest and therefore a forest case has also been ledged against the project proponent for illegal mining on notified forest and emphasized that due to distance of zero(0) meter of aforesaid mining lease, it is causing adverse impact on forest and also requested to cancel the Environmental Clearance.
- 5. After receiving the complain from DFO, Giridih East Division, Giridih vide its letter no. 4261, dated: 21.12.2022, a show cause notice was issued to project Authority Shri Arun Kumar Ladia vide SEIAA letter no.: 319, dated 22.12.2022. Project Authority Shri Arun Kumar Ladia submitted his reply of show cause vide its letter no. zero, dated 10.01.2023, in the light of para 8(vi) of EIA notification, 2006 as referred below:

"Deliberate concealment and/or submission of false or misleading information or data which is material to screening or scoping or appraisal or decision on the application shall make the application liable for rejection, and cancellation of prior environmental clearance granted on that basis. Rejection of an application or cancellation of a prior environmental clearance—already granted, on such ground, shall be decided by the regulatory authority, after giving a personal hearing to the applicant, and following the principles of natural justice".

Thereafter a clarification was sought on show cause reply of Shri Arun Kumar Ladia (Project Authority) from DFO. Giridih East Division, Giridih vide SEIAA letter no. 418, dated: 09.02.2023. The DFO. Giridih East Division, Giridih vide its letter no.: 1704, dated: 20.05.2023 submitted its clarification.

- 6. In the clarification of DFO, Giridih East Division, stated that plot no. 01 and plot no. 04 are adjacent to each other. The plot no. 01 is notified forest area and plot no. 04 is area on which mining lease has been granted. Thus distance of boundary of mining lease area i.e. plot no. 04 is at zero(0) meter from notified forest. The actual distance of mining lease boundary is very less or negligible and is inappropriate for the requirement of Environmental Clearance i.e. 250 meter.
- 7. As per the provision para 8(vi) of EIA notification 2006, a date 22.06.2023 was decided for personal hearings of both the parties and letter was issued vide SEIAA letter no. 142, dated 12.06.2023 to the DFO, Giridih East Division, Giridih and Project Authority Shri Arun Kumar Ladia to appear before the Member Secretary, SEIAA on 22.06.2023.

#### Findings:-

- 8. Shri Pravesh Agarwal. Present DFO Giridih East Division. Giridih and Shri Arun Kumar Ladia with authorised representative Shri Raghaw Nandan Prasad appeared before Member Secretary. SEIAA on 22.06.2023. The DFO. Giridih East Division reiterated the same facts as mentioned in his clarification letter no. 1704. dated 20.05.2023 that distance of plot no. 04 on which mining lease was granted from plot no. 01 (notified forest land) is at zero(0) meter. He also emphasized that project proponent Shri Arun Kumar Ladia has also done illegal mining activity on plot no. 01 which is notified forest and produced documentary evidence like fresh map, which clearly shows that plot no.01 is adjacent to the plot no. 04.
- 9. The D.F.O., Giridih East Division has also submitted the letter no. 630 dated 26.11.2022 of Circle Officer, Bengabad, which addressed to the Deputy Commissioner. Giridih under the subject inspection report (Stone Mine of Shri Arun Kumar Ladia at Plot No. 4 & 5(P) at Village Lakhanpur, Block Bengabad, District Giridih, Jharkhand (0.732 Ha) wherein it has been clearly written that:
  - " मौजा लखनपुर थाना नं० 349, प्लॉट सं० 04 में रकवा 03 डी० पर पत्थर उत्खनन का कार्य किया गया है एवं प्लॉट सं० 05 पर उत्खनन कार्य नहीं किया गया है। खाता सं० 01, प्लॉट सं० 01 सर्वे रकवा 81 एकड़ के मध्ये 1.53 ए० पर पत्थर उत्खनन का कार्य किया गया है, जो गैरमजरूआ खास खाते की भूमि है एवं किस्म जंगल दर्ज है।"
- 10. Project Proponent through authorized representative Shri Raghaw Nandan Prasad submitted that total plot area of plot no. 01 is 81 Acre while the total notified area as protected forest is only 49.90 Acre. The Gazettee notification dated 27.12.1953 is read with to the following:
  - "The nature and extent of the rights of Government and of private persons in or over the forest lands and waste lands comprised in this notification have not yet been enquired into and recorded as laid down in sub-section (3) of section 29 of the said Act, but as the State Government thinks that such enquiry and record will occupy such length of time as in the meantime to endanger the rights of Government and as the enquiry and record-of-right will hereafter be made, this notification is issued subject to all existing rights of individuals or communities".

He further submitted the project proponent Shri Arun Kumar Ladia is also a present Raiyat on 01 Acre of land over plot no. 01 vide registered sale deed no. 10553/9519 dated 24.11.2014 of sub-registrar, . Giridih. He also submitted the project proponent and lessee is in possession of 01 Acre area of plot no. 01 of mouza Lakhanpur. If the D.F.O.is aggrieved he is free to move a Title Suit and/or Jharkhand Public Land Encroachment Act against project proponent before Competent Court.

11. The authorized representative of the project authority Shri Raghaw Nandan Prasad could not controvert the facts regarding distance given by present DFO. Giridih East Division, Giridih from the forest boundary to lease area.

12. On the basis of above facts it is clear that nearest distance of mining lease boundary from notified forest is zero(0) meter. And the certificate issued by then DFO, Giridih East Division, Giridih issued vide letter no. 391, dated 25.02.2014 which is important documents for Screening, Scoping and Appraisal of the project under EIA notification, 2006.

In conclusion, it is ample clear that the project proponent has procured incorrect certificate from then DFO, Giridih East Division. Giridih by concealing the fact that plot no. 01 and plot no. 04 are adjacent to each other. This certificate is found False/incorrect and this certificate was the basis of appraisal and issuing Environmental Clearance by SEIAA/SEAC.

EIA notification 2006 does not give any mandate SEIAA to take any decision on the facts given in para 10 and 11 presented by representative of project proponent. He has the liberty to get relief, if any, from the Competent Authority/Court.

In the light aforesaid facts SEIAA unanimously decided that Environmental Clearance granted to said project is hereby, cancelled with immediate effect under para 8(vi) of the EIA notification, 2006. The SEIAA further decided to request to the State Govt. to take the appropriate /disciplinary actions should be taken against erring officials for issuing incorrect/wrong distance certificate. The SEIAA further decided to authorize Member Secretary, SEIAA to issue the relevant order.

10. Karmatand Stone Deposit of Shri Prabhash Anand at Khata No.: 03, Plot No.: 333(P), 334, 336(P) at Village – Karmatand, Thana – Gandey, District – Giridih, Jharkhand (1.097 Ha) (Proposal No.: SIA/JH/MIN/38282/2019).

The case was heard on 22.06.2023 under the provision of 8(vi) of EIA notification, 2006 in which DFO, Giridih East Division, Giridih and project proponent Shri Prabhash Anand along with his authorized representative of Karmatand Stone Deposit (Area: 1.097 Ha), District: Giridih. Shri Raghaw Nandan Prasad were present before Member Secretary, SEIAA.

# **Brief history of matter:-**

1. The project proponent Shri Prabhash Anand made online application no.: SIA/JH/MIN/38282/2019 for grant Environmental Clearance of the stone mining project i.e. Karmatand Stone Deposit, Village: Karmatand at Khata No.: 03, Plot No.: 333(P), 334, 336(P), Thana: Gandey, District: Giridih (Area: 1.097 Ha) with all requisite documents such as Form-1, P.F.R., a Approved Mine Plan and other statutory documents like NOC of Gram Sabha, the certificates issued by CO. DMO and DFO. One of criteria for requirement of Environmental Clearance is the distance from forest boundary should be minimum 250 meter.

2. Then DFO. Giridih East Division. Giridih issued the certificate regarding the distance from forest boundary and mining lease vide its letter no. 267, dated 01.02.2018, in which it is mentioned that the distance of boundary of mining lease area from notified forest boundary is 255 meter.

- 3. On the basis of aforesaid and alongwith other mandatory documents, the project proposal was appraised by then SEAC in its 78<sup>th</sup> meeting held on 18<sup>th</sup> to 20<sup>th</sup> September, 2019 and project was recommended for Environmental Clearance. In the light of recommendation of SEAC Environmental Clearance was granted by the then SEIAA in its 80<sup>th</sup> meeting held on 25<sup>th</sup> September, 2019. Accordingly EC letter was issued vide letter no.: EC/SEIAA/2018-19/2165/2018/546, dated: 09.10.2019 with certain conditions.
- 4. The present DFO. East Division. Giridih vide its letter no.: 178. dated: 20.01.2023 has made a complain that actual distance of mining lease area of Karmatand i.e. Karmatand Stone Deposit of Shri Prabhash Anand at Village: Karmatand at Khata No.: 03. Plot No.: 333(P). 334. 336(P). Thana: Gandey. District: Giridih (Area: 1.097 Ha) is only 15 meter and previous certificate issued by then DFO vide letter no 267 dated 01.02.2018 is wrong and emphasized that due to distance of 15 meter of aforesaid mining lease is causing adverse impact on forest and also requested to cancel the Environmental Clearance.
- 5. After receiving the complain from DFO, East Division. Giridih vide its letter no. 178. dated: 20.01.2023, a show cause notice was issued to project Authority Shri Prabhash Anand vide SEIAA letter no.: 419. dated 09.02.2023. Project Authority Shri Prabhash Anand submitted his reply of show cause vide its letter no. zero, dated 10.03.2023. in the light of para 8(vi) of EIA notification, 2006 as referred below:
  - "Deliberate concealment and/or submission of false or misleading information or data which is material to screening or scoping or appraisal or decision on the application shall make the application liable for rejection, and cancellation of prior environmental clearance granted on that basis. Rejection of an application or cancellation of a prior environmental clearance—already granted, on such ground, shall be decided by the regulatory authority, after giving a personal hearing to the applicant, and following the principles of natural justice".

Thereafter a clarification was sought on show cause reply of Shri Prabhash Anand (Project Authority) from DFO, Giridih East Division, Giridih vide SEIAA letter no. 39, dated: 16.04.2023. The DFO, Giridih East Division, Giridih vide its letter no.: 1976, dated: 14.06.2023 submitted its clarification.

- 6. In the clarification of DFO, East Division, Giridih vide its letter no.: 1976, dated: 14.06.2023 para(d) has been stated that plot no. 311 and plot no. 333 are adjacent to each other. The plot no. 311 is notified forest area and plot no. 333 is area on which mining lease has been granted. Thus distance of boundary of mining lease area i.e. plot no. 333 is at zero(0) meter distance from notified forest and 15 meter from demarcated forest. The actual distance of mining lease boundary is very less or negligible and in appropriate for the requirement of Environmental Clearance i.e. 250 meter.
- 7. As per the provision para 8(vi) of EIA notification 2006, a date 22.06.2023 was decided for personal hearings of both the parties and letter was issued vide SEIAA letter no. 141, dated 12.06.2023 to the DFO, East Division, Giridih and Project Authority Shri Prabhash Anand to appear before the Member Secretary, SEIAA on 22.06.2023.

### Findings:-

- 8. Shri Pravesh Agarwal, Present DFO Giridih East Division. Giridih and Shri Prabhash Anand with Authorised representative Shri Raghaw Nandan Prasad appeared before Member Secretary. SEIAA on 22.06.2023. The DFO. East Division reiterated the same facts as mentioned in his clarification letter no. 1976, dated 14.06.2023 that distance of plot no. 333 on which mining lease was granted from plot no. 311 (notified forest land) is at (0)zero meter. And the nearest distance from demarcated forest is 15 meter as a proof he also produced documentary evidence like Cadastral Sheet duly signed by then settlement Officer and then Divisional Forest Officer which clearly shows that plot no. 311 is adjacent to the plot no. 333.
- 9. Project Proponent through authorized representative Shri Raghaw Nandan Prasad submitted that the total plot area 29.12 Acres while the total notified area at protective forest in Karmatand is 13.22 Acre which is further distributed over plot no. 69. 311 and 151. Therefore the full plot of 311 has not been notified protective forest is only 13.22 Acre. The Gazette notification no. 2653 R dated 31.08.1955 is read with following.

"The nature and extent of the rights of Government and of private persons in or over the forest lands and waste lands comprised in this notification have not yet been enquired into and recorded as laid down in sub-section (3) of section 29 of the said Act, but as the State Government thinks that such enquiry and record will occupy such length of time as in the meantime to endanger the rights of Government and as the enquiry and record-of-right will hereafter be made, this notification is issued subject to all existing rights of individuals or communities".

He further submitted the forest demarcation within plot no. 311 is not settled as per Gazette Notification No. 2653 R dated 31.08.1955 after consideration of all raiyati rights iner se, hence the ex-parte map of forest land within plot no. 311 cannot be said to be authentic to be relied upon.

He also submitted, if the D.F.O. is aggrieved of raiyati claims over plot no. 311 of Mauza Karmatanr (Annexure-C series) and/or location/carving/situation within plot no. 311, then he is free to move a Title Suit and/or Jharkhand Public Land Encroachment Act against project proponent before Competent Court.

- 10. The authorized representative of the project authority Shri Raghaw Nandan Prasad could not controvert the facts regarding distance given by present DFO. East Division. Giridih from the forest boundary to lease area.
- 11. On the basis of above facts it is clear that nearest distance of mining lease boundary from notified forest is zero(0) meter and demarcated forest is 15 meter. And the report of then DFO. East Division, Giridih issued vide letter no. 267, dated 01.02.2018 which was important documents for Screening. Scoping and Appraisal of the project under EIA notification, 2006.

In conclusion, it is ample clear that the project proponent has procured incorrect certificate from then DFO, Giridih East Division, Giridih by concealing the fact that plot no. 311 and plot no. 333 are adjacent to each other. This certificate is found
