Minutes of the 30th Meeting of SEIAA held on 2nd - 3rd November, 2020

The meeting was chaired by the Chairman, State Level Environment Impact Assessment Authority, Uttarakhand (SEIAA) Dr S.S. Negi and was attended by the following:

- (i) Shri Sushanta Kumar Pattnaik, Member Secretary, SEIAA Uttarakhand.
- (ii) Shri Shailendra Singh Bist, Member, SEIAA Uttarakhand.

The meeting started with welcome note by the Chairman. The Member Secretary informed that total 15 proposals (B1 & B2) are under consideration for grant of EC. In the miscellaneous agenda item, there are 1 proposal under consideration for EC. These proposals are those which had been deferred earlier by the Authority for want of additional documents/clarification.

Following agenda items were discussed and decisions taken: -

- 1) Environmental Clearance for Excavation of 'Brick Earth' for Brick Manufacturing M/s Royal Bricks Field by Mohd. Faheem (Partner) R/o- Village- Bhanera Tanda, Manglour, Tehsil- Roorkee District - Haridwar, at Village - Nathu Khedi - Manglaur Road, Tehsil - Roorkee, Distt.- Haridwar. (Area- 4.916 Ha.).




The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it.

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it.


