Proposed construction of Dharmapuri storage terminal of petroleum products by M/s. Hindustan Petroleum Corporation Limited at Sivadi Village, Dharmapuri District, Tamilnadu – Category “B1”-6 (b) Isolated Storage & Handling of Hazardous Chemicals (As per threshold planning quantity indicated in column 3 of schedule 2 & 3 of MSIHC Rules 1989 amended 2000)– Terms of Reference.

The Proponent, M/s. Hindustan Petroleum Corporation Limited, has applied to SEIAA-TN for Terms of Reference for the proposed construction of Dharmapuri storage terminal of petroleum products at Sivadi Village, Dharmapuri District, Tamilnadu on 21.02.2018.

The proponent was requested to furnish certain details vide SEIAA letter dated: 16.03.2018. The proponent submitted the reply on 20.04.2018.

The proposal was placed before the 112th SEAC Meeting held on 28.05.2018. The proponent made a brief presentation about the project proposal. The proponent informed the committee that the land selected for the development project is yet to be allotted legally to them and hence the proponent has not become the owner of the land required for the project. The proponent informed that action is being taken to acquire the land and requested the Committee to appraise the project pending land approval. However, the Committee concluded that the land ownership is crucial and fundamental for any appraisal of the project. In the absence of land availability, the Committee decided to defer the proposal and asked the proponent to re-submit the proposal after acquiring necessary land along with proper documents.

The proponent has furnished the details on 28.02.2019 informing that acquisition process is in final stages and the proposal is with industries Department, Government of Tamil Nadu.

Now government of Tamil Nadu has granted Administrative sanction for taking over land for storage of petroleum products of Hindustan Petroleum Corporation limited, Dharmapuri district – Nallampalli Taluk – measuring 113.10 acres patta land in Sivadi village and land ownership change of 2.82 acres of poramboke land vide G.O.no: G.O (Level) No.37 dated 22.01.2019.

The SEAC noted the following:

1. The Proponent of M/s. Hindustan Petroleum Corporation Limited has applied for Terms of Reference to SEIAA on 21.02.2018. for the proposed construction of Dharmapuri storage terminal of petroleum products
2. The project/activity is covered under Category “B1” of Item 6 (b) Isolated Storage & Handling of Hazardous Chemicals (As per threshold planning quantity indicated in column 3 of schedule 2 & 3 of MSIHC Rules 1989 amended 2000)” of the Schedule to the EIA Notification, 2006.

The proposal was placed in the 126th SEAC Meeting held on 26.02.2019. Based on the presentation made by the proponent, the SEAC Members interacted with the proponent about the project. The following are the key observations and recommendations:

1. The SEAC directed the proponent to take all preventive measures to minimize / eliminate emission from the project operation. An action plan towards this needs to be submitted.
2. A plan for hydrocarbon monitoring shall be furnished.
3. Risk assessment studies should be conducted with reference to habitations nearby.
4. The organic content of the MSW should be treated locally in a OWC and used as manure.
5. A total of atleast 15% of the plot area should be designated for green belt which should be raised along the boundaries of the plot. The proponent shall earmark in the

layout of the greenbelt area with dimension and GPS coordinates and furnish the same.

6. The rain water harvesting calculation should be as per the Central Ground Water Board (CGWB).
7. Proposal for the solar energy utilization. The proposal should cover atleast for 10% of total energy utilization.
8. The proponent shall provide the fire safety management and rescue plan shall be furnished.

The SEAC decided to recommend to SEIAA-TN the proposal for the grant of Terms of References (ToR) (Annexure-I) for preparing EIA / EMP report with Public Hearing for the proposed construction of Dharmapuri storage terminal of petroleum products by M/s. Hindustan Petroleum Corporation Limited at Sivadi Village, Dharmapuri District, Tamil Nadu. The key observations and recommendations from the public hearing should form part of additional ToR in addition to the standard ToR.


