

Minutes of the 69th Meeting of State level Environment Impact Assessment Authority, Jharkhand, held on 23rd March, 2019.

The 69th meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 23/03/2019 in the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

The decisions taken in the 69th SEIAA meeting are as follows:-

1. SEIAA considered the recommendations made by SEAC in its 68th meeting held on 14th and 15th March, 2019 for grant of Environmental Clearance to the following projects.

- i. Kajra Stone Mine of M/s Vinod Kumar Jain (Partner: Sri Mukesh Kumar Jain and others) at Vill. Kajra, Kamdara, Gumla (2.02 Ha).
- ii. Kumhari Stone Mine of M/s Vinod Kumar Jain (Partner: Sri Mukesh Kumar Jain and others) at Vill. Kumhari, Basia, Gumla (2.02 Ha).




The Authority examined the recommendations made by SEAC to the project mentioned in Sl. No. 1 (i), (ii) where in SEAC has recommended to grant of EC to these projects without District Survey Reports (DSR) of concerned district.

On the other hand SEAC in its 67th meeting which was held on 25th, 26th and 27th February, 2019, in the case of three project proposals related to minor minerals [(i) Tirildih-Turi Stone Deposit of M/s Kiran Construction & Infrastructure Pvt. Ltd at Vill. Tirildih & Turi, Ghatsila, East Singhbhum (8.90 Ha) (ii) Dindli Sand Mining Project on Kharkhai River of M/s Amit Trading Corporation at Village- Dindli, Thana- Adityapur, Dist.- Saraikela-Kharsawan, (6.07 Ha) (iii) Heben Sand Mine Project on Sanka River of Sri Binay Kumar Agarwal at Vill.- Heben, Simagunda, Saraikela-Kharsawan (6.24 Ha)] were not taken into consideration due to unavailability of DSR and SEAC has recommended that Department of Mines and Geology, Govt. of Jharkhand should make the DSR available to SEAC as it is mandatory for the minor minerals.

In the case of similar nature, the Authority should be made aware of two different decisions of SEAC. Hence, after full deliberations the projects mentioned in Sl. No. 1 (i), (ii) is being sent back to SEAC in the light of above observations.

- iii. "NUCLEUS CITY" of M/s Chalice Real Estate LLP at Vill. : Gari, Anchal : Bargai, Dist. : Ranchi.

It was decided to grant Environmental Clearance to the above mentioned project proposal alongwith additional condition other than SEAC that the



Environmental Clearance is subject to compliance of memo no.- 1444/Tech, dated 21.08.2018 of Jharkhand Fire Service Headquarters, Ranchi.

- iv. "NUCLEUS MALL" of RANCHI" of M/s Chalice Real Estate LLP at Vill : Gari, Anchal : Bargai, Ranchi.

It was decided to grant Environmental Clearance to the above mentioned project proposal alongwith additional condition other than SEAC that the Environmental Clearance is subject to compliance of memo no.- 1444/Tech, dated 21.08.2018 of Jharkhand Fire Service Headquarters, Ranchi.

- 2. SEIAA considered the recommendations made by SEAC in its 68th meeting held on 14th and 15th March, 2019 for grant of ToR to the following projects :-**

- i. Khokha Sand Mining Project located on river bed of Son River of M/s Ganga Kaveri Construction Pvt. Ltd at Vill. : Khokha, Anchal : Kharaundhi, Dist. : Garhwa (23.00 Ha).

The Authority examined the recommendations made by SEAC and it was unanimously decided that above project proposal will considered once the clarification of SEAC is received in accordance with the directions issued by SEIAA under 6 (iv) of its 68th meeting held on 19th and 23rd March, 2019.

- ii. Parasi Gold Deposit and Beneficiation Plant of M/s Rungta Mines Ltd, Vill. : Parasi, Kothadih, Kutachauli, Tehsil : Tamar, Dist. : Ranchi (75.273 Ha).

It was decided to grant ToR to the above mentioned project proposal with the conditions recommended by SEAC.

- 3. SEIAA considered the recommendations made by SEAC in its 68th meeting held on 14th and 15th March, 2019 for grant of EC extension to the following project:-**

- i. 2 x 63 MW Thermal Power Plant of M/s Inland Power Ltd. at Vill. : Tonagatu, Block - Goal, District Ramgarh.

The Authority examined the recommendations made by SEAC in above case and after full deliberations it was unanimously decided to extend the validity of Environmental Clearance for another 2 years i.e. upto 19th December, 2020 as recommended by SEAC.

- 4. (a) Dangawar (b) Ranideva (c) Dewarikala (d) Badepur (e) Birdhwar & Kolhua Sand Mining Project of Sri Upendra Singh, Dist. Palamau.**

The Authority examined the recommendations made by SEAC alongwith an application dated 10.01.2019 of project proponent Shri Upendra Singh.

After full deliberations it was unanimously decided that District Mining Officer, Palamau will clarify that why he has issued excess/more E-mining/transport challan than the production capacity mentioned in EC/CTO. District Mining Officer, Palamau is also requested to provide the copy of lease agreement of above projects.








