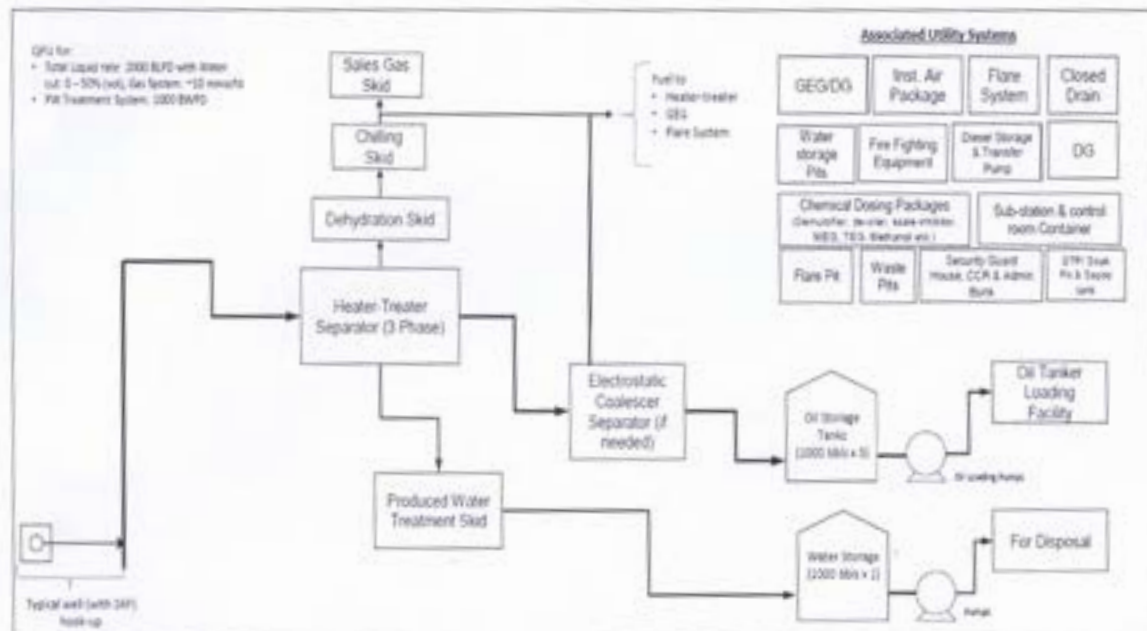

Following environmental aspects/ components of the project were also explained before the Committee:

Water Consumption/day: 87 KLD during drilling per well and 15 -18 KLD for each early production location.

Source of water: Would be sourced by Water Tankers from locally approved/ authorized sources.

Permission from CGWA or any other agency: NA. No Ground Water Wells shall be drilled for extraction water specifically for this project as the water requirement is very minimal and only for short period.

Energy Consumption: For drilling: 2950 kVA for drilling of each well and will be made available from D.G. Sets For Early Production: Gas Engine Generator (GEG) - 1 MW and 1X500 KVA DG Set for emergency use Kind of Fuel used: HSD, Natural Gas in early production Quantity of fuel used: Approx. 20 KLD for drilling

Wastewater Generated/day: 52 KLD (12 KLD Domestic, 40 KLD from drilling operation) during drilling of each well. During operation of EPU/QPUs, approximately 225 KLD of produced water and other wastewater (Washing etc) 10 KLD will be generated along with 5 KLD domestic wastewater from each early production location.

Waste water Treatment facility has been proposed as follow:

For drilling: ETP (consisting of physicochemical treatment, Ultra filtration (UF) & RO (if needed) of 50 KLD capacity and the treated water would be used for drilling mud preparation, housekeeping, dust suppression, toilet flushing, and other misc. use. Domestic wastewater during drilling 12 KLD will be treated in STP (of 20 KLD capacity) which will be reused for plantation/ green Belt, etc.

For Early Production: Wastewater (Produced water, other wastewater from washing etc) from Early Production stage will be treated in ETP (consisting of Physicochemical treatment, ultra filtration (UF) & RO (if needed) of 250 KLD Capacity) and the treated water would be used for dust suppression, green belt etc. and also reused for injection into other purposes and the excess quantity will be disposed through abandoned deep dump well or other suitable onshore disposal medium Mode of discharge: No Discharge to the surface. In principle, ZLD concept will be implemented.

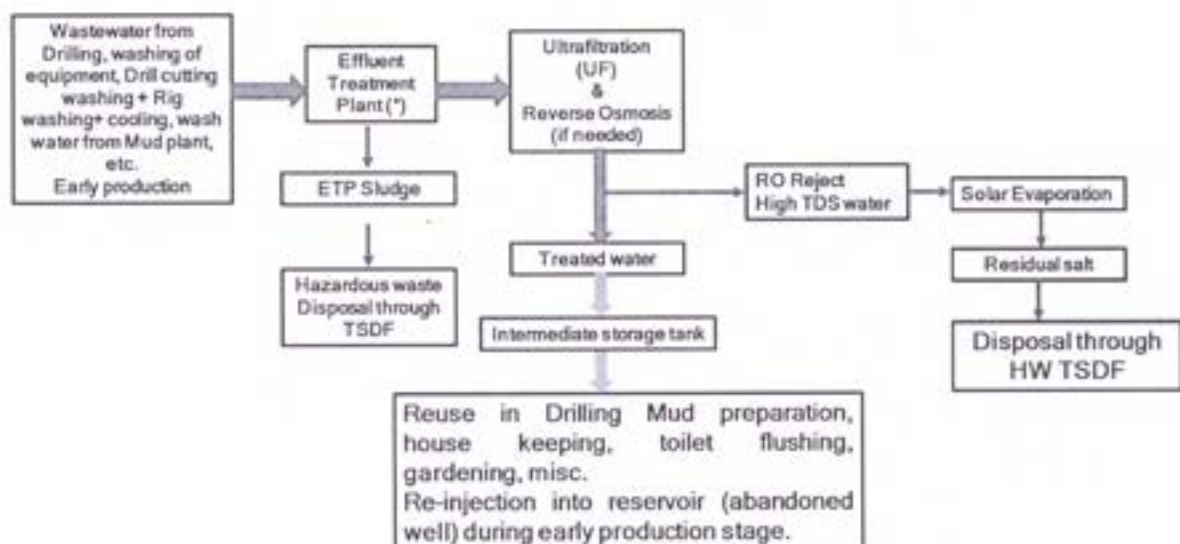

The proposed project is setting up of PGIMER Satellite Centre at Una, Himachal Pradesh Phase-I. The construction of the proposed project includes building for 300 bedded hospital and 40 beds of ICU with allied facilities staff quarter, mortuary, ESS and HVAC plant room.

Online proposal for granting Environment Clearance was submitted on dated 07/12/2022 and accepted by the SEIAA secretariat on dated 23/12/2022 and forwarded to SEAC secretariat.

The case was listed in 90th meeting of the SEAC held on 23-24th March, 2023.

After deliberating on the information submitted by the project proponent and considering the facts placed before the Committee, the SEAC decided to list the case in next meeting after compliance to the following observations:

1. The project proponent shall resubmit details about built up area after including service areas roads, parking etc.
2. The project proponent shall revise and resubmit plantation plan by including local species.
3. The project proponent shall recalculate and resubmit water demand, waste water recycling potential balancing details for both construction and operational phases.
4. The project proponent shall ensure recycling at least 50% treated waste water through dual plumbing system after tertiary treatment- MBBR technology and proving the ultraviolet radiation purification.
5. The project proponent also under take sampling and analysis of GLC values of PM 2.5.
6. The project proponent shall submit copy of MoU signed with authorized vendor for disposal of bio-medical waste which shall be generated from proposed Hospital.
7. The project proponent shall submit affidavit to include in plan to built and construct night shelter for the attendants of indoor patients and submit revised budget.
8. The project proponent shall revise the muck management plan and submit with cut fill details for minimizing the waste disposal.
